Comments: According to the data submitted by the school, the Student Interest Survey was given during the 2007-2008 school year. The school surveyed students in grades 8-11 and had a return rate of 86%. As a result of the student survey the school has started girls' and boys' soccer for the 2008-2009 school year.

Accommodation of Interests and Abilities	X		According to the data given the school has met Test 1, 2 and Test 3 consistently for the past three school years. School officials shared that participation in athletics at the school varied a great deal from year to year due to the interest of students. The data submitted indicated that students are surveyed properly and records are kept. The school noted that they had started a girls' soccer team due to the interest expressed by a group of students.  This was an area of deficiency in the February 2002 report and the school should be commended for its' efforts to increase participation opportunities.
Equipment and Supplies	X		The February 2002 audit report recommended that the Gender Equity Review Committee develop a written policy governing the purchase and the replacement of uniforms for the various teams. Uniforms viewed appeared to be of the same quality except for volleyball and the new soccer uniforms. At the present time the school is still in the process of determining if there is sustained interest in soccer to continue with the funding of a program. When such determination is made the school will then purchase additional uniforms. It did appear that some teams had more sets of uniforms than others. (See KHSAA Recommendation)
Scheduling of Games and Practice Time	X		The school has a practice schedule in the master Title IX file. Students athletes interviewed shared that the practice times on the schedule were followed. The school shares its' athletic facilities with both a middle school and elementary school located on the same campus.  The school currently meets the prime time prime date requirement for girls' basketball. The school played 50 % of its home contest in Prime-Time for the 2007-2008 school year.

Travel and Per Diem Allowances	X		Transportation is provided by the bus for most athletic contests. It appears that chartered buses are taken for some athletic events. The school does not have any written policies in regards to travel and pier-diem that would insure equity ( See KHSAA Recommendation)
Coaching	X		Pay is comparable for both male and female sports. A salary schedule was found in the Title IX master file. There appears to be an inequity due to the disparity in the number of coaches for female teams. The girls' volleyball team currently has two coaches for three teams. The girls' basketball team had one less coach last year due to the schools inability to find another assistant. The school should exhaust all efforts to find an assistant coach for the girls' teams. See (KHSAA Recommendation)
Locker Rooms, Practice and Competitive Facilities		X	The school equitably shares two locker-rooms with dressing areas for all sports at the school. These are the only dressing areas or locker-rooms available to student athletes. The gym floor has recently been refinished and painting has been completed to the gymnasium. An additional practice gym has been constructed next to the large gymnasium. This facility appears to be equally shared by those sports teams who use it. The tennis courts are located on school grounds but are not in playable shape. The school currently does not offer tennis and there has been no interest expressed in tennis on the student survey to warrant an expensive upgrade to the courts. The February 2002 audit report noted a disparity in amenities between the girls' softball field and boys' baseball field. The baseball field has lights and concrete block dugouts with a roof. The softball field does not have lights and only chain link dugouts are provided with no roof. The school was not given a deficiency at that time due to the fact that the school did not have a softball team that used the field. School personnel informed auditors that participation in softball fluctuated and was not as consistent as the coach would like it to be, however it appears that the condition of the girls' softball field would be a deterrent to

The school should be commended for recognizing this inequity and indicated that lights and dugouts were needed as an item for corrective action for the past two years. The school has not submitted a timeline for completion of this project and there is no plan at present to upgrade the softball field. (See KHSAA Recommendation)
Medical and Training Facilities and Services	X	The weight room is located close to the gymnasium. The school had recently converted a former industrial shop to a weight room. This project is still under renovation and auditors recommended the purchase of light weight bars for female use. When the weight room is fully operational a weight room schedule should be posted.  The school does not have a certified trainer or provide training services to any athlete.
Publicity		This past school year the school started a cheer squad. The squad will cheer an equal amount of games for both boys and girls for both home and away games according to school guidelines.  The school gymnasium has recently been painted and has no banners hanging from the gym. The school currently has no policy in place for how these items would be displayed. There are several small trophy cases in which trophies are displayed The school has no schedule cards or athletic posters. Although not a gender equity issue, there was discussion with school officials about how the school could develop polices that would increase recognition of student athletes which would benefit overall participation the schools' athletic program. Support Services	X	The school has no outside booster organizations that support the school. Coaches and parents fundraise to purchase athletic equipment and supplies as well as other athletic needs. Auditors expressed concern that without specific oversight of expenditures, coaches and parents could cause a spending inequity by their fundraising efforts. Those sports who had eager coaches and parents would be able to supply more benefits to the athletes at the school

The school was rendered deficient due to the disparity between the boys' baseball field and girls' softball field.

- Submit to the KHSAA, no later than August 30, 2009 a copy of an adopted policy regarding a uniform replacement schedule for all teams that participate in athletes at the school. A copy of this replacement and review process must be provided to all head coaches and must be placed in your school's Master Title IX File.
- Submit to the KHSAA, no later than August 30, 2009, a plan for the purchase of new weight training equipment which will be appropriate for use by female athletes.
- Submit to the KHSAA, no later than August 30, 2009 a copy of your school's established written polices (guidelines) regarding the necessary credentials and accomplishments for an athlete or team to be honored with banners, awards or recognition within your school.

Submit to the KHSAA, no later than August 30, 2009, a plan to address the inequities found between the girls' softball field and boys' baseball field.

The following items should be submitted:

- The results of a study of the feasibility of making needed improvements at the present softball field.
- A time line with anticipated completion dates for upgrades needed at the present field to make it equitable to the baseball field.
