ACCOMMODATIONS OF INTEREST AND ABILITIES NOTES: According to information and data submitted, Bullitt Central High School has meet the standard for Test 3 for the provision of athletic opportunities the school years 2020-21 and 2021-22. The most recent Student Interest Survey was administered April 25, 2022 with a return rate of 60.4%. The school currently offers twelve (12) varsity sports for males and eleven (11) varsity sports for females. The school administration was reminded the importance of accurate team and rosters submitted so that data results would provide a complete school analysis of opportunities.

BENEFITS REVIEW- EQUIPMENT AND SUPPLIES: A written uniform replacement/review policy indicated an even/odd rotation cycle for girls' and boys' basketball (home/away) uniforms. Several teams were reviewed or replaced annually. All uniforms were purchased with school appropriated funds. The uniforms viewed were of high quality and comparable in quantity for "like" sports. All other equipment viewed appeared to be well-maintained and suitable for their specific sport. Bullitt Central spent approximately \$162 per male athlete and \$109 per female athlete during the 2020-21 school year.

BENEFITS REVIEW- SCHEDULING OF GAMES AND PRACTICE TIMES: Game schedules viewed in the Title IX file and on-line appear to equitable in number of competitive events for "like" sports. Schedules for shared facilities (main gymnasium and auxiliary gymnasium) appeared to showed equitable usage with girls and boys' basketball and volleyball. (In-season sport is given priority.) Not available for viewing were schedules for the shared football field (football, girls' and boys' soccer) or indoor hitting facility.

BENEFITS REVIEW- TRAVEL AND PER DIEM: Travel and Per diem guidelines viewed were complete and included information pertaining to mode of transportation (school bus, van, parent transport, or charter vehicle), guidelines for overnight housing (4 athletes to a room, \$120 per day or \$30 per athlete), and Per diem (\$10 per meal or \$30/day maximum). The guidelines addressed Booster clubs' financial responsibilities and required them to follow set guidelines concerning transportation and per diem.

BENEFITS REVIEW- COACHING: There was written evidence of a Board approved salary schedule which showed overall equivalence in stipend amounts and parity in the number of coaching positions. With regard to accessibility, data indicates there is a ratio of 12:1 athlete to coach for males and 9:1 athlete to coach for females, giving a slight advantage to females. Approximately 50% of head coaches are on campus for both male and female athletes.

Informal evaluations between the Athletic Director and head coaches are held at the completion of their competitive season. No written instrument was used.

BENEFITS REVIEW- LOCKER ROOMS, PRACTICE AND COMPETITIVE FACILITIES: Bullitt Central is in the process of finalizing plans for a major renovation of their athletic facilities. Currently competitive and practice venues on campus are football field (used by football and soccer), 6 lane track, softball and baseball fields, two tennis courts, wrestling room, in-door hitting facility, main gymnasium and auxiliary gymnasium. Off campus venues include: Swimming-UL pool, Bowling-Ken-Bowl, Golf-Heritage Hills course, Fishing-local lakes.

There was written evidence of locker room assignment for all teams, however, upon review the area designated for Football cannot be considered a locker room. A main focus of Title IX is to ensure that all student athletes have a safe and secure place to dress and secure items. The area for football is a small, open room (no lockers) in the fieldhouse with access to a public restroom facility. It is currently being used as the wrestling team practice facility. The qualities and amenities of the actual viewed locker rooms were comparable.

There was written and viewed evidence of storage assignments for all teams.

BENEFITS REVIEW- MEDICAL AND TRAINING FACILITIES AND SERVICES: Bullitt Central has one weight room located in the upper mezzanine of the main gym and is easily accessible for all athletes. A schedule assigning times to female and male sports team was posted at the site. Equipment viewed appeared to be lacking in lighter weights and "female appropriate" equipment. Coaches interviewed indicated they did not use the weight room due to limited knowledge of proper techniques. *It is recommended the GERC review the equipment in the weight room and seek to provide instruction for coaches on proper weight lifting technique.*

The school has daily services of an athletic trainer who is contracted through University of Louisville hospital. The training room was well equipped and easily accessible to all athletes. Physical exams for athletes are scheduled in May for a fee of \$25.

BENEFITS REVIEW- PUBLICITY: Scheduling of support groups (cheerleaders and the dance team)

appears to be coordinated and monitored by the Athletic Director providing for equitable performance at football and girls/boys' basketball games. There was written evidence of awards and recognition that provided equivalency in display of banners, All-State honors, letter/bars, award certificates, and Senior awards. Criteria for earning a letter was available for each individual sport with additional awarding left to the coaches' discretion. All teams were required to have post season banquets or recognition events. Spending in this category showed approximately \$23 per male athlete and \$14 per female athlete.

BENEFITS REVIEW- SUPPORT SERVICES: The assignment of available office space appears to be equitable and accessible to all coaches. *Exception-The football coaching offices are housed in temporary trailer near the football stadium.* Due to the location, there is limited access to phone or computer service. Completion of the planned renovation project is to include coaching offices for football.

Bullitt Central has one Booster organization with an external account that is responsible for fundraising activities. Each sport team has a representative in the Booster club and are responsible for their individual account. To provide administrative oversight, the Booster club is required to report to the school yearly a budget and all expenditures. To ensure parity and equity, the Athletic Director monitors and approves all fundraising events. A written Booster agreement was not in the Title IX file.

Current over-all spending falls within acceptable parameters in per athlete and percentage expenditures (\$467 for males and \$411 for females). It is recommended school officials develop a written agreement for the Title IX file and continue to monitor expenditures for the Booster organization.

Upgrades and construction plans due to be completed in the fall of 2023 demonstrate the dedication to providing the best for all athletes at Bullitt Central. Emergency plans were comprehensive, venue specific and posted at each site.

There are three AEDS on campus-main gym, auxiliary gym, main office. The athletic trainer has one in her possession as well.
