Accommodation of Interests and Abilities	X		According to data provided by school personnel, Campbellsville High School is currently meeting the standards established in both Test #1 and Test #2 for Athletic Participation Opportunities. The school's calculations appear to be correct and its data is in proper order. The school Re-Visit revealed a vast improvement in the school's Title IX file. KHSAA officials noted that the file contained a uniform rotation plan, written booster agreements with all active clubs, monthly booster club spending reports, weight room usage schedule, gym usage schedule, game schedules for all teams and various items relating to publicity for all sports. The school's Gender Equity Review Committee had two active student members, and the file contained minutes for all meetings held since the original KHSAA visit. The school is to be commended

Equipment and Supplies	X		the past two years. The school currently has a uniform rotation and replacement plan in place. This plan is based on a four-year rotation for all sports except baseball and softball which are on a three-year rotation. The uniforms and equipment reviewed by KHSAA officials during the visit appeared to be equitable and of good quality for all athletes. According to data provided by school personnel on the Re-Visit form, Campbellsville High School is currently spending approximately \$114 per female athlete and \$159 per male athlete for equipment and supplies.

The 1-9-03 report requested that the school district upgrade the softball dugouts, provide district transportation to the softball field, provide dressing and locker facilities for the softball team, provide public restrooms near the softball field and develop a schedule which provided for equitable use of the school's indoor batting and practice facility. Submittals by the school and the recent KHSAA Re-Visit show that the school has incorporated all of the above designated changes. The school is to be commended for making these changes as requested within the time frame outlined by the KHSAA. It was suggested to school officials that the softball dressing room, although adequate, could use some upgrading (i.e. paint and new benches).

			currently has one cheerleading squad which cheers at all home games for both the boys' and girls' basketball teams. The squad also cheers at away games for both teams when competing against district opponents. Review of the school's Title IX file showed several posters, programs, and schedule cards which gave publicity to all sports.

Support Services	<b>X</b>	Booster clubs and administrative monitoring of spending for athletics was discussed with school officials. It appears that in the past two years the school has taken several positive steps in regard to oversight of booster clubs (i.e. written agreements and required monthly spending reports). It was suggested that school officials look into the feasibility of requiring administrative approval for any booster spending that provides benefits to athletic teams at Campbellsville High School. All booster clubs still maintain bank accounts outside the school.

#### 5. Brief Summary/Analysis of the Corrective Action Plan (Form T-60)

The school's most recent Corrective Action Plan calls for development of a written plan relating to the selection and assignment of cheerleaders, continuing to increase prime time playing opportunities for girls' basketball, provision of restrooms for softball and soccer facilities, offering the sport of Girls' Golf in the fall of 2004, and attempting to adopt a written policy on out-of-state travel for athletic teams.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs The most recent school Re-Visit showed no major deficiencies at this time.

- 7. KHSAA Recommended Action in relation to new deficiencies: The most recent school visit revealed no new deficiencies at the school.
- 8. KHSAA Recommended Action in relation to re-occurring deficiencies: The February 16, 2005 school Re-Visit revealed that the school had successfully addressed the deficiency designated in Locker Rooms, Practice and Competitive Facilities that was cited in the January 9, 2003 Title IX report.
