- I. Construction of expanded locker rooms for girls' teams is ongoing. The school indicated that this construction should be completed during the summer of 2001.
- II. The school has no facility for softball teams (although the school does not have softball teams at the present time). School personnel have set a 3-12 month time line to correct this situation. In prior years, the softball team has used the baseball field.
- III. The school has no facility for soccer games. At the present time, the soccer and field hockey teams share a field. School personnel have set a 3-12 month time line to correct this situation.

- With future submissions, the school is encouraged to submit full and complete forms for all teams, including junior varsity and freshman teams. In addition, the school is reminded that each team form should be signed and dated when it is completed.
- The school is requested to recalculate and resubmit form T-6 (summary of Equipment

and Supplies for all boys' and girls' programs). The school is reminded that the total number of game and practice uniforms as well as a listing of all sport-specific equipment should be included in this summary. This information should be submitted on or before **June 25, 2001**.

- The school is requested to confirm whether its field hockey and soccer teams will be able to use the football stadium (which is currently under construction) for its games and practices. This information should be provided on or before **June 25, 2001**.
- On or before **June 25, 2001**, the school shall develop a plan that allows female students to better utilize its weight room. This plan should include, but should not be limited to, a published schedule of times and dates during which female students may utilize this facility.
