Comments: The most recent Student Interest Survey was conducted during the 2013-2014 school year. Students in grades 9-11 were surveyed with a return rate of 91.4%.

Accommodation of Interests and Abilities	X		The most recent Student Interest Survey was administered during the 2013-2014 schoo year. Submitted data indicated that students in grades 9-11 were surveyed with a return rate of 91.4%. Reported information on the 2018 Annual Report shows that Christian County offers nine (9) varsity sports for males and eight (8) for females. The most recently added sport activity is bass fishing. Interviews with administration indicate that archery shall be added the 2015-2016 school year. A valid review of results for this area depends upor the accuracy of team roster input and response(s) that may result from the Studen Interest Survey. It is also noted that Gende Equity Committee meeting dates, minutes, and attendance information should be made a par of the school Title IX file. Committee meeting minutes, for a minimum of three (3) years should be retained as part of the Title IX file.
Equipment and Supplies	X		There was written evidence of a three (3 and/or four (4) year uniform review/replacement plan for all team uniforms Uniforms for the 'like' sports were shown to be on the same review cycle. Tennis and gol uniforms are replaced yearly. Viewed uniforms were of high quality and equivalent in the quantity provided. All other viewed equipmen appeared to be well-maintained and available for equitable access. An overall review o spending for this category appears to favor the male athletes.
Scheduling of Games and Practice Time	X		There was viewed evidence of all team schedules in the Title IX file. There was evidence showing overall equivalence and parity within the 'like' sports regarding the number of competitive event opportunities

		provided for all levels. There was also viewed evidence for the equitable scheduling and access to the shared facilities of the main gymnasium, auxiliary gymnasium and the soccer practice fields.
Travel and Per Diem Allowances	X	There was written evidence of a travel and per diem guideline that indicated mode(s) of transport and the provision for overnight stay (hotel). All travel requests are approved by the school Principal, Superintendent, and/or the Board of Education. The assurance of overall equity is monitored by these administrative levels. Interviews with students and coaches indicated the provision for meal allotments for athletic trips, however, this was not included in the written guideline for per diem. An overall review of spending for this category meets the acceptable parameters for both males and females. (see KHSAA recommendation 7.a.)
Coaching	X	There was viewed evidence of a school board approved salary schedule which showed overall equivalence in the salary provided and number of coaching positions provided. According to submitted data, the athlete to coach accessibility ratio heavily favors the males. Interviews with administration indicate possible errors in the reporting column dealing with the reported number of coaches for baseball, softball, soccer, basketball, and wrestling. Interviews with administration also indicated that end of season written evaluations of all head coaches are done by the Principal and Assistant Principal. (see KHSAA recommendation 7.b.)
Locker Room, Practice and	Х	There was written evidence of locker room and
Competitive		storage assignment for all teams. The quality and amenities of all locker rooms are similar

Facilities		and comparable. The viewed competitive facilities are all of high standard and well- maintained. Facilities located off-campus are the Stadium of Champions, De-Bow practice soccer fields and the Western Hills Golf Course. The Stadium of Champions host competitive events for football and boys/girls soccer contests. The golf course provides a venue for practice and competition matches. Slight differences that were viewed between the baseball and softball facilities include the amenities (information) that the scoreboard provides for baseball as compared to softball, more on-site available storage at the baseball site, and the inclusion of a locker room and office area as part of the building that houses the indoor hitting facility for baseball. These items should be kept in mind as facility self- evaluations are conducted or as improvements are being considered.
Medical and Training Facilities and Services	X	The weight room area is located in the Multi- purpose Building #3 on the school campus. It was spacious, provided equitable access, and a current usage schedule was posted at the site. There appeared to be limited appropriate equipment for female use and visual displays in the weight room were more in support of male teams. Interviews with administration indicated that Athletic Training services are provided through an agreement with the Jennie Stuart Medical Center. The trainer is available on a daily basis, at all home events and some selected away events. There was written evidence of the trainer's schedule in the school Title IX file and posted at the site which showed equitable access and availability to the student athletes. Interviews with administration also indicated that athletic physicals are made available to all athletes, twice a year, at no cost, by the local medical center. There was also viewed evidence of emergency action plans for all competitive venues.

Publicity	X	There was written evidence of an awards guideline that included the provision for end-of- season recognition (banquets), team awards, and banner display. There is also a school Hall of Fame sponsored and supported by the Heritage Bank of Christian County. Interviews with administration indicated that previous and/or current Christian County Coaches are members of the Hall of Fame Committee. It appears that criteria has been established to ensure overall equivalence relative to selection to the Hall of Fame. School administration provides oversight to ensure equivalence in the support provided to teams by the cheerleaders, dance team, and band. An overall review of spending for this area meets the acceptable parameters for both males and females.
Support Services	X	A two-year review of spending showed that approximately \$803.00 was spent per male athlete and approximately \$656.00 spent per female athlete. This falls slightly outside the acceptable parameters (\$100.00) on a per athlete basis. In review of the benefit areas, it appears that the disparity has regularly occurred in the area of Equipment and Supplies. Overall and benefit category spending is the responsibility of school administration. Regardless of where funds come from, it is up to the institution to make up any difference and/or to ensure overall equivalence, relative to spending. Interviews with administration indicated that all sports have booster clubs, with outside accounts, with the exception of tennis, golf, and track. Interviews with administration indicated that monthly reporting of booster club activity and approval of all booster club fund raising projects are required by the school and district office. However, it appears there is no mechanism in place for the oversight and/or

		school administrative approval of booster expenditures. Coaches interviewed were knowledgeable of the school process (purchase order) for any purchases utilizing school funds. (see KHSAA recommendation 7.d.)

- b. Please submit to the KHSAA, no later than March 1, the number of coaches and levels of play for the sports of baseball, softball, girls soccer, boys soccer, girls basketball, boys basketball, and wrestling.
- c. Upon receipt of this report, a review of the current weight room equipment should be evaluated so as to determine the needs and/or appropriateness of weight equipment that should be added for female use.
- d. Please submit to the KHSAA, no later than March 1, a plan of administrative oversight and/or prior approval of expenditures regarding booster funds from the outside established booster club accounts.
