Travel and Per Diem Allowances	X	According to the school's most recent submittal to KHSAA, it is currently spending approximately \$227 per female athlete and \$126 per male athlete for travel and per diem.
Coaching	X	A review of the school district's salary schedule indicated equity. According to the school's most recent submittal to KHSAA, all girls head coaches are employed on campus.
Locker Rooms, Practice and Competitive Facilities	X	The October, 2001 audit report requested that the school address the disparity between the boys' and girls' dressing rooms in the gym. It was recommended that air conditioning be installed in the girls' locker room that would be comparable to that in the boys' locker room. The most recent visit showed that this had not been done. Meetings with school administrators, coaches, and student-athletes revealed that a joint decision was made to upgrade the locker room in other ways. The locker room now has new carpet, renovated shower and restroom facilities, fresh paint, and cushioned locker top seats. According to an interview with a current girls' basketball player, these changes were a joint decision and are what both the players and coaches wanted. The current girls' locker room now appears to exceed the boys in regard to quality of amenities. School officials were alerted to the fact that these changes are to be reflected on the school's April 15, 2005 Corrective Action Plan. There is also a written statement in the school's file describing the agreement for the locker room changes. School officials were also told that a schedule for usage of the school's batting practice facility be included in the April 15, 2005 Corrective Action Plan. This document is not currently included in the facilities usage schedule in the Title IX file. The school is presently completing the installation of new lights at both the baseball and softball fields.

Medical and Training Facilities and Services	X	The school is currently developing a new weight training facility in the basement of the school's district office. School officials were reminded that a schedule for usage of this facility should be developed, posted, and placed in the Title IX file and be a part of the school's April 15, 2005 Corrective Action Plan.
Publicity	X	According to the school's Re-Visit form, it currently has one cheerleading squad which cheers at all home games for both the boys' and girls' basketball teams. They also cheer at all away district games for both boys and girls. School officials have developed a site based policy addressing the posting of various forms of recognition in the school gymnasium. School officials were alerted to the fact that this policy should be a part of their Title IX file.
Support Services	X	This area was designated as deficient in the October, 2001 report primarily due to the fact that the school failed to submit data to the KHSAA related to the school's athletic expenditures. According to the school's most recent submittal to the KHSAA, 48.9% of its athletic expenditures go to boys' sports while 51.1% is expended for girls' sports. The school currently has one athletic booster club which supports girls' and boys' basketball. Because the booster club maintains bank accounts outside the school's activity accounts, KHSAA officials discussed various written agreements which the school could have with the booster club that might provide stronger administrative oversight. This written agreement should be included in the school's April 15, 2005 submittal to the KHSAA.

5. Brief Summary/Analysis of the Corrective Action Plan (Form T-60)

The school's most recent Corrective Action Plan calls for upgrading the girls' locker room in the gym and completion of the installation of new lights at the softball field.

In relation to the previously cited deficiency in the area of <u>Accommodation of Interests</u> and <u>Abilities</u>, more accurate accounting and calculations by school officials appear to have adequately addressed this situation.

In relation to the previously cited deficiency in the area of <u>support services</u>, more accurate school accounting and reporting appear to have adequately addressed this situation.
