ACCOMMODATIONS OF INTEREST AND ABILITIES NOTES: This school did not offer athletics at the time of the first Title IX visit cycle. The school's only previous Title IX school visit was on September 21, 2011. The 2011 report documents that the school was meeting the standard of both Tests 1 and 3 for provision of athletic opportunities at that time. A review of annual reports for the past two years shows that it is very likely that the standards of Tests 1 and 3 are still being met. The internal analysis summaries for the 2015-16 and 2016-17 annual reports show that the ratio of participants per team to total participation (internal audit summary- Row 17) is 51.6%. Based on this data, the document grants credit for Test 1 (internal audit summary- Row 20). In regard to Test 3, the responses on the T-3 form appear to be supported by the information on the most recent student athletic interest survey. The T-63 form in the 2015-16 annual Title IX report shows that an 89% completion rate was received on the most recent student athletic interest survey. During the recent visit, the school's Title IX file was inspected. It was found to contain the annual Title IX reports for the past five years, the previous Title IX school visit report, a board-approved extra service pay schedule for coaches, a listing of the current members of the Gender Equity Review Committee, current game schedules for all school-sponsored varsity teams, a vague statement regarding recognition of athletic accomplishments (see Publicity and KHSAA Recommended Action), a written designation of locker room and athletic equipment storage space, minutes for only one GERC meeting which was held during the current school year (see KHSAA Recommended Action), and some ambiguous statements addressing past uniform purchases (see Equipment and Supplies and KHSAA Recommended Action). It should be noted that the file contained no written regulations addressing travel and per diem. (See Travel and Per Diem Allowances and KHSAA Recommended Action.) Although not a part of Title IX requirements, but a requirement under KRS160.445, the school did not provide a copy of its Athletic Facility Emergency Medical Plan. (See KHSAA Recommended Action.) School officials and members of the Gender Equity Review Committee were encouraged to work toward the development of a comprehensive and functional Title IX file.

BENEFITS REVIEW- EQUIPMENT AND SUPPLIES: The previous Title IX school visit report rated this benefit category *Satisfactory*. The report requested that the school develop and implement an equitable uniform review, rotation, and/or replacement plan. All the uniforms reviewed during the recent visit were of high quality and appeared to be supplied in equitable quantities. As was the case in 2011, the school still <u>does not</u> have an equitable uniform review, rotation, and/or replacement plan. Interviews with student athletes and coaches did not confirm the implementation of equitable cycles of review for "like" teams. (See *KHSAA Recommended Action*.) Information in the 2015-16 and 2016-17 annual Title IX reports shows that the school was spending approximately \$41 per female athlete and \$39 per male athlete for equipment and supplies.

BENEFITS REVIEW- SCHEDULING OF GAMES AND PRACTICE TIMES: The 2011 Title IX school visit report rated this benefit category *Satisfactory*. Information gathered during the recent visit indicated that the number of competitive events scheduled for teams of "like" sports was comparable. The only facility at the school that is shared by both genders is the gym. A usage schedule that seemed to show parity is in the Title IX file. Scheduling optimal playing times for athletic events was discussed with school representatives who were commended for the provision of parity in regard to this endeavor.

BENEFITS REVIEW-TRAVEL AND PER DIEM: The 2011 Title IX school visit report deemed this benefit category *Satisfactory.* The report requested that all aspects of travel and per diem be addressed in new written guidelines for this category. At the time of the recent visit, a review of the Title IX file and interviews with administrators revealed that the school still has no written regulations regarding provision of parity within this benefit category. According to information in the 2015-16 and 2016-17 annual Title IX reports, the school was spending approximately \$42 per female athlete and \$56 per male athlete for travel and per diem. Due to the fact that the school had not developed the requested written guidelines for this category and interviews indicated there was no oversight in regard to equitable provision, this benefit area is deemed deficient. (See *KHSAA Recommended Action.*)

BENEFITS REVIEW- COACHING The 2011 Title IX school visit report designated this benefit category *Satisfactory.* The school's athletic director is responsible for evaluation of all head coaches. A written instrument is not part of this evaluation. A review of the school's extra service pay schedule for coaches showed parity. According to the information in the 2016-17 annual Title IX report, the only coaches who are compensated are boys and girls' basketball and volleyball. The total amounts spent for these sports appear equitable. The recent visit revealed that the coaching ratio for male athletes was 7.8 participants per coach and for females it was 7.9 participants per coach. Data offered by the athletic director indicated that 50% (2/4) of the head coaches of girls teams and 25% (1/4) of the head coaches of boys teams were on-campus employees.

BENEFITS REVIEW- LOCKER ROOMS, PRACTICE AND COMPETITIVE FACILITIES: The previous Title IX school visit report rated this benefit category *Satisfactory*. At the time of the original visit, all practice and playing venues appeared to be comparable. The girls' basketball, boys' basketball, archery, and volleyball teams practice and compete in the gym which is well-appointed and has sufficient seating. The baseball field provides adequate amenities. The boys and girls swim team participants practice at an excellent pool which is part of the Paducah Athletic Club that is located across the street from the school. The school has two identical dressing rooms (one for all male teams and one for all female teams) in the gym. All school-sponsored teams have equipment space either under the stage or in a large closet in the gym. The space available seems adequate. No coaching offices are provided at the school.

BENEFITS REVIEW- MEDICAL AND TRAINING FACILITIES AND SERVICES: The 2011 Title IX school visit report rated this benefit category *Satisfactory*. At that time, there was no posted usage schedule for the weight training room. The recent visit revealed there is no weight training room now. Most of the equipment used at the time of the previous visit has been sold to another school. There are a limited number of weights in the gym which are used sparingly by a few athletes. Some student athletes use equipment at the Paducah Athletic Club located across the street from the school. Services of an athletic trainer are not provided. Physical examinations are offered to any student athlete free of charge at the Orthopedic Institute on a designated day each year.

BENEFITS REVIEW- PUBLICITY: The 2011 Title IX school visit report designated this benefit category *Satisfactory.* The report requested that the school develop equitable guidelines regarding recognition of student athletes. The school does not currently have a cheerleading squad or dance team. This is the first year (2017-18) for the school band to perform at athletic events. The <u>tentative plan</u> is for the band to play at an equal number of boys and girls home basketball games as monitored for parity by the athletic director. The written regulations regarding parity in this benefit category that were requested by the 2011 Title IX school visit report were not provided during the recent visit. Interviews with students and school officials indicated that no guidelines were in place for the posting of banners or the provision of awards and post season banquets. Information in the annual Title IX reports for the past two years show that the school was spending approximately \$4.40 per female and \$4.75 per male athletes for awards. The failure of the school to provide evidence requested in 2011 that equity is being pursued in regards to all three areas evaluated in relation to recognition renders this benefit category deficient.

BENEFITS REVIEW- SUPPORT SERVICES: The 2011 Title IX school visit report rated this benefit category *Satisfactory.* According to school administrators, there are no booster clubs supporting athletic teams at the school. No athletic fees are charged for student participation. Information in the 2015-16 and 2016-17 annual Title IX reports showed that athletic spending slightly favored female athletes. Community Christian is a non-football playing school. Over the two-year period evaluated for this report, the school was spending approximately \$317.50 per female athlete and \$240 per male athlete for total support.
