Comments: The percentage of school enrollment compared to the percentage of participants meets the standards of Test 1. In 2010-2011 the enrollment percentage for females was 47% and the percentage of participation was 40.8%, however the percentages in the status report for 2011-2012 were improved to the acceptable range. The enrollment percentage for females was 47.6% and participation was 49%. Males were 53.4% of enrollment and 51% of participation.

Comments: This standard was not met, but Volleyball has been added in the last five years.

Accommodation of Interests and Abilities	X		The school has met the standard for Test 1 and Test 3. The 2006 report requested that the school keep the minutes from all Title IX meeting in the permanent file.		
Equipment and Supplies	X		The school appears to have equitable uniforms, equipment, and supplies. The school has a five-year rotation of uniforms, but a written rotation is again strongly recommended and included in the Title IX file and the coaches handbook. The teams have storage space for equipment, but it is again recommended that the assignments for each storage space be included in the coaches handbook.		
Scheduling of Games and Practice Time	X		The gym and weight room availability was scheduled and posted.		
Travel and Per Diem Allowances	X		The school does not transport teams, however, it is strongly recommended that a policy for transportation (for special occasions) be established as well as a policy establishing parameters for meals and lodging. This is a continuing issue from previous Title IX visits and the school is encouraged to establish guidelines and include them in the Title IX file and in the coach's handbook.		

Coaching	X	Coaching assignments for like sports are equitable, as well as the ratio of athlete to coach. The salary schedule is based on percentages from teachers' salary scale, but appears to be equitable. As stated in the audit report of 2006-2007, written assignments are needed for the coaches' offices and included in the coaches' handbook.
Locker Rooms, Practice and Competitive Facilities	X	All teams, with the exception of tennis, have assigned locker rooms and storage space. The tennis facility is off campus, but a locker room at school should be assigned for the tennis teams' use.

Medical and Training Facilities and Services	X	The training room is adequately equipped and is available to all athletes. A trainer is also available daily. It is recommended the trainer post a time schedule of her availability. There are two weight rooms, one designated for girls, however, all athletes have access to the original weight room. A schedule should be posted on both weight room doors.
Publicity	X	There are two cheerleading squads and the assignments are rotated between girls' and boys' games. Results of all teams' competitions are announced on the schools' PA and reported in the local newspaper. A policy for banners and awards needs to be created and kept in the school's Title IX folder.
Support Services	X	Spending was not equitable in the 2011-2012 report, however this appears to be a one year occurrence as no pattern of overspending for one gender over the other has been indicated.

5. Brief Summary/Analysis of the Improvement Plan (Form T-60)

The school has completed re-surfacing of the track with a rubberized surface. A weight room for the girls has been completed. Both of these projects are excellent facilities for the athletes at Conner High School.

The school continues in its efforts to increase female participation.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

No deficiencies were observed in the over-all athletic program.

No major new deficiencies were observed in the total athletic program at Conner High School. However, the school needs to establish written policies for the following and submit them to the KHSAA by **April 30, 2013**:

A list designating locker room and storage space for all teams

A policy outlining the uniform rotation

A travel and per diem policy

A Booster Club Agreement

A schedule for weight room use to be posted outside of each weight room

A list of all Gender Equity Review Committee Meeting minutes for 2012-2013

8. KHSAA Recommended Action in relation to reoccurring deficiencies

There are no reoccurring deficiencies at Conner High School. The scheduling of games and practice times was listed as a deficiency during the December 14, 2006 visit, but has since been addressed and corrected.
