It was suggested that the school personnel consider establishing a rotation plan for the replacement of uniforms. Form T-6 was incomplete and shall be re-submitted by June 5, 2001.

Coaching			It was noted that the baseball team had three more coaches than the softball team. Two of the three coaches were volunteers. This provides the baseball team a slight advantage. One of the girls' soccer coaches receives \$280.00 plus dollars less than the boys' soccer coach who had less experience.
Locker Rooms, Practice and Competitive Facilities	X		The practice and competitive facilities were of good quality and ample storage space is provided for both programs. There is a shortage of locker space for the girls' programs and the school is addressing this issue. The re-assignment of locker space usage and the addition of lockers could resolve the locker problem. The small lockers that are not used could be removed. The girls' softball dugouts are large metal cage type dugouts while the baseball team has nicer cement block dugouts.

(Selection of Cheerleaders) On or before **June 5, 2001**, the school is requested to provide information to the KHSAA concerning the manner in which cheerleaders are selected for boys' and girls' teams. If cheerleaders are selected in such a way as to result in arguably better (i.e. "A" team vs. "B" team) cheerleaders performing at boys' events, the school shall also submit a plan under which cheerleaders of equal ability shall perform at an equal number of boys' and girls' games in comparable sport (i.e., boys' varsity and girls' varsity basketball game).

(Prime Time Contest/Girls' Basketball) On or before **June 5, 2001**, the school is requested to provide information to the KHSAA concerning the number of "prime time" games scheduled (games to be played on Friday and/or Saturday nights) for its girls' varsity basketball team during the 2000/2001 season. To the extent that a fewer percentage of girls' games are played during prime times (when compared with the percentage of boys' games scheduled for prime times), the school shall advise the KHSAA of action it intends to take to immediately correct the difference.
