Accommodation of Interests and Abilities	X		According to data submitted to KHSAA, the school meets the standard established in Test #1 for the school years 1999-2000, 2000-2001, and 2001-2002. The school appears to meet the standard established in Test #2 for the school years 1999-2000, 2000-2001, and 2001-2002. The correct method for calculations of opportunities tests was discussed with school officials. The proper development of and follow-up to a corrective action plan was discussed with school officials.
Equipment and Supplies	X		The school visit showed a good quality of equipment and uniforms are supplied for all athletic participants. School officials were alerted to the fact that there should be a team sheet (T-5) for every individual team at the school. The school currently has a uniform replacement plan based on a five-year rotation.
Scheduling of Games and Practice Time		X	The school is considered to be currently deficient in this area due to lack of progress in the area of "prime time" scheduling of girls' basketball games. According to the school's 2002-2003 girls' basketball schedule, 31% of their total games are played in "prime time" and 25% of their home games are played in "prime time". (See KHSAA Recommended Action). It appears there is a slight disparity in total number of games scheduled by girls' teams versus the total number of games scheduled for the boys' teams. It is requested that the Gender Equity Review Committee review this situation.
Travel and Per Diem Allowances	X		School officials were alerted to the fact that the information on the summary sheet does not match the information on the team sheets in relation to meal allotments. These forms are to be corrected in the school's Title IX file.
Coaching	X		The school district's extra service pay schedule appears to be equitable.

Locker Rooms, Practice and Competitive Facilities	X		The school visit showed that all shared athletic facilities appear to be shared equitably. The need for an assigned dressing area for every athlete at the school was discussed with school officials. There appears to be a slight disparity in benefits provided in relation to the baseball and softball complexes. The school is currently involved in several projects which are improving the softball field. It was emphasized to school officials that this progress should continue.
Medical and Training Facilities and Services	X		All athletes at Dawson Springs High School have the privilege of using the Trover Clinic for weight training.
Publicity	X		Cheerleading was discussed. The school currently has one cheerleading squad which cheers at all home boys' and girls' basketball games and an equal number of away games for both boys and girls. It was suggested that the school look into the feasibility of developing a policy for the posting of athletic recognition at the school.
Support Services	X		According to Forms T-35 and T-36 submitted by the school in 2001-2002, the school spends \$22.80 per female athlete on equipment and supplies while it spends \$44.85 per male athlete on equipment and supplies. The 1999-2000 Forms T-35 and T-36 could not be fully analyzed because school officials were unable to say for sure if all spending sources were included. Therefore, the Gender Equity Review Committee was requested to closely review and continually monitor athletic spending and attempt to insure parity. Booster clubs were discussed. The school appears to be in period of transition in relation to booster groups. The need for monitoring by school officials was emphasized.

5. Brief Summary/Analysis of the Corrective Action Plan (T-60)

The school's most recent corrective action plan calls for renovation of the girls' soccer field, landscaping of softball infield, construction of a swimming pool, construction of new lockers in boys' and girls' dressing rooms, and the mounting of an indoor batting cage for softball and baseball.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

The school's major deficiency appears to be in the area of "prime time" scheduling for girls' basketball. It should also be emphasized that monitoring of spending and booster activities is very important.

7. Facility Recommendations or Concerns

School and KHSAA officials agreed that while not an equity issue, the lack of lockers and dressing areas was the major facility concern.
