Comments: After reviewing the past two Student Interest Surveys and looking at the current athletic opportunities at Fern Creek High School it appears that the standard established in Test Three for provisions of athletic opportunities is currently being met.

Comments: The most recent student interest surveys show that Fern Creek is meeting the needs and interests of the student athletes. The last survey shows some interest in the new sports activities being offered by the KHSAA. Accommodation of Interests and Abilities	Х		Fern Creek is offering the activities that their students are interested in and there are plans to add even more opportunities in the future.
Equipment and Supplies	X		In the 2002 Audit Fern Creek was satisfactory in this area but the school was urged to establish a Uniform Rotation Plan. Noted problems with equipment storage space was pointed out. In 2004 the school received a second audit and again was advised to develop a uniform rotation plan. The Uniform Rotation Plan is now in place but the Gender Equity Review Committee needs to re-evaluate it as there were areas pointed out that could make the policy even better.
Scheduling of Games and Practice Time	Х		In 2002 the school received a satisfactory in this area although it was reported that some coaches were unhappy with practice times. The school was advised to establish written practice schedules for all sports. A satisfactory was also given in 2004 as well as in 2013.
Travel and Per Diem Allowances	X		In 2002 the school received a satisfactory in this area although there were discrepancies on team and summary reports regarding the amount of monies spent for meals in various sports. The interviews revealed that student athletes were being transported in personal cars. In 2004 the school again received a satisfactory but the school was advised to develop a transportation policy to cover underage drivers. In 2013 the school had a much better Travel and Per-Diem Policy however several areas were pointed out that were not included in the policy and need to be reviewed by the Gender Equity Review Committee.
Coaching	Х		The first two Audits revealed that the school was satisfactory in this area and the 2013 Audit remains with a satisfactory. The Gender Equity Committee needs to keep a close eye on this area as there appears to be some disparity in relation to compensation and accountability of coaches. Both of these areas need to be monitored by the Gender Equity Review Committee and school administrators for the provision of parity.

Locker Rooms, Practice and Competitive Facilities	In the 2002 Audit this was an area that was deficient. Some locker rooms were under renovation however many athletic teams were not assigned a locker room. In 2004 there are still athletic teams that have no locker rooms assigned to them. After touring the dressing rooms in 2013 we found that all the teams are now assigned athletic dressing rooms. The Gender Equity Review Committee needs to take a tour of the dressing rooms and ascertain if further changes are needed. It was noted that several improvements have been made at the softball complex since the last school visit.

Medical and Training Facilities and Services	X	At the time of the first two audits the school was satisfactory in this area. Both audits advised that a weight room schedule needs to be posted. With the 2013 Audit is was evident that the females now have equal access with schedule times now present for females. A very nice training room is in place that is well stocked.
Publicity	X	In 2002 the school received a satisfactory in this area however it was pointed out that there was disparity in the way the cheerleads were scheduled for boys and girls athletic activities. In 2004 the school received a satisfactory in this area but the school was advised to develop an Awards and Banner Policy. In 2013 the Cheerleading issues appear to have been addressed. An Awards and Banner Policy is now in place but the Gender Equity Committee needs to take a close look and update it to cover all the aspects within this benefit category.
Support Services	X	The school has had some problems in this area in the past because of improper and inaccurate reporting on the T-35 and T-36 forms. During the past year the school has had some issues with Booster Clubs. The Administration has since dissolved all booster club activities in regards to the Athletic Department.
