School personnel need to adequately address the Corrective Action Plan and the advantages it has identified during the self-audit.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

The percentage of coaches that are off-campus is extremely high for both programs. Only four of seventeen coaches are on-campus, and none of the four are head coaches. The benefits of having coaches that are on-campus are not available to the students at Fort Campbell High School.

7. Facility Recommendations or Concerns

There appeared to be some storage shortage. The plans for the addition of lights on the softball facility on-campus should be immediately addressed.
