The school was urged to have a written policy regarding uniform replacement. The team reports for this category were completed by one individual. Individual forms should be completed by individual coaches and then summarized.

The girls' basketball played only one game in "prime time" in 2002-2003. The school shall address "prime time" scheduling for girls' basketball for the 2003-2004 school year.
Travel and Per Diem Allowances			The KHSAA Audit Staff was unable to determine status of this area due to incomplete team reports and inaccurate Summary Report. Football, boys' basketball and girls' basketball were the only teams to complete this report.
Coaching	X		The school has a large number of coaches off- campus. However, both programs suffer the loss of the benefits an on-campus coach provides. The rate of compensation for same- sport coaches is comparable.

It was strongly suggested that a roof be placed over the wire dugouts that have been placed at the softball facility, and that the school should complete a comparable locker room project for softball before any additional monies are spent for baseball.

The school does not have a certified trainer available to all athletes. Form T-20 was not completed by any team. It was noted on the form that "all teams use same facility".

The number of coaches on staff that are off-campus in the Athletic Department is somewhat of a deficiency to the athletic program.

If cheerleaders are selected in such a way as to result in arguably better (i.e. "A" team vs. "B" team) cheerleaders performing at boys' events, the school shall also submit a plan under which cheerleaders of equal ability shall perform at an equal number of boys' and girls' games in comparable sport (i.e., boys' varsity and girls' varsity basketball game).
