Comments: At the time of this audit Hopkinsville High School is offering every sport that the KHSAA has to offer. During the past five years only one level of competitive offerings has been added so it appears that Hopkinsville is not in compliance with Test 2.
C). Was the Full and Effective Accommodations of Interest and Abilities Test (T-3) an area in which the school met Title IX Opportunities compliance? Yes ⊠ No □
Comments: With all the sports offerings for boys and girls at Hopkinsville it appears that the school is in compliance with the requirements for passing Test 3. It is pointed out that the last two student interest surveys have had a low return rate so the Gender Equity Review Committee should look at ways to get a better return rate when the survey is given again in 2011-2012.

Accommodation of Interests and Abilities	X		The school is offering every sport offered by the KHSAA. The offerings at the varsity, junior varsity, and freshman levels are provided as the numbers indicate. It is recommended that the Gender Equity Review Committee take a close look at female participation over the past three years and what appears to be a decline in female participation. During this same time period there appears to be an increase in male participation. The committee should explore ways to increase female participation.
Equipment and Supplies	X		At the time of the original Title IX Audit in March of 2003 it was pointed out that the school needed a Uniform Rotation Plan. At the time of this audit there is a rotation plan in place, but it is recommended that the Gender Equity Review Committee take a close look and re-evaluate the policy. The current policy is not specific as to when a team gets new uniforms and indicates that they hope to go to a three year rotation. It is highly recommended that a rotation be put in place that designates when each sport is due for a uniform replacement. A copy of the Uniform Rotation Plan should be placed in the permanent Title IX File and the Athletic Handbook.
Scheduling of Games and Practice Time	х		The school is in compliance with Prime Date scheduling. Schedules are in place to show that shared practice facilities in like sports are on a rotation and of equal access for both male and female athletes.
Travel and Per Diem Allowances	x		At the time of the original audit the Gender Equity Review Committee was asked to develop a Travel and Per-Diem Policy. At the time of this audit a Travel Policy was in place but it was located in two or three different areas of the file. The committee needs to reevaluate the Travel and Per-Diem policy so that all the aspects of travel are combined in one area. A copy of the policy should be placed in the permanent Title IX File and the Athletic Handbook.

5. Brief Summary/Analysis of the Corrective Action Plan (Form T-60)

At the present time the biggest task before the Gender Equity Review Committee is the re-evaluation of several policies. The new Athletic Director is in his first year and has some very good ideas that he should document in a corrective action plan. A copy of any and all corrective action agreed upon by the Gender Equity Review Committee should be sent to the KHSAA by May 16, 2011.

6. KHSAA Recommended Action in relation to new deficiencies

> At the time of the original audit there were some concerns with some of the policies the school had never put in place. These policies are now in the permanent Title IX file, but many are very vague and would be hard for outsiders to understand if the Title IX file or Athletic Handbook were observed. There are no overall deficiencies at this time but the Gender Equity Review Committee is being asked to reevaluate several policies.

7. KHSAA Recommended Action in relation to reoccurring deficiencies

> A potential red flag area is dealing with the control of Booster Clubs in regards to spending. The Gender Equity Review Committee needs to strongly consider implementing signed Booster Club agreements. .
