Accommodation of Interests and Abilities	x		According to the data submitted on the 2012 Student Interest Survey, students in grades 8 thru 11 were surveyed with a return rate of 83%. There are currently 9 sport level opportunities for females and 9 for males. The school is to be commended for its consistent rate of proportionality between participation and enrollment.
Equipment and Supplies	X		Uniforms viewed appeared to be of mid to high quality and equivalent in quantity. There was written evidence of a uniform review and/or replacement plan in place that showed parity for all sports. All other viewed equipment appeared to be equivalent in quality and available for equitable access. A two-year expenditure average shows approximately \$125.00 spent per female athlete and \$177.00 spent per male athlete.
Scheduling of Games and Practice Time	X		Equitable, written plans were presented regarding the scheduling of games and practice times. There was written and posted evidence showing access and use of shared facilities.
Travel and Per Diem Allowances	X		There was written evidence of a travel and per diem guideline which provided for equivalence and administrative oversight. Interviews with students and administrators indicated the use of school bus and/or school board owned vehicles for transport as well as the opportunity for overnight trips for competitive events. A two-year expenditure average shows approximately \$87.00 spent per female athlete and \$87.00 spent per male athlete.
Coaching	x		There was written evidence of a school board approved pay schedule that showed equivalence and parity in salary and the number of coaching positions for like sports.

		The school is to be commended for the number of on-campus coaches for the girls and boys sports teams. The current access ratio of coach to athlete is 12:1 for both males and females.
Locker Rooms, Practice and Competitive Facilities	X	At the time of this visit, practice and competitive events for volleyball, cross country, and basketball were taking place at the old Jackson County High School. The newly occupied Jackson County High School is in the final completion stages of the gymnasium that will house practice and competition sites for volleyball, girls and boys basketball, indoor hitting facilities for softball / baseball, four (4) locker rooms, additional storage areas, and available office space for coaches. Administrators also indicated that final bids had been approved for the development of an on-site softball field, baseball field, cross country course, and golf practice area. These are expected to be completed and playable for the 2013 season. Evidence of the beginning development of this project was viewed. Currently, practice and competition for softball and baseball are located at the Tyner Elementary school, approximately 12 miles from the high school. The girls and boys golf team currently compete at Crooked Creek Golf Course, located in Laurel County, approximately 25 miles away. Golf teams also have equitable access for year round practice at the Saghollow Course in Owsley County. Football practices and competes at a facility located at the new high school. There was written evidence of locker room assignment for all teams. All current locker rooms appear to be equitable and with similar amenities.

Medical and Training Facilities and Services	X	The weight room is located in a separate building adjacent to the high school and provides equitable access to all sports. The weight room is well organized and equipped with proper equipment for female use. There was written and posted evidence of a weight room use schedule which showed equivalent and available access. An Athletic Trainer from the UK Sports Medicine Outreach Program visits the school at least one (1) day a week and provides service to all athletes. Administrators indicate that athletic physicals are made available to all athletes through schedules with a local Nurse Practitioner and/or the Jackson County High School Nurse.
Publicity	x	Interviews with students and coaches indicated that an awards night recognition program was done for all sports. There was written evidence of an awards guideline that indicated criteria for banner recognition and display. There was no written evidence for the provision and criteria of earned awards, or other types of possible recognition (i.e. retired jerseys, rings, picture display).

		The school has one cheerleading squad that cheers all home games for football, girls and boys basketball, as well as post season contests. To insure equity, all support groups are scheduled with administrative oversight. A review of a two year spending pattern could not be accurately determined as there was a majority of '0' amounts reported in the area of Awards on the 2011-2012 Annual Report.

Support Services	X	Interviews with administrators indicate that there are no booster clubs and that all fundraising dollars are deposited in school

	accounts. There was written evidence of guideline for fundraiser approval and for the approval of items for purchase. Coaches interviewed were well informed and aware of the school process for approval to purchase items with school funds. There was written evidence of assigned storage space for all sports. Office space for coach access is currently available at the old Jackson County High School. A football coach's office, located at the new high school, just recently became accessible. An overall two-year spending summary could not be accurately evaluated as inconclusive amounts were reported in one of the benefit areas (awards). (see KHSAA recommendation c.)
