Eight out of ten head coaches for boys are on campus during the day and nine out of eleven head coaches for girls on campus. Using a written instrument, the Athletic Director is responsible for evaluating head coaches at the end of each season.

| BENEFITS REVIEW- MEDICAL AND TRAINING FACILITIES AND SERVICES: The training and weight room facility has two levels-the lower room containing cardio-machines and equipment and the upper levels houses free weights, kettle bells, and weight machines. All equipment is appropriate for use by female athletes. Interviews with athletes and coaches indicate use by all athletes. The school employs a full time strength and conditioning coach who develops programs for all sport teams. KCD has an athletic trainer that is present daily and remains on site until practice or competition has been completed. Contact information is posted on the training room door. The training room is located near the gym and easily accessible to all. Physical examinations are the responsibility of the individual athlete. <br> Comprehensive emergency plans were viewed in the file and also posted at each athletic venue. |  |  |

BENEFITS REVIEW- SUPPORT SERVICES: KCD has limited office space available for coaches. Interviews with the Athletic Director and school administrators indicate plans for renovations will fully address this issue. Lack of office space and renovation plans should be addressed in the annual report on T-61 Improvement Plan. The school has one booster club that works closely with the Athletic Director to ensure equity and compliance to Title IX standards. Overall expenditures fall within acceptable parameters in both percentage and per athlete spending. On a two -year average, approximately $\$ 399$ in spent on male athlete and $\$ 470$ on female athletes.
