ACCOMMODATIONS OF INTEREST AND ABILITIES NOTES: In review of the annual 2023-24 Title IX Annual Report for Leslie County, it appears the school has failed to meet the standard for provision of opportunities on any of the three tests. After discussion with athletic director and tour of the school's facilities, failure to meet these standards is likely due to incorrect reporting on the annual report. School administration was reminded that accurate submission of team rosters provides data that results in a complete analysis in the provision of Opportunities. To meet the standard for Test 3, clear instructions to the students, prior to the Student Interest Survey, are important as the results of the survey should reflect interest in all sports/sport activities currently offered and possible additions to Leslie County. The most recent survey (administered March 5, 2024) was deemed invalid due to the zeros reported in the school's current sport offerings and many new activities. To determine student interests and meet the standard of Test 3 for full and effective accommodation of interest and abilities, it is recommended Leslie County administer the Student Interest Survey electronically the 2024-25 school year. Leslie County currently offers eleven sports teams for males and twelve sports teams for females. The most recent sports added are Esports, girls and boys golf and girls' and boys' indoor track.

BENEFITS REVIEW- EQUIPMENT AND SUPPLIES: There was written evidence of a uniform review and/or replacement plan that appears to be equivalent for all teams. Uniforms are purchased on a four -year rotation with funds provided by Leslie County Board of Education. Uniforms viewed were mid to high quality and equivalent in number for "like sports". Shoes were provided for girls' basketball and volleyball teams. Coaches and athletes interviewed were aware of the uniform guidelines. All other equipment viewed appeared to be well-maintained and suitable for the specific sport. Spending for equipment and supplies on a two-year average was approximately \$170 per male and \$201 per female athlete and falls within acceptable parameters.

BENEFITS REVIEW- SCHEDULING OF GAMES AND PRACTICE TIMES: All competitive schedules viewed appeared to be comparable in number of events and times except softball/baseball. The softball schedule viewed showed ten fewer games than baseball. Interviews with the administration indicated scheduling for softball was not complete at this time and additional games would be on the schedule.

The Nixon Center is a multipurpose gymnasium shared with volleyball and girls' and boys' basketball with priority given to the in-season team. Written evidence of a schedule for the Nixon Center was not available. The athletic director indicated the coaches work together to develop a schedule for the facility monthly. It is recommended written evidence for usage of the Nixon Center be posted on site and placed in the Title IX file. The schedule for the weight rooms (2) is posted on site and appears to provide equitable use for both male and female athletes.

BENEFITS REVIEW- TRAVEL AND PER DIEM: Written evidence viewed indicated transportation for athletic events is by school bus with the provision to use a charter bus when deemed necessary. Procedure for approval and scheduling a charter bus was included. Guidelines for meals allows \$15.00 a day per athlete. Not included in the travel guidelines is parameters for over-night housing.

Spending for travel/per diem could not be assessed due to zeros reported on the T-35 form in 2022-23 and 2023-24 Annual Reports. The athletic director was provided information as to what data should to be entered on form T-35 2024-25 Annual report to ensure parity in expenditures for travel.

**BENEFITS REVIEW- COACHING:** There was written evidence of a Leslie County salary schedule that showed overall equivalence in coaching stipends and parity in number of positions for all sports. Regarding accessibility, data provided showed the athlete to coach ratio is 10:1 for both female and male athletes. Accessibility is no issue as most head coaches are employed on campus. Interview with the athletic director indicated that all coaches are evaluated each year using a written instrument.

BENEFITS REVIEW- LOCKER ROOMS, PRACTICE AND COMPETITIVE FACILITIES: Practice and competition venues for Leslie County are located on campus. The football field is turf, lights, press box, new digital scoreboard, and ample bleacher seating. Adjacent to the football stadium is a separate six (6) lane track recently resurfaced. The Nixon Center houses the gymnasium for volleyball, girls' and boys' basketball and locker room facilities. The baseball field and softball field are side by side with comparable amenities. Archery practices in the school cafeteria. A course for cross county is on campus and meets are held several times a season. All other facilities meet the standard to host post season contests.

Written evidence for the assignment of locker rooms did not include all teams. While touring the facilities it was noted two locker rooms in the Nixon Center that were not being used by Leslie County athletes. It is recommended the athletic director and GERC evaluate **available** locker rooms and assign ALL teams a dressing area. According to Title IX, all students have the right to be provided a safe and secure place to dress and a safe and secure place to store their belongings.

BENEFITS REVIEW- MEDICAL AND TRAINING FACILITIES AND SERVICE: Leslie County has two weight rooms that are easily accessible and appropriately equipped for female usage. A schedule is posted in each weight room that appears to provide equal access and time slots to both male and female teams. The school offers weight training classes during the school day for male and female athletes. A local physical therapist contracted by Leslie County provides athletic training services and attends afternoon practices and all home athletic competitive events. Physical exams are provided in partnership with Grace Health and the school nurse and are free of charge to all students.

BENEFITS REVIEW- PUBLICITY: Leslie County has one cheer squad and a pep band that serves as support groups for football, girls', and boys' basketball teams. The athletic director provides oversight to ensure equitable support and attendance to all teams. There was written evidence of an awards/recognition guideline that includes the provision of team and individual awards, team and individual banners, and banquets. Interviews with coaches and athletes indicate all teams hold post season recognition programs. The athletic director was reminded to report all expenditures made by teams for post season events. Spending on average for a two -year period is approximately \$19 per male athlete and \$19 per female.

BENEFITS REVIEW- SUPPORT SERVICES: The assignment of office space for coaches appears to be equitable. There are no booster clubs at Leslie County High School and all teams have individual accounts in house. There is a procedure in place for approval of fundraising projects and expenditures that provides administrative oversight. Interviews with the coaches indicate they are knowledgeable of the procedures required for fundraising activities and purchasing. With the information submitted it appears overall spending for a two -year period falls within acceptable parameters in both percentage (55% male and 45% female) and per athlete basis (\$431 male and \$426 female). The athletic director is reminded that complete and accurate reporting of expenditures in all benefit categories provides a true assessment of Leslie County's athletic programs.
