Coaching	X		No deficiencies were found. However, it is strongly recommended that additional female coaches be employed. Also, the Gender Equity Committee should provide a written policy dealing with supplemental salaries for coaches.
Locker Rooms, Practice and Competitive Facilities	Х		No deficiencies were found. The Audit Team recommends the following: 1) A press box for the softball field, 2) resurface the tennis courts, and 3) resurface the track.
Medical and Training Facilities and Services	X		No deficiencies were found. The school should be commended for having a full-time trainer. Also, it is recommended that a weight room schedule be posted.
Publicity	X		No deficiencies were found. A written policy for the display of banners, etc. in the gym should be established.

Recommendations include: 1) continue to accommodate the interests of the students, 2) add additional storage for minor sports, 3) additional prime time games for girls' basketball, 4) a written policy for pre and post game meals, display of banners, selection and performance of cheerleaders, funding and activities of booster clubs, and for the provision of supplemental salaries for coaches, 5) the addition of female coaches, 6) a press box for girls' softball, 7) resurface the track and tennis courts.
