However, after the reviewing the 2000-2001 and the 2001-2002 Annual Title IX reports, it appears that the school has made satisfactory progress in this area.

Locker Rooms, Practice and Competitive Facilities		X	The boys' and girls' soccer teams play on the same field which has no lights. Double headers in which the girls usually play first are sometimes scheduled so early that parents cannot attend because they are still working. It is recommended that lights be installed on the soccer field. Also, the baseball field has a press box, concession stand, and protective padding on the outside fence. The softball field does not have any of these advantages. It is recommended that the Gender Equity Review Committee address these items on their Corrective Action Plan, Form T-60, that is to be submitted on their 2002-2003 Annual Title IX Report. A schedule for use of the weight rooms should be posted.

**5. Brief Summary/Analysis of the Corrective Action Plan (T-60)**

The 1999-2000 Corrective Action Plan does not reflect the needs of the interscholastic program. However, the 2000-2001 and the 2001-2002 reports include items designed to promote more participation of female athletes. Prime time games for girls' sports teams were also being added. Future Corrective Action Plans should include adding lights to the soccer field and building a press box and concession stand for the softball field. Also, future plans should continue to include adding prime time games for girls' basketball as well as additional female participation.

It is recommended that lights be installed on the soccer field. It is also recommended that the school should pursue building a press box and concession stand for the softball field and installing protective padding on the outfield fence.
