Accommodation of Interests and Abilities	X		The responses and information submitted by the school indicate that the standard for Test 1, the Test for Substantial Proportionality, have been met. The information submitted for Test 3 was incorrectly recorded. The number of students issued the survey was omitted, and even though the school indicated a 100% return rate, it was not possible to verify this number. This was probably an oversight, but the data needs to be seen in order to prove compliance. In the 2015-2016 Annual Report, the Test 3 data needs to be reported correctly.
Equipment and Supplies	X		There is a uniform, replacement cycle plan based on a 4-year rotation. Replacement of a teams' uniforms prior to that teams turn in the rotation plan, will be based on need due to wear and tear or loss of the uniforms. The quality and quantity of uniforms appeared to be comparable, but not all uniforms were available to determine the accuracy of this statement. During the tour of facilities, there was evidence of complete uniforms for several teams, in the storage areas. The uniform policy is on file in the Title IX file. Spending in this area on a two-year average was in an acceptable range.
Scheduling of Games and Practice Time	X		Each school sponsored team has a schedule in the file. For like sports, the scheduling appears comparable for competition opportunities. For shared facilities, there was a schedule for practice times on file for all the facilities used by various teams. All teams appeared to have a designated locker room space assigned, with some teams like swimming and golf, using locker room space on sight and not at the school. A list of storage space for each team was on file. With an extra gym and new field house available, this eased

		the assignments for locker rooms and storage rooms.
Travel and Per Diem Allowances	X	There are travel guidelines that show transportation to games is provided by the athletic department. Out of state competition appeared comparable for like sports, with both male and female teams having the opportunity to travel to out-of-state competition. Although no specific amounts for lodging and meals is given, the guidelines do state that meal money will be the same as allowed by the KHSAA. The Gender Equity Review Committee should review the Travel and Per diem policies and make sure they are more specific.
Coaching	X	The school has an equitable pay scale on file for all levels of coaches for all the athletic teams. The base pay is the same for like sports, with an increase for experience. The ratio for access of coaches is equitable; there are 6 out of 12 boys' coaches and 5 out of 11 coaches for girls on campus. Coaches are provided with a handbook containing all the guidelines for the athletic department and there is an evaluation in place for the coaches.
Locker Room, Practice and Competitive Facilities	X	There is no disparity in locker room assignments, except for the wrestling team's locker room. This team is assigned the rest room at the multipurpose room for its dressing room. It is recommended that a locker room be made available for the wrestlers in order to ensure that they have privacy and security for personal items. Nelson Co. has ample storage space and all teams have assignments on file. The practice areas are shared equitably. A prior audit report concerned inequities for the baseball and softball fields, but this issue no longer exists. The ball fields have been improved and are equitable with amenities for these athletes.
Medical and Training Facilities and Services	Х	The weight room is located in the field house, connected with the football dressing room but has no separation between these two rooms. Because it is located in a large open area with the football dressing room, there could potentially be a problem for the female athletes using the facility. It was explained that the

		scheduling of female teams is at a time when the football team is not using the facility. There are a variety of machines that are suitable for both male and female athletes, but it appears there is a shortage of lighter weights for the female athletes. It is suggested that more female appropriate weights be made available. There is a usage schedule available for fall, winter, and spring sports, but it is not posted inside or outside the room. It is recommended the schedule be posted outside the entrance to the weight room as well as inside. Nelson County has an athletic trainer provided by KORT Therapy. The trainer is available each day, but there appeared to be no schedule for availability posted showing access for athletes to trainer. It is recommended that the trainer develop and post a schedule of availability to athletes as well as contact information. The school does not provide physicals for the athletes. There is a copy of Athletic Facility Emergency Medical Action Plan available.
Publicity	X	The cheerleading squad supports football, and boys' and girls' basketball teams. There is also a Pep Band which supports the football and basketball teams at home games. The AD has oversight of the cheerleaders and band performances at these games. There are guidelines on file in the coaches athletic handbook and Title IX file for displaying of banners, but no guidelines were developed for display of pictures; either team or individual pictures. It is recommended that the Gender Equity Review Committee develop guidelines for picture displays. Whether the awards are paid for by the school or thru a booster, the value of these awards need to be recorded. It is recommended that school administrators examine this category on the T-35 form to ensure it is recorded correctly.
Support Services	Х	There is no Athletic Booster Club at Nelson County High School, but on the T-35 form

		several of the expenditures are recorded as being paid by boosters. The athletic teams conduct various fundraisers, which must be approved by the principal and board of education. All funds are deposited into the schools account. Spending for the past two years has been very equitable, falling within the range of compliance.

(Locker Room, Practice and Competitive Facilities) – By March 31, 2016 the school is to submit to the KHSAA evidence of provision of a locker room.

(Training Facilities and Services) – By March 31, 2016 the school is to submit to the KHSAA a usage schedule for the weight training room which shows provision of equitable access.

By March 31, 2016 the school is to submit to the KHSAA a written schedule showing the availability of the school's athletic trainer.

(Publicity) – By March 31, 2016 the school is to submit to the KHKSAA written regulations for display of athletic pictures.
