Accommodation of Interests and Abilities	X		The most recent Student Interest Survey was administered during the 2013-2014 school year. Submitted data indicated that students in grades 8-11 were surveyed with a return rate of 98%. Reported data supports the information as provided on the T-3 form(s) with reference to interest in lacrosse and archery. Both of these sports/activities have been added for both girls and boys. Oldham County High School currently offers twelve (12) varsity sports/activities for males and eleven (11) for females. A total of 25 sport level opportunities are provided for males and 23 are provided for the females.
Equipment and Supplies	X		There was written evidence of a three (3) year uniform review plan for team uniforms that were purchased and retained by the school. Sports where athletes purchase and retain their own uniforms, on a yearly basis, include boys and girls golf, swimming, tennis, and archery. As females are the under-represented gender at Oldham County High School, an item that may be addressed by the Gender Equity Committee is the school purchase of uniform tops for the boy's soccer team while the girl's soccer members purchase their own uniform tops. Viewed uniforms were of excellent quality and comparable in the quantity provided. An overall review of spending in this category showed that approximately \$90.00 was spent per male athlete and \$72.00 spent per female athlete. All other viewed equipment appeared to be of good quality and available for equitable access.

Scheduling of Games and Practice Time	X	There was viewed evidence of the most recent game schedules for all sports in the Title IX file. Viewed schedules showed comparability and equity with regard to the number of competitive event opportunities provided. There was also viewed evidence of equitable scheduling and usage for the gymnasiums in building one and building three. Interviews with administration indicated that there are times when the game soccer/lacrosse field and soccer/lacrosse practice field are shared by the boys and girl's soccer/lacrosse teams, however, there was not a schedule showing equitable usage or access to these as a shared facility. (see recommendation 7.a.)
Travel and Per Diem Allowances	X	There was written evidence of a travel and per diem guideline that stipulated administrative approval relative to special mode of transport (common carrier) and all overnight trips. All other transportation is provided by local district school bus service. All meal and/or hotel allowances require prior approval by school administration and payments are handled through the purchase order process. An overall review of spending in this category showed that approximately \$157.00 was spent per male athlete and \$143.00 spent per female athlete.
Coaching	X	There was viewed evidence of a school board approved salary schedule which showed overall equivalence in the base salary provided and comparable in the number of coaching positions, particularly for the like sports. Evidence showed that total salaries are paid on a percentage of a coach's base salary

		including educational rank and experience. The approximate athlete to coach ratio, with regard to accessibility, is 11:1 for males and 13:1 for females. Interviews with administration indicated that approximately 40% of the head coaches for female teams are located oncampus and approximately 50% of the head coaches for male teams are located oncampus. School administration also indicated that the Athletic Director conducts end-of-season exit meetings with each head coach. Written documentation is currently not maintained.
Locker Room, Practice and Competitive Facilities	X	There was written evidence of locker room and storage assignment for all teams. Viewed locker rooms appear to be equitable and with similar amenities. All facilities are very well maintained and are located on the school campus except for golf and swimming. The golf teams utilize sites at the Oldham County Country Club and Eagle Creek Golf Course for practice and play. The swim teams utilizes the facility at the YMCA. There are two (2) gymnasiums. One is located in the main school, referred to as building one and the second one is located in the old gym referred to as building three. The volleyball and basketball teams utilize the main gym for practice and games. The building three gym is only used for practice and is scheduled on an equitable basis for boys and girls basketball. Viewed facility differences included two outdoor hitting areas and bullpen area for baseball compared to a single outdoor hitting area for softball. The softball field has a permanent building structure for a press box while the baseball field had a ground level, open wood frame type press box. Also, due to some recent storm/wind damage, the outfield fence at the baseball field appears to need some repair. The soccer and lacrosse teams have a game and practice field area that is shared by both the boys and girls teams. The wrestling team has an exclusive practice area

		located on the lower level of the main school building. Wrestling competitions are hosted in the main gym. Football and track practice and compete at the Bell Stadium, on the school campus. There are five tennis courts, on campus, which provides for practice and competition for the boys and girls teams. The Arvin Center is the location assigned for archery team practices. This center is an extension of the high school. The boys and girls cross country teams have a practice area that includes parts of the school campus. Competitions are held at Wendell Moore Park and at EP Tom Sawyer Park. All facilities have served as host sites for post season play.
Medical and Training Facilities and Services	X	There are two (2) weight conditioning rooms at Oldham County High School. One is located on the lower level of the main school building and the other is located in the fieldhouse, adjacent to the high school. Both are spacious and very well maintained. It appears that the weight room located in the high school has more appropriate equipment for female use, however, interviews with students and coaches indicate use of both weight rooms. There was evidence of a schedule for both weight rooms showing equitable use and access. These schedules were in the Title IX file and posted at each site. Athletic Training services are available on a daily basis and at all home events. Interviews with administration indicate a contract with Baptist Health for these services. The main training room is located in large, spacious area off the gymnasium. A schedule showing availability and contact was posted at the site. School administrators also indicated that athletic physicals are the responsibility of each student. There was viewed evidence of athletic venue emergency plans located in the Title IX file and also posted at each venue.

Publicity	X	There was written evidence of a recognition guideline that provided the specifics for certificates/letters/bars, banner display, trophy display, and end-of-season banquets. Interviews with administration indicated that there is one cheerleading squad, a dance team, and pep band that provides support for the football, girls and boys basketball teams. Pegasus Sports also provides radio and video coverage of select football, boys and girls basketball games. Interviews also stated that the athletic director provides administrative oversight to ensure overall equitable support by each group. An overall review of spending in this category showed that approximately \$40.00 was spent per male athlete and \$35.00 spent per female athlete. In the gymnasium, there were displayed three (3) girls team jerseys and two (2) boy's team jerseys. These were selected prior to current administration so criteria for selection and/or recognition was unknown. (see recommendation 7.b.)
Support Services	X	An overall review of expenditures for a two-year cycle shows that Oldham County High School falls slightly outside the acceptable parameters both on a percentage and per athlete basis. Interviews with administration indicate that there is one athletic booster club and that all fundraising projects and the monitoring of booster club expenditures are the responsibility of the athletic director. It appears that shared office space is provided for girl's soccer/softball, and girl's basketball/volleyball. Exclusive office space is currently assigned to football, boy's basketball, and baseball. (see recommendation 7.c.)

- b. Upon receipt of this report, the Gender Equity Committee shall establish guidelines for the recognition and display of team jerseys.
- c. Upon receipt of this report, the Gender Equity Committee, may review the current assignment of office space in order to ensure overall equivalence and access for coaches of male and female teams.
