5. Brief Summary/Analysis of The Corrective Action Plan (T-60)

School intends to provide medical and training benefits to the girls in the same manner as provided to the boy's programs. There will also be an effort to provide equitable travel and per diem benefits to both genders.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

1. Weight room limited to male students only.

- 2. It appears that boy's teams are provided practice uniforms and girl's teams are not.
- 3. Travel and Per Diem allowances are not equitable.

1. School appears to realize that sport's programs would be enhanced with the ownership of their own softball and baseball facilities.

9. KHSAA To Follow-Up Regarding Corrective Action If Necessary On The Following:

Note #1 Boy's sports are provided practice uniforms while girl's sports do not appear to be provided any practice uniforms. School shall provide documentation in it's 2000-2001 Title IX Audit Report (to be submitted no later than April 15, 2001) as to what action has been taken to eliminate this inequity.

Note #2 Boy's Basketball information has not been submitted for benefits areas relating to Coaching, Medical and Training Facilities and Services, Publicity and Support Services. School shall submit to the KHSAA, no later than **December 15, 2000**, these Benefits analysis in these areas.

Note #3 It appears that the boy's basketball team members are provided shoes, bags, etc., while the girl's team is provided only balls. This inequity must be addressed and corrective action spelled out in the schools 2000-2001 Title IX Report.

Note #4. Corrective action shall be shown in the school's 2000-2001 Title IX Report (to be submitted no later than **April 15, 2001**) as to what action has been taken to ensure that both boy's and girl's teams are treated equitably in the area of travel and per diem benefits to athletes.

(Selection of Cheerleaders) On or before December 15, 2000, the school is requested to provide information to the KHSAA concerning the manner in which cheerleaders are selected for boys' and girls' teams. If cheerleaders are selected in such a way as to result in arguably better (i.e. "A" team vs. "B" team) cheerleaders performing at boys' events, the school shall also submit a plan under which cheerleaders of equal ability shall perform at an equal number of boys' and girls' games in comparable sport (i.e., boys' varsity and girls' varsity basketball game).

(Prime Time Contest/Girls' Basketball) On or before December 15, 2000, the school is requested to provide information to the KHSAA concerning the number of "prime time" games scheduled (games to be played on Friday and/or Saturday nights) for its girls' varsity basketball team during the 2000/2001 season. The school should also provide similar information for the 1999/2000 season. To the extent that a fewer percentage of girls' games are played during prime times (when compared with the percentage of boys' games scheduled for prime times), the school shall advise the KHSAA of action it intends to take to immediately correct the difference.

(Practice Uniforms) School must provide in the 2000-2001 Title IX Audit (to be submitted by April 15, 2001) as to the actions and decisions that have been made to ensure that female athletes will be provided the same opportunities for practice uniforms in all sports to be comparable to those offered in boy's sports.
