ACCOMMODATIONS OF INTEREST AND ABILITIES: The January 29, 2008 and the December 12, 2013 Title IX school visit reports rated the accommodations of interest and abilities Satisfactory based on evidence indicating that the standard established by Test 3 for the provision of athletic opportunities was being met at the time of both visits. A review of the annual reports for the past two years indicate that the school is not currently meeting the standard established by any of the three opportunities tests. In regard to Test 1, the 2018-19 annual Title IX report shows that females-the underrepresented gender-were 36.3% of the participants while they were 50% of the school's enrollment. In relation to Test 2, the addition of a varsity dance team increased the percentage of total participation for females by nine percent. In regard to Test 3, the most recent student athletic interest survey (2017-18) shows an indicated interest in soccer (43), swimming (19), and bass fishing (23). The T-3 form in the 2017-18 states that meetings will be held to assess the interest in bass fishing and soccer, but neither the T-3 form or the T-60 form in the 2018-19 annual Title IX report indicate any follow-up has taken place. Since it cannot be verified that these interests have been addressed for validity, this area is designated **deficient**. School officials were reminded that failure to present evidence of the provision of equitable opportunities is the most significant deficiency within the Title IX evaluation. (See KHSAA Recommended Action.) The T-63 form in the 2017-18 annual Title IX report shows that a 90.3% completion rate was received on the most recent student athletic interest survey. IT IS TO BE NOTED THAT THE SCHOOL FAILED TO PROVIDE ANY EVIDENCE OF AN ACTIVE GENDER EQUITY REVIEW COMMITTEE. NO MINUTES FOR ANY MEETINGS HELD DURING THE PAST THREE YEARS WERE MADE AVAILABLE AT THE TIME OF THE MOST RECENT VISIT. INFORMATION FROM SCHOOL ADMINISTRATORS INDICATED THAT NO GERC MEETINGS HAVE BEEN HELD FOR "AT LEAST" THREE TO FOUR YEARS. (See KHSAA Recommended Action.) During the 2/11/20 visit, the school's Title IX file was reviewed. It contained copies of annual Title IX reports for the past three years, a board-approved extra service pay schedule for coaches, a listing of individuals identified as members of a Gender Equity Review Committee, usage schedules for one of the three weight training rooms, and a listing of when the girls basketball team used the gym (see Scheduling of Games and Practice Times and KHSAA Recommended Action), guidelines addressing the posting of athletic banners and induction into the school's athletic hall of fame (see Publicity and KHSAA Recommended Action), written designation of the locker room and athletic equipment storage space assigned several of the school's teams, (see Locker Rooms, Practice and Competitive Facilities and KHSAA Recommended Action), a chart showing partial cycles for team uniform replacement (see Equipment and Supplies and KHSAA Recommended Action), and some written guidelines addressing the mode of transportation and provision of meals for student athletes (see Travel and Per Diem Allowances and KHSAA Recommended Action). SCHOOL OFFICIALS WERE STRONGLY ENCOURAGED TO ESTABLISH A GENDER EQUITY REVIEW COMMITTEE AND BEGIN PROCESS OF DEVELOPMENT OF GUIDELINES ADDRESSING PROVISION OF THE EQUITABLE OPPORTUNITIES AND BENEFITS FOR STUDENT ATHLETES.

BENEFITS REVIEW- EQUIPMENT AND SUPPLIES: The 2008 and 2013 Title IX school visit reports designated this benefit category *Satisfactory*. The most recent visit revealed that the school had a uniform review, rotation, and/or replacement plan that contains either inaccurate or incomplete cycles of replacement for teams. (See *KHSAA Recommended Action*.) The uniforms and equipment examined during this visit showed two significant disparities. (1) One boys team—football—is supplied shoes as part of the uniform. No girls team is provided this amenity. (2) The uniforms displayed by the school's Title IX coordinator revealed a disparity in the quantity of softball uniforms when compared to baseball. According to the Title IX coordinator, softball is supplied one game top only per player, and baseball is given three full uniforms per player. It should be noted that an interview with a softball player indicated that the softball uniform seen during this visit was not all that was provided for team members. (See *KHSAA Recommended Action*.) The failure of the school to show equivalence in the uniforms provided, and the failure to offer evidence that an equitable plan of replacement is being followed renders this benefit category to be **deficient**. (See *KHSAA Recommended Action*.) The failure of the school to show equivalence in the uniforms provided, and the failure to offer evidence that an equitable plan of replacement is being followed renders this benefit category to be **deficient**. The 2017-18 and 2018-19 annual Title IX reports show that the school was spending approximately \$168 per female athlete and \$219 per male athlete for equipment and supplies.

BENEFITS REVIEW- SCHEDULING OF GAMES AND PRACTICE TIMES: The 2008 and 2013 Title IX school visit reports designated this benefit category *Satisfactory*. A major component of this benefit category is the equitable scheduling of competitive events for teams of "like" sports. This area could not be evaluated due to the failure of the school to provide recent game schedules for all varsity teams as requested for this visit. The school Title IX coordinator was given the opportunity to present this information during this recent visit, but he did not. (See *KHSAA Recommended Action.*) According to information gathered during this visit, the practice facilities that are shared per gender at the school are two weight training rooms and the main gym. A complete usage schedule for the gym shared by both boys' and girls' basketball was not available, and an equitable usage schedule was provided for only one weight training room. The failure to produce evidence of equitable scheduling of competitive events and the sharing of practice facilities renders this benefit category to be **deficient**. (See *KHSAA Recommended Action*.) The scheduling of competitive events during the most optimal playing times on an equitable basis was discussed with school officials who were encouraged to monitor this endeavor closely.

BENEFITS REVIEW- TRAVEL AND PER DIEM: The 2008 and 2013 Title IX school visit reports designated this benefit category *Satisfactory*. According to information gathered during the most recent visit, a board-owned school bus is the only mode of transportation ever used by student athletes. Vans or charter buses are not used for students. The Title IX file had some statements related to the equitable provision of meals. UPON RECEIPT OF THIS REPORT, THE GUIDELINE ADDRESSING MEAL ALLOTMENTS SHOULD BE MADE MORE SPECIFIC. (i.e. Is \$15 allotment per day, per meal, or for entire trip?) There were no regulations available during this visit in regard to the equitable provision of lodging. (**See KHSAA Recommended Action**.) Interviews with student athletes indicated that no consistent regulations were being followed in terms of lodging. The 2017-18 and 2018-19 annual Title IX reports showed the school was spending approximately \$182 per female athlete and \$136 per male athlete for equipment and supplies.

BENEFITS REVIEW- COACHING: The 2008 and 2013 Title IX school visit reports designated this benefit category *Satisfactory.* During the most recent visit, it was learned that the principal is responsible for the evaluation of all head coaches. A written instrument is not currently used for documentation of this process. The extra service pay schedule seen during the visit appears to show equivalence. The T-35 form in the 2018-19 annual Title IX report shows that the total amounts spent for coaching salaries for teams of "like sports showed relative parity. Information gathered during this visit indicated that the coaching ratio for females is 7.6 participants per coach and for males is 9.6 participants per coach. The school's Title IX coordinator shared data showing that 14% (1/7) of the head coaches of girl's teams and 57% (4/7) of the head coaches of boy's teams are on-campus employees. According to this data, the coaching ratio appears to favor female participants, and the availability of on-campus coaches favors male participants.

BENEFITS REVIEW- LOCKER ROOMS, PRACTICE AND COMPETITIVE FACILITIES: The 2008 Title IX school visit report designated this benefit category *Deficient* because of long existing disparities in the amenities at the softball field compared to those at other outdoor venues. The 2013 report designated this category *Satisfactory* stating that the disparities at the softball field had been addressed by the addition of a press box, construction of a brick wall at the base of the backstop, installation of fence netting, enclosure of the bullpens, cutting the infield, and correcting drainage issues. The tour of competitive facilities during the most recent visit revealed that the venues for "like" sports had equitable amenities. The Title IX file did not list a dressing area for boys and girls golf. UPON RECEIPT OF THIS REPORT, THE LISTING FOR DRESSING AREAS IS TO BE AMENDED TO INDICATE THAT GOLFERS HAVE THIS BENEFIT AT THE GOLF COURSE. A tour of the dressing areas showed a significant disparity in the quality of locker rooms for athletes, but these differences were gender neutral. The tour also revealed that teams had several equipment storage areas that were not listed in the file. UPON RECEIPT OF THIS REPORT, SCHOOL OFFICIALS ARE ASKED TO UPDATE THE LISTING OF EQUIPMENT STORAGE AREAS TO SHOW <u>ALL</u> STORAGE SPACES USED FOR SCHOOL TEAMS. It appears that equity is being provided within this benefit category, but documentation is needed.

BENEFITS REVIEW- MEDICAL AND TRAINING FACILITIES AND SERVICES: The 2008 Title IX school visit report designated this benefit category *Satisfactory*. The 2013 report designated this category *Deficient*. The major cause of the deficiency was the school's lack of a usage schedule for one weight training room seen during the tour of facilities, and the interviews with coaches and student athletes that revealed the existence of two additional weight training facilities to which KHSAA representatives were not given access. The tour during the most recent school visit showed that the school currently has three weight training facilities. Weight room #1 is a large, well-equipped venue located in the "old gym." It has numerous training options that are very suitable for female athletes. An equitable usage schedule for this room was in the Title IX file and posted at the facility. Weight room #2 is in the "old high school" and is used only by the football team and had equipment more suitable for male athletes. Weight room #3 is a very small venue located in the new gym. It has fewer training options than the other two facilities, but does have equipment that appears appropriate for use by females. There was no usage schedule available for this facility. (See Scheduling of Games and Practice Times and KHSAA Recommended Action.) Interviews with student athletes confirmed fairly widespread use of and equitable access to weight training rooms 1 and 3. Daily access to an athletic trainer is available on an equitable basis through a contract with Kings Daughters Sports

Medicine. Free athletic examinations are available on the first Friday in May by doctors and nurses from Kings Daughters Sports Medicine.

BENEFITS REVIEW- PUBLICITY: The 2008 and 2013 Title IX school visit reports designated this benefit category *Satisfactory.* The 2013 report stated that the regulations addressing equitable provision of awards, as well as the guidelines related to the posting of banners, needed to be expanded and updated. The school currently has one varsity cheerleading squad that cheers at all home and away football games. There was no written policy and school administrators did not know how the cheerleaders were assigned for girls and boys basketball games. (See *KHSAA Recommended Action.*) The band performs at all home football games, and the pep band plays at an equal number of boys and girls home basketball games. The number of games that the pep band gives support is monitored and approved by the principal for the provision of parity. The Title IX file had equitable guidelines were being followed. The file also contained criteria for induction into the school's athletic hall of fame. The school did not provide the requested regulations addressing equivalence for student athletes in terms of awards and post season banquets. (See *KHSAA Recommended Action.*) Interviews with student athletes seemed to confirm the provision of parity in regard to awards, but there was insufficient confirmation related to banquets. The 2017-18 and 2018-19 annual Title IX reports show that the school was spending approximately \$52 per female athlete and \$39 per male athlete for awards and recognition.

BENEFITS REVIEW- SUPPORT SERVICES: The 2008 and 2013 Title IX school visit reports designated this benefit category *Satisfactory*. The tour of facilities during the most recent visit revealed that exclusive coaching offices are provided for football, boys basketball, and girls basketball. The school currently has one booster club that supports the football team. This booster club houses all its funds outside of school accounts, and, according to administrators, there are no procedures in place for oversight or approval of booster spending in regard to the provision of equitable benefits. IT WAS EMPHASIZED TO SCHOOL OFFICIALS THAT THERE NEEDS TO BE A MECHANISM IN PLACE FOR THE OVERSIGHT OF BOOSTER SPENDING. An analysis of athletic spending for the past two years is as follows:

2017-18 - Thirty-eight (38) percent of spending was for female athletes (the underrepresented gender) who made up 36% of the participants. Sixty-three (63) percent of the spending was for male athletes who made up 64% of the participants. This means that \$816 was spent per athlete for females and \$760 per athlete for males.

2018-19 - Thirty-nine (39) percent of spending was for females who were 36% of the participants. Sixty-one (61) percent was spent for male athletes who were 64% of the participants. This means that \$993 was spent per female athlete and \$878 was spent per male athlete for total support.

If these expenditures submitted by the school are averaged over the two-year period of this analysis, they appear to show an advantage to female participants.

OTHER GENERAL OBSERVATIONS

Although not part of the current Title IX evaluation, as per request, the school was asked to provide a copy of its Athletic Facility Emergency Plan (KRS 160.445). The plan made available during this visit <u>was not</u> venue-specific as requested by the statute. **(See OTHER ACTIONS NECESSITATED BY THIS VISIT.)**

As per request, the school was asked to identify the locations of its Automated External Defibrillators. According to the school's Title IX coordinator, there are permanent AED's in the (1) commons area adjacent to the high school gym, (2) lobby of the "old high school", (3) concession stand at the football/softball complex, (4) concession stand at the baseball field, and (5) concession stand adjacent to the practice football field and tennis courts.

No one from the community attended the Public Comments session. SCHOOL ADMINISTRATORS WERE STRONGLY ENCOURAGED TO FORM A GENDER EQUITY REVIEW COMMITTEE AND DELIBERATELY MONITOR THE EQUITABLE PROVISION OF OPPORTUNITIES AND BENEFITS FOR THEIR STUDENT ATHLETES. The meeting was adjourned at 3:25pm EST.
