ACCOMMODATIONS OF INTEREST AND ABILITIES NOTES: The January 15, 2002 and the September 27, 2011 Title IX school visit reports rated this area Satisfactory. At the time of both visits, the evidence indicated that the school was meeting the standard established by Test 3 for the provision of athletic opportunities. A review of the recent Title IX annual reports shows that the school seems to meet the standard established by all three opportunities tests. In regard to Test 1, the 2016-17 report shows that females made up 49% of the athletes at the school, and they were 48.6% of the school's enrollment. Under Test 2, the addition of girls' varsity lacrosse, girls' junior varsity soccer, and girls varsity and junior varsity volleyball during the past five years has increased female participation by 39.3%. In relation to Test 3, the responses on the T-3 form appear to be fully supported by the information in the most recent student athletic interest survey. The T-63 form in the 2015-16 annual Title IX report shows that an 82.8% completion rate was received on the most recent student athletic interest survey. School officials were commended for the information indicating that equitable opportunities are being provided for all student athletes. During the most recent visit, the school's Title IX file was examined. It was found to contain both the previous Title IX school visit reports, annual Title IX reports for the past five years, a listing of salaries paid to individuals who filled coaching positions (see Coaching and KHSAA Recommended Action), a listing of the current members of the Gender Equity Review Committee, recent game schedules for all varsity teams, a schoolgenerated athletic handbook for student athletes, a written facility usage schedule for the gym (see Medical and Training Facilities and Services and KHSAA Recommended Action), written regulations addressing equitable provision of awards (see Publicity and KHSAA Recommended Action), written designation of locker room space assigned some teams (see Locker Rooms, Practice, and Competitive Facilities and KHSAA Recommended Action), written designation of the athletic equipment storage space assigned some teams (see Locker Rooms, Practice and Competitive Facilities and KHSAA Recommended Action), minutes for one Gender Equity Review Committee meeting held in 2014 (see KHSAA Recommended Action), a uniform review, rotation, and/or replacement plan (see Equipment and Supplies and KHSAA Recommended Action), and an Athletic Facility Emergency Medical Plan (KRS 160.445). School officials were strongly encouraged to work toward the development of a comprehensive Title IX file with regulations that are implemented for the benefit of student athletes.

**BENEFITS REVIEW- EQUIPMENT AND SUPPLIES:** The 2002 and 2011 Title IX school visit reports rated this benefit category *Satisfactory*. All uniforms examined during the most recent visit appeared to be of high quality and supplied on an equitable basis. The school had a uniform review, rotation, and/or replacement plan showing equitable cycles of replacement for "like" sports. UPON RECEIPT OF THIS REPORT, THIS PLAN IS TO BE UPDATED TO INCLUDE <u>ALL</u> UNIFORMS THAT ARE REPLACED ON AN ANNUAL BASIS AND TO INCLUDE BOYS AND GIRLS LACROSSE. The 2015-16 and 2016-17 annual Title IX reports show that the school was spending approximately \$89 per female athlete and \$73 per male athlete for equipment and supplies.

**BENEFITS REVIEW- SCHEDULING OF GAMES AND PRACTICE TIMES:** The two previous Title IX school visit reports rated this benefit category *Satisfactory*. Information gathered during the most recent visit indicated that the number of competitive events scheduled for teams of "like" sports was comparable. There was an equitable usage schedule for the gym, but there was no usage schedule for the weight training room. (See <u>Medical and Training Facilities and Services and KHSAA Recommended Action</u>.) The scheduling of athletic competitions during the most optimal playing times was discussed with school officials who were strongly encouraged to work toward the provision of parity in this endeavor.

**BENEFITS REVIEW- TRAVEL AND PER DIEM:** The 2002 and 2011 Title IX school visit reports rated this benefit category *Satisfactory.* The 2011 report documented that the school's Title IX file <u>did not</u> contain any equitable guidelines addressing the provision of per diem. The most recent review of the file revealed there were no written regulations addressing the mode of transportation or provision of equitable meals and lodging. Interviews with student athletes and coaches gave no indication that any equitable guidelines were being followed. Because the school failed to offer evidence of any regulations in this area in 2011 or during the most recent visit, this benefit category is currently **deficient**. (See *KHSAA Recommended Action*.) The 2015-16 and 2016-17 annual Title IX reports show that the school was spending approximately \$29 per female athlete and \$32 per male athlete for travel and per diem.

**BENEFITS REVIEW- COACHING:** The two earlier Title IX school visit reports rated this benefit category *Satisfactory.* The school's athletic director is currently assigned to evaluate all head coaches. A written instrument is used as part of this process. The school did not provide an extra service pay schedule for coaches—only a listing of payments to individuals who held coaching positions. (See <u>KHSAA Recommended Action.</u>) According to the T-35 form in the 2016-17 annual Title IX report, the total amounts spent for coaching salaries for teams of "like" sports were comparable. Data gathered during the most recent visit indicated that the coaching ratio for female athletes is 7.5 participants per coach, and the ratio is 7.4 participants per coach for male athletes. Information provided by the athletic director indicated that 38% (3/8) of the head coaches of boys teams were on-campus employees.

BENEFITS REVIEW- LOCKER ROOMS, PRACTICE AND COMPETITIVE FACILITIES: The two previous Title IX school visit reports rated all the individual components of this benefit category *Satisfactory*. The boys and girls basketball teams play and practice in the school's gym. The golf teams practice and compete at the Tates Creek Country Club located about 10 miles from the school. Bus transportation is provided to practice and home matches. The girls and boys swim teams compete and practice at Northside YMCA located a few blocks from the school. The track team practices at Transylvania University, Lexington Christian High School, and the Sayre Athletic Complex. All other teams sponsored by the school play and practice at the Sayre Athletic Complex located approximately nine miles from the school. Bus transportation is provided to the complex for practices. The complex is well-appointed and maintained. All the competitive and practice venues appear to have been constructed with equitable benefits in mind. The tour of facilities during the most recent visit revealed that the dressing rooms at the school and athletic complex were assigned equitably. During the tour, it appeared that some athletic equipment storage space was assigned for each team. It is recommended that the assignment of storage space be evaluated in relation to equitable size for "like" teams and proximity to the practice and playing venues for teams. It should also be noted that the Title IX file did not contain a complete listing of locker room or equipment storage space each team. (See KHSAA Recommended Action.)

**BENEFITS REVIEW- MEDICAL AND TRAINING FACILITIES AND SERVICES:** The 2002 and 2011 Title IX school visit reports rated this benefit category *Satisfactory*. The most recent visit revealed that the school has a weight training facility consisting of two rooms. One of these rooms contains cardiovascular equipment, and the other one has mostly weight training equipment. Both these rooms contain numerous training options that are very suitable for use by female athletes. Interviews with students and coaches confirmed that some female teams use this facility. However, unlike the past Title IX visit, the school did not have a usage schedule for this venue, and the school-based interviews gave no indication that equitable access for females was emphasized. (See <u>KHSAA Recommended Action</u>.) A certified trainer available through a contract with the University of Kentucky is provided on an equitable basis to all student athletes. Physical examinations are the responsibility of the student athletes at Sayre.

**BENEFITS REVIEW- PUBLICITY:** The two previous Title IX school visit reports rated this benefit category *Satisfactory.* The school currently sponsors one varsity cheerleading squad that is assigned to cheer at all home boys and girls basketball games and at away games versus teams within the city of Lexington. The Title IX file contained excellent guidelines for provision of parity in regard to athletic awards. There were no regulations related to post season banquets, posting of athletic banners, or criteria for entrance into the school's athletic hall of fame. (See *KHSAA Recommended Action.*) Equity of spending within this benefit category could not be evaluated because the school's T-35 form submitted to KHSAA contained <u>budgeted amounts rather than actual expenditures</u> in the *Awards* column. (See *KHSAA Recommended Action.*) The fact that the majority of the written regulations necessary for this benefit area were not provided and spending could not be evaluated due to inaccurate submittals of expenditures, this category is deemed **deficient**.

BENEFITS REVIEW- SUPPORT SERVICES: The 2002 and 2011 Title IX school visit reports rated this benefit category *Satisfactory* and stated at the time of those visits that no athletic booster clubs existed. The tour of facilities during the most recent visit revealed that the school provided only one coaching office which was located at the athletic complex. This office is shared by all coaches whose teams practice at this facility. The school currently has one booster club which supports all athletic teams at the school. The booster club houses all its funds off the school campus. According to school administrators, all booster purchases are approved by the athletic director. The internal audit report for 2015-16 shows that the school was spending approximately \$483 per female athlete and \$639 per male athlete for total support—a \$156 difference in favor of male athletes. In 2016-17, the internal audit report showed that \$564.31 was spent per female athlete and \$610.94 per male athlete—a difference of \$46.62 in favor of males. Although this spending shows more parity than the previous year, it is still slightly outside of generally accepted parameters for the provision of parity for a non-football playing school. While it appears that significant progress has been made in this category in 2016-17, athletic expenditures should continue to be closely monitored in relation to equitable benefits for student athletes.
