5. Brief Summary/Analysis of the Corrective Action Plan (Form T-60)

The school has made some improvements in the locker room for girls; however, lack of resources has some projects pending. It was not clear whether actual plans for some locker room improvements had been submitted to the School Board. The School Board did renovate the swimming pool.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

The greatest deficiency in the overall girls and boys athletic program at Shawnee High School is the lack of participation by girls and boys. The school's inability to maintain and expand programs is their greatest hurdle to overcome. By seeking community and alumni support, good coaching, and the school's efforts to attract and maintain a viable program is essential. With the School Board's support in the continuous upgrading of the girls' locker facilities, could also help the school have attractive and efficient facilities for Shawnee athletics.

7. KHSAA Recommended Action in relation to new deficiencies: The auditor did not observe any new deficiencies.

8. KHSAA Recommended Action in relation to re-occurring deficiencies:

- 1. The original deficiencies on the 1999-2000 report were travel, locker rooms and weight rooms. The school has addressed the travel and weight room issues; however, some facility improvements are needed in the weight room regarding machines compatible for females when resources become available. The locker room has improved; however, further improvements are pending on School Board assistance and approval to complete some projects. The auditor will continue to monitor this matter.
- 2. Submit to the KHSAA by **February 1, 2005**, a written uniform replacement rotation policy for male and female athletic teams. This policy is to be kept in the school's permanent Title IX file.
- 3. Submit to the KHSAA by **February 1, 2005**, a written policy regarding the recognition of accomplishments of student-athletes and teams as it relates to banners, awards, etc. This policy is to be kept in the school's permanent Title IX file.
