Travel and Per Diem Allowances		X	Impossible to determine given that many forms are not signed and/or labeled as to what sport they refer to. It appears that boy's football is given per diem meal money along with boy's golf. It does not appear that any girls sports' are provided meal money.
Coaching	X		Excluding football, the girls coaches have extensive experience in coaching. However, the school should look at some comparable sports that afford boys more coaches than girls. More coaches allows for more individual coaching and training opportunities. The school provided a percentage breakdown as to what coaches are paid to coach. In future reports, when salaries are requested, figures shown should be dollar amounts.

There is a Fieldhouse that appears to be used by boys' sports. A case in point is that the boys baseball team is listed as using it while the girls softball team does not. The baseball and softball teams both play at the same community park several miles away.

# 5. Brief Summary/Analysis of The Corrective Action Plan (T-60)

It appears that school personnel are beginning to address items that need to be changed. School personnel intends to add an additional coach in Volleyball to allow for the addition of a Freshman Team. The school is looking into the possibility of constructing (possibly by 2002-2003 school year) a sports complex on campus for soccer, baseball and softball teams. School personnel has stated they will work to provide equal publicity for all comparable sports, as well as work toward equalizing fund-raising opportunities for both boys' & girls' sports programs.

## 6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

The most obvious overall inequity is the amount of money spent on boy's teams versus girl's

teams. Not including football expenditures (\$21,930), boys' sports expended \$88,795 while girls' sports expended \$53, 855. The variance in expenses is significant given that comparable boys' and girls' teams were budgeted the same amounts for the year. If football were included, then boys' sports would have had almost twice as much spent on them as girls' sports. Obviously, Booster Club monies are included in these amounts (which they are supposed to be), but these expenditure amounts cause a genuine concern over the equity in benefits afforded the female students. The school should show no later than April 15, 2001 that it has worked with school Booster Clubs to gain control over these funding issues and eliminate this apparent inequity.

### 7. Facility Recommendations or Concerns

Given that a Fieldhouse apparently exists for boys' teams, there should be an aggressive and meaningful effort to develop an on-campus sports complex that can be used by female (as well as male) student athletes rather than to travel 8-10 miles to off-site fields.

School shall submit the following additional information:

**<u>NOTE</u>**: School shall submit, no later than **April 15**, 2001 it's plan for bringing expenditures more into line with Title IX guidelines.

**<u>NOTE</u>**: While it is not being required at this time, future efforts by the school to audit the school's Title IX compliance should ensure that forms are filled out properly and signed by appropriate personnel/coaches.

(Selection of Cheerleaders) On or before March 1, 2001, the school is requested to provide information to the KHSAA concerning the manner in which cheerleaders are

selected for boys' and girls' teams. If cheerleaders are selected in such a way as to result in arguably better (i.e. "A" team vs. "B" team) cheerleaders performing at boys' events, the school shall also submit a plan under which cheerleaders of equal ability shall perform at an equal number of boys' and girls' games in comparable sport (i.e., boys' varsity and girls' varsity basketball game).

(Prime Time Contest/Girls' Basketball) On or before March 1, 2001 the school is requested to provide information to the KHSAA concerning the number of "prime time" games scheduled (games to be played on Friday and/or Saturday nights) for its girls' varsity basketball team during the 2000/2001 season. To the extent that a fewer percentage of girls' games are played during prime times (when compared with the percentage of boys' games scheduled for prime times), the school shall advise the KHSAA of action it intends to take to immediately correct the difference.
