The school has not included all student participants on T-1 (compare T-4 numbers) and has not performed the calculation correctly. Using the numbers from T-4, female participation equals 41% while male participation equals 59%.

9. KHSAA To Follow-Up Regarding Corrective Action If Necessary On The Following:

(Selection of Cheerleaders) On or before January 2, 2001, the school shall provide information to the KHSAA concerning the manner in which cheerleaders are selected for boys' and girls' teams. If cheerleaders are selected in such a way as to result in an arguably better (i.e., "A" team vs. "B" team) cheerleaders performing at boys' events, the school shall also submit a plan under which cheerleaders of equal ability shall perform at an equal number of boys' and girls' games in comparable sports (i.e., boys' varsity and girls' varsity basketball games).

(Prime Time Contest/Girls' Basketball) On or before January 2, 2001, the school is requested to provide information to the KHSAA concerning the number of "prime time" games scheduled (games to be played on Friday and /or Saturday nights) for its girls' varsity basketball team during the 2000/2001 season. The school should also provide similar information for the 1999/2000 season. To the extent that a fewer percentage of girls' games are played during prime times (when compared with the percentage of boys' games scheduled for prime times), the school shall advise the KHSAA of action it intends to take to immediately correct the difference.

(Insufficient Information) The school has not accurately summarized the information sought on Form T-6 which calls for the total number of game and practice uniforms and sport specific equipment within each category. The school is requested to supply this information on or before January 2, 2001.

(**Opportunities**) The school has not demonstrated compliance under the three-prong test. Based on information submitted, it appears that there is sufficient interest to form volleyball team(s). Accordingly, on or before **January 2, 2001**, the school shall either: (1) submit an amended Corrective Action Plan setting forth a plan for adding volleyball team(s) beginning with the 2001/2002 school year or (2) provide information demonstrating why such teams can not or should not be added.

(Weeks of Practice Before Contests) Information submitted by the school indicates that its girls' softball and soccer teams begin practice later than comparable boys' teams. On or before January 2, 2001, the school shall explain the reason for this difference.

(Weight Room) On or before January 2, 2001, the school should submit a schedule reflecting that its present weight training facilities are available for use by all teams desiring to use them. Alternatively, if the school has completed construction of its new facilities, it should advise the KHSAA of that fact.

(Missing Information) Several team forms lack information, signatures and/or dates. This information should be supplemented on or before January 2, 2001.
