Comments:

The area of History and Continuing Practice of Program Expansion also appears to be an area that meets the standard for compliance. The percentage of current female participants added in the past five years for the school years of 2003/2004, 2004/2005 and 2005/2006 is 25% or greater for each reported year. Twenty-five percent or greater is the standard of compliance for this area of Opportunities compliance.

Comments:

Based on the responses to the most recent Student Interest Survey for interschool athletics, South Laurel High School provides for Full and Effective Accommodation of Interest and Abilities. For the 2006/2007 school year, a total of 14 teams are offered for a female population of approximately 640 students. Teams are fielded for soccer, cross country, basketball, volleyball, tennis, softball, tennis and track & field.

Comments:

The student Interest Survey was administered during the 2005/2006 school year to students in grades 8, 9, 10 and 11 during their "Academic Plus Teachers" period. The return rate for the survey exceeded 90%.

Accommodation of Interests and Abilities	X		As noted previously, the Accommodation of Interests and Abilities at South Laurel High School is rated as satisfactory. A freshman volleyball team was added this past Fall to bring the total number of teams to $14 - 8$ varsity, 4 junior varsity and 2 freshman.
Equipment and Supplies	X		The purchase of uniforms for the various sports is funded through the school board and the quality is superior for both genders. A written rotation plan for the purchase of uniforms is in effect and a copy included in the Title IX documents. The sport specific equipment for the teams seems to be comparable; per athlete equipment expenditures for males (\$167) as compared to females (\$104) is reasonable given that South Laurel's football program includes approximately 65 participants.
Scheduling of Games and Practice Time	X		Practice and game schedules are written and posted. The gymnasium rotation schedule for the basketball teams is equitable. The male and female soccer teams share the field for practices. South Laurel is compliant for prime dates for girls' basketball. Last season 5 of the 8 (63% home games were scheduled on a prime date for this year, four of the nine home games (44%) are slated for prime date.
Travel and Per Diem Allowances	X		Both the softball and baseball teams take out- of-state trips. Meals are not provided for student athletes. The Gender Equity Review Committee is requested to develop writter procedures for travel and per diem allowances and submit it to KHSAA offices by April 15 2007.

Coaching	X	Pay is comparable for coaches of male team and coaches for female teams; a copy of the coaching stipends is included in the Title I file. It is noted that Laurel County Puble School System provides for a generous number of assistant coaches for several teams. appears that the coaching staff is stable and experienced. There is a greater number of head coaches employed on campus for male team than head coaches employed on campus for female teams. There are two weight rooms – the one designated for ma athletes is adjacent to the football locker room and the one assigned for female athletes adjacent to the gymnasium. Written schedule for both weight rooms are posted.

Publicity	X	The cheerleaders, pep band and dance team support male teams and female teams on an equitable basis. Two media guides are printed; one for fall sports and one for winter sports. A written policy with specific criteria for retiring a jersey is included in the Title IX documents. Also displayed in the gymnasium are banners for regional wins and pictures of state championship teams. The Gender Equity Review Committee is to write a policy for the display of honors for regional and state wins and submit it to KHSAA by April 15, 2007.
Support Services	X	Expenditures for male teams and expenditures for female teams appear to be comparable. The school board contributes \$10,000 for non- revenue sports teams. Numerous booster groups provide assistance for the athletic program. Signed booster agreements are on file for soccer and football. School personnel are directed to obtain a signed agreement from the group supporting the girls' basketball team. Administrative procedures are in place to monitor fund raising and expenditures by booster organizations so that an imbalance in funding will not occur. In past years the totals listed on the bottom of Form T-36 (Actual Expenditures – Program Comparison Charts 2) included with the KHSAA Annual Verification of Title IX Procedures were incorrect. Any inaccuracies in the listed totals included for past years are to be corrected and copies of the forms submitted to KHSAA so that the files can be updated.

10. Comments

The Gender Equity Review Committee is to be commended for their efforts to insure that the athletic program at South Laurel High School is comparable in opportunities and benefits for both male and female teams. It is clear, based on observations and comments made during the Title IX Revisit, that the Committee, school district and community have been actively engaged in developing an exceptional sports program for their student athletes. Also, the leadership of the South Laurel's athletic director is apparent and been a positive force in the progress that has occurred over the years.

The Title IX permanent file was comprehensive and very well organized in a notebook format. Minutes for Gender Equity Review Committee meetings were available. It was suggested that perhaps the work of the Committee would be enhanced with the addition of another student representative. Also, as noted previously, the development of policies relative to the display of honors in the gymnasium and travel/per diem are to be submitted to KHSAA offices.

During the interview phase of the Title IX Revisit, both students and coaches stated that they felt the athletic program was well supported by school personnel and the community. The following improvements that were made in the past several years were mentioned during the conversations: increased opportunities for female participants, the addition of a second weight room, increased publicity for girls' sports and the construction at the softball and baseball facilities. The only concern put forth related to the assignment of officials; more specifically, whether the quality of the officiating was comparable for both male and female basketball games. Overall, the interviewees expressed considerable satisfaction and pride in South Laurel's athletic program.

Gender Equity Meeting January 31, 2007

Meeting was called to order by G.J. Smith. Members present were G.J. Smith, Tish Walker, Konnie Snyder, Elizabeth Johnson, Albert Binder and Regina Bishop.

Motion to approve minutes from last meeting was made by Mrs. Bishop and seconded by Mrs. Snyder.

A confidential vote took place to retire a banner for former coach Raymond Reed. The voting was unanimous to retire the banner. It will be retired during the boy/girl double header versus Rockcastle County. The girls game will be played first.

The gender equity visit will be February 8.

Student representative, Tish Walker, had heard a concern about some trash in the batting cages. Mr. Smith said that this had been addressed.

South Laurel High School athletics does not provide money for over night regular season trips. For KHSAA post season trips we will provide \$7.00 per meal and allow \$125.00 per motel room. Exception: If there is not a motel room available at this price, we will exceed this figure.
