ACCOMMODATIONS OF INTEREST AND ABILITIES NOTES: The November 19, 2003 Title IX school visit report rated this area Satisfactory based on evidence indicating the standard established by Test 1 was being met. The October 19, 2011 school visit report rated this area Deficient citing the school's failure to meet the standards established by any of the three opportunities tests. The report emphasized that the school had not addressed an interest in volleyball that had been indicated on the past two student athletic interest surveys. This deficiency has been corrected by the establishment of a volleyball program at the school. A review of annual reports for the past two years suggests that the school is meeting the standards for both Tests 1 and 3 for the provision of athletic opportunities. In relation to Test 1, the percentage of participation for female athletes is well within 5% of their percentage of enrollment. In regards to Test 3, the internal audit summary for 2016-17 documents the responses on the T-3 form that appear to be supported by data on the most recent student athletic interest survey. The T-63 form in the 2015-16 annual Title IX report shows that a 100% return rate was received on the student athletic interest survey for that year. During the most recent visit, the school's Title IX file was reviewed. It was found to contain the two previous Title IX school visit reports, annual Title IX reports for the past five years, a schoolapproved extra service pay schedule for coaches, a listing of the current members of the Gender Equity Review Committee, current game schedules for all varsity teams, a school-generated athletic handbook for coaches and participants, quidelines addressing equity in regards to letter and bars and athletic awards (see Publicity and KHSAA Recommended Action), written designation of locker room and athletic equipment storage space assigned to each team, minutes from all Gender Equity Review Committee meetings for the past three years, a uniform replacement plan showing only past purchases (see Equipment and Supplies and KHSAA Recommended Action), regulations addressing the equitable provision of mode of transportation and meals (see Travel and Per Diem Allowances and KHSAA Recommended Action), and a copy of the school's Athletic Facility Emergency Medical Plan (160.445). School officials were encouraged to continue to develop a comprehensive Title IX file.

BENEFITS REVIEW- EQUIPMENT AND SUPPLIES: Both the 2003 and 2011 Title IX school visit reports rated this benefit category *Satisfactory*. The 2011 report recommended that the uniform review/rotation plan be expanded. During the most recent visit, uniforms for all varsity teams were reviewed and appeared to be of mid-to-high quality and supplied in equitable quantities. The file contained a uniform plan which only documented past purchases. It was emphasized to school officials that the <u>review/replacement plan should show projected future purchases</u>. (See *KHSAA Recommended Action*.) Interviews with student athletes and coaches gave significant indication that uniforms were provided in an equitable manner. According to information in the 2015-16 and 2016-17 annual Title IX reports show that the school was spending approximately \$84 per female athlete and \$141 per male athlete for equipment and supplies. This spending seems to favor male athletes. This advantage appears to be explained in the 2016-17 annual report on the T-60 form. The disparity is the result of uniform purchases for 2016-17 which are designated on the uniform review/rotation plan.

BENEFITS REVIEW- SCHEDULING OF GAMES AND PRACTICE TIMES: Both the previous Title IX school visit reports rated this benefit category *Satisfactory*. Information gathered during the most recent visit indicated that the number of competitive events scheduled for teams of "like" sports was comparable except for softball and baseball. This disparity was explained by the athletic director and the softball coach. The number of softball players who participated during 2016-17 limited the number of games that could be played. The school did not provide usage schedules for the gym or soccer fields (see *KHSAA Recommended Action*) or the weight training room (see *Medical and Training Facilities and KHSAA Recommended Action*). Interviews with coaches and student athletes indicated that equitable access was provided to all three of these venues. The scheduling of competitive events during optimal playing times for both genders was discussed with school officials who were commended for the provision of parity in this area.

BENEFITS REVIEW- TRAVEL AND PER DIEM: The 2003 and 2011 Title IX school visit reports both rated this benefit category *Satisfactory*. The 2011 report requested that the school develop and implement a comprehensive policy regarding the equitable provision of travel and per diem. The most recent visit revealed that the school has specific regulations addressing mode of transportation and meals for student athletes. These guidelines should be expanded to include equitable provision of lodging. (See *KHSAA Recommended Action.*) According to information in the 2015-16 and 2016-17 annual Title IX reports, approximately \$12 was spent per female athlete and \$21 per male athlete for travel and per diem.

BENEFITS REVIEW- COACHING: The two previous Title IX school visit reports rated this benefit category *Satisfactory.* The school's principal and athletic director are responsible for the evaluation of all head coaches. A written instrument is not currently being used as part of this process. A review of the school's extra service pay schedule for coaches showed parity. According to data on the T-35 form in the 2016-17 annual Title IX report, the total amounts spent for coaching salaries for teams of "like" sports appear to be equitable. The athletic director provided data during the school visit showing that the coaching ratio for females and males is the same--one coach per seven participants. Additional information indicated that 12.5% (1/8) of the head coaches of girls teams and 28.5% (2/7) of the head coaches of boys teams are on-campus employees.

BENEFITS REVIEW- LOCKER ROOMS, PRACTICE AND COMPETITIVE FACILITIES: The 2003 and 2011 Title IX school visit reports rated this benefit category *Satisfactory*. The 2011 report documented that the softball facility was significantly inferior to the baseball facility. The tour of facilities during the most recent visit revealed that an oncampus softball field has been constructed that provides amenities very comparable to those at the baseball field. The other practice and playing facilities reviewed during the most recent visit seemed to have similar amenities. The school has four dressing rooms which are shared by all school teams except boys and girls golf. These dressing rooms offer equitable amenities, and the assignment of these facilities also seems equitable. All teams have equipment storage spaces that appear to be appropriate in size and proximity to the teams' practice and/or playing facilities.

BENEFITS REVIEW- MEDICAL AND TRAINING FACILITIES AND SERVICES: Previous Title IX school visit reports rated this benefit category *Satisfactory*. The 2011 report stated that the weight training room contained very limited equipment suitable for use by female athletes and that there needed to be a posted usage schedule at the facility. The school currently has a weight training room located adjacent to the gym. Significant progress has been made since the 2011 visit in providing equipment that is suitable for female athletes. This venue is now very well equipped with numerous training options for females. Notably, there is still no usage schedule for this facility in the Title IX file or posted at the venue. Again, it was emphasized to school officials that it is imperative that there be evidence that equitable access is provided. (See *KHSAA Recommended Action*.) The services of an athletic trainer are not available at this time. On one designated day each year, local physicians offer free physical examinations for all student athletes.

BENEFITS REVIEW- PUBLICITY: The Title IX school visit reports from 2003 and 2011 rated this benefit category *Satisfactory*. The school currently sponsors one varsity cheerleading squad that is assigned to cheer at all home girls and boys basketball games and at away games versus district opponents for both teams. The pep band plays at all home boy/girl doubleheader basketball games. The Title IX file contained excellent regulations addressing the provision of letters, bars, and athletic awards. These guidelines did not address the posting of athletic banners or post season banquets. (See *KHSAA Recommended Action.*) Information in the 2015-16 and 2016-17 annual Title IX reports shows that approximately \$4.90 was spent per female athlete and \$5.25 was spent per male athlete for awards.

BENEFITS REVIEW- SUPPORT SERVICES: Both the earlier Title IX school visit reports rated this benefit category *Satisfactory.* The school currently has one coaching office that is shared by three teams—boys basketball, girls basketball, and volleyball. Every school sport has the support of its own booster club. All the booster clubs house their funds in school accounts. The purchase order process is strictly adhered to in relation to athletic expenditures. The internal analysis summary for the 2015-16 annual report shows that total athletic spending for that year favors male participants on both a percentage and per athlete basis. St. Mary is a non-football playing school. During 2015-16, the school spent approximately \$99 per athlete more on males than females. In 2016-17, the annual Title IX report shows that 50% of the athletic expenditures were for females who made up 50% of the participants, and the same percentage were spent for male athletes. This means approximately \$485 was spent per female athlete and \$480 was spent per male athlete for total support. The spending is well within generally accepted parameters for the provision of parity.
