5. Brief Summary/Analysis of the Corrective Action Plan (Form T-60)

The Corrective Action Plans submitted as a follow-up for the original on-site visit were a better source for analysis than those submitted for the re-visit. However, a clear pattern of progress towards providing programs of interest to both boys and girls could be seen. Expanded sports offerings and the updating and improvement of those already in existence were evident as well.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

The primary concern was the failure of the school to meet standards for compliance in the Accommodation of Interests and Abilities area. Due to staff turnover in recent years, a confirmed permanent Title IX file was not yet in place. The completion of that project should provide better internal communication. In terms of administrative oversight, there was no school policy for approval of all purchases by the principal in order to monitor equitable treatment of boys' and girls' sports.

10. Comments

The school's athletic facilities have been vastly improved in a short length of time. School personnel have been diligent in improving the athletics program in spite of staff turnover and shortage of funds. Staff and student-athlete interviews revealed a positive perception of the program and the school.

Greater attention to internal communication and to continued improvement of salary stipends was recommended in staff interviews. Better quality of volleyballs and more track equipment were suggestions that came from athletes. Additionally, more promotion of attendance at home competitions of new and spring sports was a program improvement listed by athletes.

The public meeting did not materialize.

Softball- a varsity player shall earn an athletic award when they have participated in eight (8) more innings than the total games played. She must complete the season.

Track- a player shall earn an athletic award when they score four (4) more points than the total number of meets. They must also complete the season.

Volleyball- a varsity player shall earn an athletic award when they have participated in eight (8) more sets than the total games played. She must complete the season.

Golf- a varsity player shall earn an athletic award when they have participated in 75% of the matches scheduled.

Soccer- a varsity player shall earn an athletic award when they have participated in four (4) more halves than the total games played. He/She must complete the season.
