The calculation should have shown that girls represent filling 36% of the athletic participation opportunities and boys represent 64%. In addition, there is some question as to whether boys' and girls' were double and triple counted in their participation since Form T-4 totals indicate there are 80 girls and 200 boys' participation slots being filled.

Comment:
It does appear that some students have been surveyed. However, the survey only indicates a response from 178 students while the student body consists of approximately 488 students. Some explanation of this method of surveying should be included when the 2000-2001-student survey is conducted. There appears to be enough interest in girls' volleyball to provide all levels. In addition, it appears there is sufficient interest in a girls' soccer program. The Corrective Action Plan indicates intentions to sponsor these two sports in the 2000-2001 school year.

School shall submit the following additional information:

(Selection of Cheerleaders) On or before **April 15, 2001**, the school is requested to provide information to the KHSAA concerning the manner in which cheerleaders are selected for boys' and girls' teams. If cheerleaders are selected in such a way as to result in arguably better (i.e. "A" team vs. "B" team) cheerleaders performing at boys' events, the school shall also submit a plan under which cheerleaders of equal ability shall perform at an equal number of boys' and girls' games in comparable sport (i.e., boys' varsity and girls' varsity basketball game).

(Prime Time Contest/Girls' Basketball) On or before **April 15, 2001**, the school is requested to provide information to the KHSAA concerning the number of "prime time" games scheduled (games to be played on Friday and/or Saturday nights) for its girls' varsity basketball team during the 2000/2001 season. To the extent that a fewer percentage of girls' games are played during prime times (when compared with the percentage of boys' games scheduled for prime times), the school shall advise the KHSAA of action it intends to take to immediately correct the difference.

Note One (1)

Forms T-35 & T-36 should show 1999-2000 budgeted and expenditures amounts in order for an accurate determination to be made regarding the level of support afforded athletic programs. Revised T-35 & T-36, reflecting 1999-2000 budgeted & expended figures shall be provided to KHSAA no later than February 15, 2001. Otherwise, 2000-2001 figures must be provided to KHSAA with 2000-2001 Title IX report, which is due no later than April 15, 2001.
