| Scheduling of Games and Practice Time | X | At the time of the October 17, 2001 visit, the school appeared to be successfully addressing the issue of provision of prime time play for girls basketball. A review of the school's 20052006 basketball schedules indicated that the girls played $38 \%$ of their home games on prime dates. The school was given credit for meeting the KIISAA prime time requirement because the boys played only $27 \%$ of their games during prime time. The school's 2006-2007 girls basketball schedule as posted on the KHSAA web site indicates that the girls will be playing $46 \%(5 / 11)$ of its games on prime dates. Three of the four prime date games are scheduled to be played during the prime time slot. |

| Travel and Per Diem Allowances | X | During the school visit, officials indicated that per diem benefits provided were equitable. This area was very difficult for KHSAA officials to evaluate due to the school's failure to list complete travel and per diem expenditures on the re-visit form on the April 15, 2006 submittal to KHSAA. (See Support Services and KHSAA Recommended Action.) |
| Coaching | X | The school was rendered deficient in the area by the October 17, 2001 report due to the salary gap that existed between the head softball and baseball coaches, and the failure of the school to include the extended days paid to coaches on its submittals to KHSAA. A thorough review of the school's current extra service pay schedule show that these inequities have been alleviated. The softball and baseball coaches now receive equal supplements and no coach is supplemented for extended days. According to the school's most recent submittals to KHSAA. $40 \%(2 / 5)$ of the girls team coaches are off campus employees while $25 \%$ (1/4) of the boys team coaches are off campus employees. The school did not list the total of all coaching salaries on the T-35 and T-36 forms submitted to KHSAA. (See Support Services and KHSAA Recommended Action.) |

visit showed that all shared athletic facilities <br>
appeared to be shared equitably. Although the <br>
school has two locker rooms, there did appear <br>
to be a slight advantage to the girls in this area.\end{array}\right|\)

| Support <br> Services |  | $\mathbf{X}$ | The school currently has one athletic booster <br> club which has its bank account off the school <br> campus. School officials stated that the only <br> functions of the booster club are as follows: (1) <br> provides \$25 per athlete to the school for <br> benefits; (2) sponsors three awards banquets to <br> honor all athletic teams; and (3) the purchase of <br> jackets for all athletes at the school who earn a <br> letter in any sport. There appeared to be a slight <br> advantage to the boys in the provision of <br> coaching office space. The school is rendered <br> deficient in this area because of a perceived <br> inequity in funding for athletic benefits in some <br> areas (see Equipment and Supplies) and the <br> failure of the school to report complete <br> expenditures for athletic benefits in other areas <br> (see Travel and Per Diem and Coaching). A <br> full and complete disclosure may show <br> improvement, or it may show the need for <br> closer monitoring. (See KHSAA <br> Recommended Action.) |

## 5. Brief Summary/Analysis of the Corrective Action Plan (Form T-60)

The school's most recent Corrective Action Plan calls for the installation of water, electric services, and permanent restrooms at the girls softball field.

## 6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

The major perceived deficiency indicated by the most recent visit is the provision of equitable financial support for athletic benefits. (See KHSAA Recommended Action.)

Although not a deficiency, an area of concern that should be addressed is the provision of a functioning Gender Equity Review Committee at the school. It is requested that on or before April 15, 2007, the school is to submit to KHSAA written Gender Equity Review Committee minutes for at least two committee meetings held after October 20, 2006. These minutes should be signed by the school principal, athletic director, and district Title IX coordinator.
7. KHSAA Recommended Action in relation to new deficiencies
(SUPPORT SERVICES) On or before March 1, 2007, completed T-35 and T-36 forms for the 2005-2006 school year is to be submitted to KHSAA. This document should include complete expenditures for all benefit areas requested on the form. It should also include complete and accurate totals and percentages on the T-36 form.
8. KHSAA Recommended Action in relation to reoccurring deficiencies

The school was deemed deficient in the areas of Equipment and Supplies, Coaching, and Locker Rooms, Practice and Competitive Facilities by the October 17, 2001 report. The most recent visit indicated that the school has addressed the issues requested in relation to benefits provided in these categories. (See Equipment and Supplies, Coaching, and Locker Rooms, Practice, and Competitive Facilities in the body of this report.)
