Interviews with administration indicated recent approval by the Board of Education for the addition of coaching position(s) and soccer teams for boys and girls on the middle school level. (see KHSAA recommendation)
Equipment and Supplies	x		Uniforms appeared to be of equivalent quality and quantity for all sports. There was a written rotation plan in place for the purchase of uniforms.
Scheduling of Games and Practice Time	X		Equitable, written plans were presented regarding scheduling of games and practice times. The school currently meets the requirement of girls basketball prime date play for the 2010-11 season.
Travel and Per Diem Allowances	X		Transportation is provided for all athletic contests and practice facilities that are located off campus. The school does have a policy regarding transportation but it does not include attention to 'per diem' which would include allocations made for food and/or hotel use. (see KHSAA recommendation)
Coaching	x		Students interviewed were very positive about the coaches at Wolfe County High School. Coaches appeared to be comparably skilled and experienced. Data submitted showed the ratio of students to coaches to be approximately 10:1. It appears coaches are very accessible for student needs and contact.

Locker Rooms, Practice and Competitive Facilities	X	Since the 2001-2002 audit, a softball and baseball complex have been built with all comparable components and amenities as well as replacement of the basketball gymnasium playing floor. The girls and boys basketball locker rooms were of like quality and had similar amenities. Interviews with administration indicated that there were available locker rooms for softball, baseball and girls and boys cross country located in the elementary school adjacent to those venues. There was no written locker room assignment for cross country, golf, softball, and baseball. (see KHSAA recommendation)

Medical and Training Facilities and Services	X	The school weight room is located on the second level in the gymnasium and is accessible for all sports. The culture of the weight room is not motivationally inviting for females and very few light weights are available for their use. There was no written evidence of a weight room schedule. Physicals are made available to all athletes at a reduced rate by local physicians. The school does not have an athletic trainer. (see KHSAA recommendation)
Publicity	X	All athletes are recognized through an awards night/banquet program. After interviews with athletes, coaches and administrators, there appears to be a fair and equitable plan for awards and recognition. There was written evidence of an awards guideline. Auditors recommended that an expansion of that guideline may be developed to include any special awards that may be included for the future (hall of fame, regional/state accomplishments, etc.) The scheduling of cheerleading and pep band support appears to be fair and equitable to both genders.
Support Services	X	There are no established outside booster groups. All monies are deposited in the school and the Redbook procedures are followed for all receipts and expenditures. Coaches interviewed are well aware of the process and procedure in place for purchase requests and orders. Office space available is limited and appears to be shared by several coaches. There appeared to be no office space designated for cross country, track, or golf. (see KHSAA recommendation)

- Submit to the KHSAA, no later than April 15, 2011, a written designation of office space for cross country, track, and golf.
