Locker Rooms, Practice and Competitive Facilities	Х	Locker rooms, storage, and office space appear to be equitable for all athletes and coaches. Basketball, Wrestling, and Track teams have facilities for practice and competition on campus. Lockers rooms appeared to be equitable. Practice and competitive facilities for Swimming, Football, Girls' and Boys' Soccer, Softball, Baseball, Tennis, and Cross-Country are located at Falling Springs Sport Complex. This facility is owned and operated by the local Recreation department. It appears to be an excellent facility with equitable amenities for all teams. The softball field has recently been upgraded with the addition of brick dugouts and a locker room for dressing. The golf team practices and has competitions at Woodford Hills Country Club.
Medical and Training Facilities and Services	X	Woodford County has an athletic trainer provided through the services of University of Kentucky. One training room is located in the school building and another at the Falling Springs sports complex. The training rooms are accessible for both male and female athletes. The trainer's schedule and emergency phone information are available to all coaches. Woodford County has on staff a Strength Coach who maintains the weight room facility. Written evidence indicated the facility was used by all teams on a equal basis. It appeared to be equipped with a variety of weights and ropes suitable for male and female athletes.

Publicity	X	There is written evidence of an award policy in place regarding banners and pictures for both team and individuals that appears to be equitable. Information on athletic events for both male and females were posted on the school website and on the school channel 4 broadcast. It appeared to be equivalent for both male and females. Woodford County has one cheerleading squad that appears to show parity in support for all teams.
Support Services	X	<ul> <li>Woodford County has one booster club that provides financial support to all sports. They have a written agreement in the Title IX file. Monthly meetings are held with an athletic director in attendance. All fundraising projects and spending are conducted with approval of the total booster group and school administrators. The Booster Club supplies letters, bars and certificates for all athletes. The Booster Club also assists with transportation cost for all teams.</li> <li>Based on the information provided on the T-35 and T-36 forms for 2010-11 and 2011-12 school years, the overall spending is outside the commonly accepted parameters for parity. Upon further review, the disparity is due to the difference in salaries for one female and one male head and assistant coaching positions.</li> </ul>
