Equipment and Supplies	X		The School was made aware of the need for a uniform rotation plan. A note was made on the Summary Program Comparison (chart 3) giving advantage to boys over girls' teams in baseball/softball.
Scheduling of Games and Practice Time	х		There appears to be a discrepancy in scheduling shown on the team chart for girls swimming. "Is time of games satisfactory," marked "no". However, on summary chart 2, it was marked "yes".
Travel and Per Diem Allowances	X		Although there appears to be no deficiency in this area, It is suggested that school personnel look at the forms carefully. Some forms say no money is provided for food. However, the summary indicates otherwise. Also, other team charts are not clear.
Coaching	X		In future recruiting of new coaches, school personnel should be aware of the fact that a disparity exists in the experience level of some of the girls' coaches vs. some of the boys' coaches such as baseball and softball. Also, the salary schedule should address comparable length of seasons, etc.
Locker Rooms, Practice and Competitive Facilities		X	The swimming concerns should be addressed with the construction of a new facility. It is suggested that school personnel work with the Parks Department to upgrade the girls' softball dugouts to the standard of boys baseball. Also, there is a need to convert half lockers to full-size by the start of the 2001/2002 school year. As stated in The Corrective Action Plan, the school is to build a new competitive locker room for soccer and football. It is imperative that existing space next to the gym be converted to storage by the start of the 2001/2002 school year.

Medical and Training Facilities and Services	X	This area is basically satisfactory. However, there is a need to address the benefit to the boys' teams who have 3 managers vs. girls' teams having 1 manager as stated on the summary sheet. Also, there is a need to post a schedule for use of the weight room. There is a concern that the summary chart indicates that the softball training room schedule is not okay, but a different opinion was heard in the open meeting.
Publicity	X	To enhance the program, schedule cards should be provided to the softball team as they are currently provided for the baseball team. Also, a policy for posting any type of signage could be beneficial.
Support Services	X	It is apparent that there is sufficient office space available, however, it is used for storage. It is recommended that the school make use of them after the storage room is renovated.

School shall submit the following additional information:

(Selection of Cheerleaders) On or before April 15, 2001, the school is requested to provide information to the KHSAA concerning the manner in which cheerleaders are selected for boys' and girls' teams. If cheerleaders are selected in such a way as to result in arguably better (i.e. "A" team vs. "B" team) cheerleaders performing at boys' events, the school shall also submit a plan under which cheerleaders of equal ability shall perform at an equal number of boys' and girls' games in comparable sport (i.e., boys' varsity and girls' varsity basketball game).

(Prime Time Contest/Girls' Basketball) On or before April 15, 2001, the school is requested to provide information to the KHSAA concerning the number of "prime time" games scheduled (games to be played on Friday and/or Saturday nights) for its girls' varsity basketball team during the 2000/2001 season. To the extent that a fewer percentage of girls' games are played during prime times (when compared with the percentage of boys' games scheduled for prime times), the school shall advise the KHSAA of action it intends to take to immediately correct the difference.

#### (Budgets/Expenditures)

- All expenditures by booster clubs should be reflected in the expenditures section of the budget.
- The Corrective Action Plan states that the booster club expenditures will be reflected in the budget (i.e. under the schools control) by 8/20/2000. This has not been done at this point.
- There is a wide discrepancy shown on the budget for boys soccer (\$2,425) and girls soccer (\$443). This information should be provided to the Kentucky High School Athletic Association on or before **February 1, 2001**.

(Gender Equity Committee Meeting Times) Past meeting dates were all held in May. These meeting dates should be spaced out over the year. The schedule should be sent to the KHSAA by February 1, 2001.
