# **Report from the Individual Sports Committee**

### **Review Survey Results and Consider Competition Rules Amendment-Golf (Range Finders)**

The Board of Control received a recommendation from the Commissioner's Golf Advisory Committee that would allow the use of range finders at the high school level. At the time of the recommendation, Board members expressed concern about the equity, cost and availability of the devices throughout the state, and chose to defer a final decision on the use of range finders until further data could be collected.

Before making a final recommendation to the Board of Control, it was the desire of the Commissioner to determine the feelings of the membership, including elements such as cost and availability. The genesis of the recommendation dealt with improved pace of play as well as potentially having a positive impact on the quality of play. While the Commissioner's Advisory Committee has done a great job of relaying many of the feelings of the constituency as a whole, it is important that all members have input on this particular change. The membership was asked to respond to the survey, with only one vote per school. The result of that survey was that 65% of member schools approve the use of range finders.

# Review Draft WR Alignment for Distribution to Schools to be Finalized in January, 2013 with the movement of Fern Creek and Western from the original draft.

With the growth of wrestling, many of the regions are taking more than one day to compete. In addition, with the NFHS rules restricted athletes to five bouts in a day (including forfeits), the size of the bracket makes it problematic when they become so large they mandate a second day. With an average of around 956.3 wrestlers entered per year, the desire for eight regions with approximately 119.5 wrestlers entered per region would allow bracket balancing throughout the state and the duration of the meets to be similar if not the same.
