# **Report from the Sport Activity Committee**

#### Consider Revision/Elimination of Cheer Classes

When cheer was added as a sanctioned KHSAA sport-activity, the Advisory committee recommended 2 classes. However, after the first year of implementation, it is apparent that the classes, combined with the many divisions, have left holes in regional competitions as competing teams attempt to make the state competition. This change will also cut in half the cost of trophies and awards to the regional competitions. The logical next step is to eliminate classes and simply keep the divisions already in place. It is recommended to take that step at this time, so that it is known before cheer tryouts are conducted in April per Bylaw 25.

### **Report from the Individual Sports Committee**

### Approve Final Alignment in Wrestling, effective 2013-2014

With the growth of wrestling, many regions are taking more than one day to compete. In addition, with the NFHS rules restricting athletes to five bouts in a day (including forfeits), the size of the bracket makes it problematic when they become so large they mandate a second day. With an average of around 956.3 wrestlers entered per year, the desire for eight regions with approximately 119.5 wrestlers entered per region would allow bracket balancing throughout the state and the duration of the meets to be similar if not the same.

The re-drafted regional alignment includes the following basic geographic balance. As with all KHSAA alignments, the number one criteria is the geographic travel concerns of the effected schools. This is then balanced against other objections, such as entry balance, etc. Nothing about this discussion factors in anything about competitive balance, history of success or projected ability. In addition, the breakup in Region 3 and 4 is basically along the basketball alignment boundaries, with a few additional schools moved simply to balance the numbers.

As drafted and presented to the membership, the alignment was basically as follows: Region 1 - Far West KY; Region 2 - Owensboro to Elizabethtown area; Region 3 - Half of Jefferson County plus the Bullitt County Schools; Region 4 - The balance of Jefferson County; Region 5 - The northern part of Central Kentucky including the Oldham County Schools; Region 6 - Northern Kentucky; Region 7 - The southern part of Central Kentucky, from Lexington and following a path

near I-75 and south; Region 8 - The mountain area of Eastern Kentucky patterning basketball Regions 14, 15 and 16.

# Tennis - Revisions to Tie-Breaker and effect on USTA Recovery Rule

Staff recommends that the Tennis Competition Rules be amended at this time to reflect that the KHSAA change from a full third set tie break procedure to a "Super Tie Breaker". With this change, the first player or doubles team to 10 points, and ahead by 2, wins the match. It is scored as 1-0 with score in parenthesis --- 6-4, 4-6, 1-0 (10-7). This is an allowance within current tennis rules that has not previously been utilized. The change is recommended for boys and girls both in singles and doubles to ensure an ease of understanding and implementation by our teams.

# **Report from the Team Sports Committee**

### Consider three-team district procedure for possible revision

Staff has received requests about the mandatory play among 3 team districts. In many cases, the schools are willing to adhere to scheduling restrictions, but do not want to reserve four total games against their limit of games for district opponents. Staff is proposing that the Board of Control consider it a district option whether or not the schools play twice. The method for districts that play twice would remain as it is printed for 2012-2013. The method for district playing once would break the only possible tie (all teams ending up 1-1 in district play) with a blind draw. The playing once method would also be automatically implemented in any season where the dropping of one or more teams leaves only three teams in the district, and the current two-team fall back plan would be used if that number falls to two during a season. Further recommendation is additional discussion in April regarding seeding methods and tie-breakers when more than three teams are in an aligned district.

**Motion Passed:** Approve the change in the competition rules, effective 2013-2014 school year, wherein teams in three team districts would choose whether to implement a two-game requirement or one-game requirement for district play. # Region 1 (McCracken Consolidation)

With the consolidation of schools in McCracken County, the alignment in the first region must be addressed. Following months of discussion, the Commissioner, accompanied by two of the three area Board of Control members, conducted a meeting in Mayfield of the members of the first region. All schools attended. Based on feedback at that meeting, it was reaffirmed that it is the

desire of the member schools in that region to realign within the region, and not bring additional teams into the region. A review of the map will clearly show that travel is already a major issue in the first region, without affecting another school. Discussion of options showed that at this time, the district schools are not interested in any kind of alternative alignment where three or even two districts would be the result.

The following is the recommended alignment:

District 1 - Carlisle County, Fulton City, Fulton County, Hickman County

District 2 - Ballard Memorial, Graves County, Mayfield

District 3 - Community Christian, McCracken County, Paducah Tilghman, St. Mary

District 4 - Calloway County, Christian Fellowship, Marshall County, Murray

# **Consider Non-Varsity Game/Time Limits in Volleyball**

The Varsity standard format is best 3 of 5 sets, rally scoring, with the fifth set being to 15 per the NFHS Rules Book. Regular season Individual contests, by advance mutual agreement of the competing schools, may be played in best 2 of 3 sets with the third set to 25 and no cap. Should both schools not agree on match length, the default shall be the NFHS rule of 3 of 5 sets. For JV & Freshman, scoring is best 2 of 3 sets (to 21) with the third set to 15.

There would be little if any impact on team housing. Teams that have been playing on Saturday night (if utilizing housing) have been staying Saturday night, as have most of the teams who play in the semifinals. Spacing out the quarterfinals and finals would also allow for a split session, additional rest for the participants and an improved quality of play for all teams involved.

Based on that meeting, a survey is being conducted to get statewide results and a report will be mailed back to those members of the General Assembly.

# Discuss Possible Staff Recommended Amendments to Constitution or Bylaws

The Board of Control must annually review in conjunction with staff, the Constitution, Bylaws and Due Process Procedure. Per Board policy, any change to be placed on the ballot for the schools to vote on during the Annual Meeting, must get two readings, and the first reading must adhere to the May 1 published deadline for proposals.

For this year, staff recommends consideration of the following proposals: Bylaw 4 - Revise to start four-year count upon entry into grade nine (legal issues). Bylaw 25 - Consider across the Board reduction of 10 percent of varsity contests allowed in team sports (except football). New limits would be Baseball (32 from 36), Basketball (27 from 30), Soccer (21 from 23), Softball (32 from 36) and Volleyball (31 from 35)
