Consider Issuance of Referendum to Membership-AM Proposal 11

The final compilation of Proposal 11 for consideration by the membership resulted in conflicting concepts being debated by the membership. In addition, a lack of clarity of the current rule created confusion when the concepts were considered together.

Because of the sense of urgency felt by both the staff and the Board, and the underlying assistance to the membership for clarity, the Commissioner requested the issuance of a multi-part referendum to the schools to clarify and change Bylaw 23.

The first part would deal with clarity from the membership on off-season competition restrictions for play; the second part would be changes in both Bylaw 23 and 24 to stipulate open gym being applicable only to enrolled students and the third part would be to ensure clarity on coach involvement outside of the season.

Swimming Survey Results and Action

At the request of the Board of Control, the Diving schools were surveyed regarding a possible field expansion. The results of that survey were presented in July to the Board of Control. Following the receipt of those results, staff is recommending changes to the state Diving portion of the State Swimming and Diving Championship.

Tennis Format, Team Tennis Discussion

The Commissioner and Staff provided information for discussion concerning the state Tennis tournament in respect to the change from a team-oriented and structured tournament to a points-based title.

With recent changes and competition limitations necessitated by Sports Medicine advocates and researchers, the overlapping of the individual and team events was changed to separate events for the 2016 season to keep any athlete from participating in more than two full matches per day.

Significant feedback was gathered from the membership on this change. Staff spent a great deal of its summer planning retreat reviewing all issues related to this change. Team tennis has expanded over the eight years of play with more schools participating. However, because the event necessitated at least seven players per school, many schools were left out of the opportunity to win a school-based title.

Staff felt that more schools and students benefitted from a match-based and point-based tournament than from a seven player required team scoring tournament.

Motion Passed: That the official championship tournament for tennis return to a format where advancement points are awarded in the singles and doubles competition, and the additive points determine the winner. Staff would be directed to assist as feasible with the development of a coaches association conducted team-based event, which would be held on different dates and at different times, than the KHSAA State Tournament passed with a motion by Debbie Beichler and a second by Mark Evans.
