Commissioner Tackett and Associate Commissioner Cope updated the Board on the change in format of the State Swimming Meet (each gender on its own day), so that the KHSAA would be better able to accommodate all of the parents, grandparents, and fans hoping to see the State Championships. The State meet has been at the University of Louisville for many years and both the University of Kentucky and the University of Louisville desire to host the championships. There are no large alternate facility available.

Golf Region Alignment and State Qualification Discussion

Following the last Board meeting, Staff reviewed Board of Control feedback and wanted to separate the issues as the Board further considers changes in Golf. A survey is currently out to the membership on golf participation to help guide the Board's further deliberations.

For this discussion, the staff recommended consideration of reducing the number of members who play on a qualifying team in the state tournament to four players (from five). This will have a direct impact on the pace of play discussions that have been involved in past tournaments and allow for fewer at large players if the number of regions is increased. Once this decision is made, staff will fully compile the membership survey and bring a draft alignment to the Board for the January meeting, at which point final decisions can be made on the number of team and individual qualifiers advancing to the state tournament.
