## **Diving Regions Survey Results and Date Approval**

After more than two years of discussion, a survey was taken of the membership regarding the scheduling of regional diving competition in which schools were asked to choose between two options. Each school was asked to submit only one vote. Voting was done by the Principal or Designated Representative of each school with no duplicates being used.

## **Option A - REGIONAL DIVING**

I would see staff set the regional diving competition at three to four "super-regional" type sites. These competitions would be held BEFORE the regional swimming meets. The plan would be to have no more than four, likely only three competitions that would combine regions. These competitions would seek to have the same judging panel at all competitions to assist with consistency, and points would be earned per region, not super-region. In other words, if a combined meeting involving Regions 1, 2, and 3 were held, each region would have its scoring, and the points earned would "carry forward" to the regional swim meet to determine the region champion.

## **Option B - STATE DIVING SCHEDULE**

For the most part, the schedule will remain the same for the State Meet, as was done in 2019. However, it was requested that when this survey is done that we also ask about State Meet Diving scheduling. Several schools mentioned that they would prefer the Diving Competition to be started and completed on Thursday if we have facility availability, to allow the divers who desire to do so to return to the school for Friday sessions.

So issue 2 asks if your school would favor completing the Diving in one day at the state meet if the facility is available, or continuing to do the first rounds on Thursday and Diving Finals on the day of that gender's swimming finals.

Based on the survey, 75% of the respondents favor scheduling regional diving using option A.

## 2020 Diving Schedule

Using the previous survey referenced, schools were asked about conducting the State Competition in Diving all in one day. With minimal objections, 62 of 100 of the responding schools favored the change (Option A).

The KHSAA could schedule diving to be completed in one day, if and only if, the diving well is available throughout the day and not subject to "black out time" by the host facility.

Also, rotate the genders so that a different gender is conducting their state championship during swimming warm-ups each year.

Based on the survey, more schools favored the move, and it is logistically feasible and could result in a reduction in obligated travel, potentially giving diving its date.

## Sayre Request to Replace Jenkins in District

With the withdrawal of Jenkins from district play for the duration of the alignment, Sayre, with a relatively new football program, has requested to enter the playoffs in 2020 in Jenkins vacated spot. A more geographic solution could be developed for 2021 when natural adjustments in the classification are scheduled.

Commissioner Tackett reported that the move appears advantageous to all involved to approve the request with these scheduling issues to be considered:

- 1. Allow Sayre to assume Jenkins' spot, automatically taking the 4th seed.
- 2. Allow Sayre to assume Jenkins' spot, and seed Sayre 4th unless their RPI places them in a higher position.
- 3. Seed the district entirely based on RPI
- 4. Mandate that all teams adjust schedules to play Sayre, with flexibility for movement of district games outside of the scheduling grid.
