Impact on Schools of Title IX Reg Changes

Commissioner Tackett and Assistant Commissioner Bilberry gave a brief report on the impact of changes in Title IX on the member schools even within the data system of the KHSAA.

Effective this past summer the Office of Civil Rights through federal mandate required all secondary schools to designate and authorize at least one individual to serve as that school's Title IX Compliance Coordinator. The name, title, office address, email address, and telephone, number of each designated individual should be published on the school's website and in any relevant publications such as the Student Code of Conduct or Employee Handbook. This information should be accessible to all current students, applicants for admission or employment, employees, parents or legal guardians, and all school unions or organizations that have Collective Bargaining Agreements.

In the KHSAA's ongoing efforts to work with our member schools, the KHSAA will establish the position in the KHSAA database of Title IX Annual Report coordinator, separate and apart from the Title IX Coordinator. These additional steps will be an effort to help maintain gender equity. The Title IX Annual Report Coordinator will serve as their school's point of contact for the KHSAA spring reporting and on-site visits. The Title IX Coordinator will be required in the database with the requisite email addresses and phone numbers being available for the general public as well as the student body and school employees.

Both of these positions will also serve as the onsite representatives in regards to forming Gender Equity Review Committees and conducting these committee meetings. The Title IX Annual Report Coordinator will be responsible for administering student surveys, completing the Annual Report, and working with the KHSAA Title IX Auditors whenever their school is scheduled for a site visit.

Holders of each of these positions are encouraged to contact the KHSAA at any time with questions or concerns in regards to administering their schools Title IX program as well as dealing with any complaints or inquiries from students, employees, or the general public.
