So, if a coach has been vaccinated x 2 and is then exposed to COVID-19 they can STILL get infected therefore can be a spreader. Most likely asymptomatic, but still a potential spreader. The data on whether the vaccine keeps you from getting the virus is underway, but not available yet.

So, the coach won't be 'home free' from spreading the virus. But they have protected themselves from severe illness.
