Finance/Admin

President-Elect Election

Rationale:

The Board of Control annually elects from its membership, a President-elect to serve the following year, and then transition to the President position in the second year following.

Board members are reminded that the officers for the following year are elected at the 5th meeting of the year.

As adopted, the procedure for the election is as follows:

A. ELIGIBILITY AND NOMINATIONS

To be eligible to seek the position of President-elect, the individual shall be in the second year (rising to the third year) of his/her first term, or in his/her second term.

Nominations shall be made in open session with a motion from a sitting member of the Board of Control. No second shall be required for the nomination.

B. BALLOTING

Balloting shall be done in open session with a public vote.

1. ELECTIONS WITH ONE CANDIDATE

In an election with one candidate, the candidate shall receive at least ten (10) votes to be elected or may be elected by approval of a properly made motion to accept the candidate by acclamation.

2. ELECTIONS WITH TWO CANDIDATES

In an election with two candidates, a candidate shall receive at least ten (10) votes to be elected.

A ballot that is tied or in which no candidate receives ten (10) votes shall be repeated a maximum of two times.

If three ballots are held with no member receiving ten (10) votes, the election shall be decided by a coin toss with the candidate alphabetically listed first having "heads" on the coin.

3. ELECTIONS WITH MORE THAN TWO CANDIDATES

In an election with more than two candidates, a candidate shall receive at least ten (10) votes to be elected.

If no candidate receives ten (10) votes and one candidate has a greater number of votes than the other two (2) candidates, and the other candidates not having the greater number of votes are tied, a candidate shall be eliminated by coin toss with the candidate alphabetically listed first having "heads" on the coin. The election shall then proceed according to either section (2) or (3) above based on the number of remaining candidates.

If no candidates receive ten (10) votes and one candidate has a greater number of votes than the other two (2) candidates, and the other candidates not having the greater number of votes are not tied, the candidate shall be eliminated with the fewest votes. The election shall then proceed according to either section (2) or (3) above based on the number of remaining candidates.

Update on Corporate Sales Agreement

The KHSAA has been in the corporate sales world since the administration of former Commissioner Tom Mills who retained a former high school principal to help sell its partnerships. Under Commissioner Louis Stout and with current staff negotiation, the Association originally signed with USA Properties, a division of Host Communications in a corporate sponsorship sales agreement that was fairly revolutionary at the time and allowed for both internal staff sales and

external sales. Under Commissioner Brigid DeVries, sales were shifted away from internal sales to solely focus on sales by an external group, eventually evolving into an agreement with iHigh.com, based in Lexington. During all of these times, multiple methods have been used to sell sponsorship. The previous external agreements were highly favorable to the sales companies, with few controls by the Association.

Under the current Commissioner, working in conjunction with staff and the Board of Control, corporate sales were again made an internal function with full-time staff hired in this area. Following a trial with that arrangement and further complicated by retirement system issues, the determination was made to outsource sales again to an outside entity where they remain today with a fair amount of success.

Teall Properties Group (TPG) is a newer player in the business, and is focused on the marketing of state high school associations, and in many cases, individual schools, exclusively around the marketing of high school athletics to the corporate community. They have solicited the KHSAA for more than a year and a friendly exchange of information has occurred without obligation on the part of either party.

TPG Deal Points

TPG sells at this level, and now includes the New York, Vermont, New Hampshire, Massachusetts, Maine, New Jersey, DC, Tennessee and South Carolina Associations, along with several large high school conferences.

TPG is currently the marketing arm for the NFHS and NFHS Networks and in discussions with many other state associations.

TPG offers both guarantee models, where revenue is guaranteed for the Association budgets, and standard sales models.

TPG Deal Points and Considerations

For the guarantee model, revenue is guaranteed long-term so that the Association can more readily create a working budget for the year without having to dedicate other staff to constant monitoring and supervision. In other words, staff can do what they are trained to do and let a sales force do what they are trained to do.

Guarantee model presentations are longer term (i.e. 10 years) in which the company is likely upside down for more than two years (with the Association continuing to receive its guarantee) While 10-years is frequently a discussion point, the security of guaranteed income has a value. Any worries of "lost potential" are hopeful that sales will be at such a level that the company ends up advantaged, which is why safeguards are contemplated in the agreements.

Financial Model

Each year, Association and TPG must agree on a budget of revenues and expenses. Both jointly control the expense side of the equation through this process.

The Association receives its contracted guarantee each year regardless of sales, a guarantee with a modest escalation each year.

Financial Model

Sponsorship agreements would be re-worked for existing partners to ensure that expenses (tickets, hotels, etc.) are separate and are paid to the Association for fulfillment. Specific agreements (agreements involving expense trade such as restaurants, auto dealers) as well as Musco Lighting would continue to be managed by the Association due to the nature of those agreements.

Implementation Model

If agreed, staff could finalize the agreement and sales could begin in early spring. Current marketing would be retained through the end of the school year with TPG not selling into the spring events for 2021 without concurrence by the Association.

Staff would provide space and technical assistance for the TPG staff member (selected by TPG in consultation with KHSAA), and no other personnel costs would be involved.

Included in the proposal is a signing bonus. If executed, staff would bring back to the Board in May potential uses for those revenues including potential consideration of "seed" money for the development of the foundation.

Recommendation

Authorize staff to continue negotiation and sign an agreed-to contract to shift the corporate sales operations to TPG for 21-22 following review of contract by General Counsel and signature by the Commissioner.
