Marketing Sales Status Report from TPG Sales

Associate Commissioner Cope and TPG KHSAA Lead Sara Hacker provided a brief oral report as we close the year.

Report from April NFHS Legal Meeting-Radar Alerts

Commissioner Tackett, Associate Commissioner Cope, and General Counsel Collins attended the NFHS Summit and Legal Meeting in Indianapolis on April 20 and 21. The Summit dealt with key issues facing states (primarily judicial and legislative), the NFHS Network, and excellent information on ensuring that states don't undervalue their events. It was reinforced that in many cases, Kentucky is somewhat unique because the vast majority of our events are not multiple-day duration and involve fewer room nights, which, while helpful for our schools, may lead to fewer incentives for the tourism groups to put out dollars for appearances.

The Legal meeting began with a comprehensive list of issues, including the legal status of championship workers and very unusual court cases. Then an in-depth look at Name Image and Likeness and its impact throughout the country. In many cases, states have had to make emergency amendments to their rules (if they could get school support to pass them). We found we were fortunate not only to have more flexibility in our rules than most states but having the opportunity to be in on the authorship of the Kentucky NIL statute afforded us the chance to get some protections.

A comprehensive review of key cases throughout the country, work on the officials recruiting and retention issue, and a lengthy session on various transgender issues continued throughout the day. There was then a lengthy discussion of transfer rules and policies and an update on the latest intellectual property developments in this level of play.

A very informative session on combination teams (co-ops) gave our staff good information if the future direction we have to utilize. There was a good session on legislative monitoring and lobbying and the wisdom (or not) of using a lobbyist. Mr. Tackett assisted Mr. Collins in a presentation to the group on the privacy of student records which they were able to inform the states of issues discovered in an in-depth case this past year.

The remainder of the meeting dealt with recent developments in implicit bias, innovations in state association governance, concussion litigation, state oversight of coaches, the latest in sports medicine and catastrophic injury concerns, and a plethora of new offerings with NFHSLearn.com.This is a beneficial meeting in our governance role, and it was important for our staff to be present.

Reports from KAAA Meeting

The Kentucky Athletic Administrator Association invited the Commissioner and staff back to the conference to present on current issues and things to look forward to. Mr. Collins ran a legal session where he gave legal update to Athletic Directors on negligence, liability, and general legal issues in today's high school athletics environment. Mrs. Bridenbaugh also presented at the conference about the status of middle schools across the state and covered specifics within the Middle School regulation.

NFHS Summer Meeting

The Summer meeting will be held in Seattle, Washington, this year, where the executive staff and qualifying board members will be attending. This conference is a great opportunity to connect with other states to see what challenges they have faced and the great things they are doing around the country.

NFHS Network Report and Information

The Commissioner and staff reported on ongoing NFHS Network operations.

Handbook and Regulations Review

Discuss Bylaw 14 Interpretations on Ineligible Players Participating

The discussion was of swimming issues and track participation in same races by ineligible and eligible athletes. Issues surrounding using non-eligible competitors in practice (i.e., boys in girls' basketball practice) was also reviewed.

Changes to Association Policies

Staff reviewed necessary policy changes. The Board has previously considered and discussed the changes to the Board policies such as sunsetting any COVID provision. Adapt the Competition Rules to match current board-approved operations for draws, substitutions, and other event-specific guidelines enumerate all state association adoption provisions in the playing rules within the competition rules. Update the provisions regarding enrollment-based classifications.

Reviewed and updated all provisions related to officials licensing, including the background check provisions (once per career), online registration through an outside entity, clarifications on retention of physical exams, and all other discussed policies since the beginning of the pandemic.

These shall be submitted to start the regulatory process and available in full revised form in time for the July board meeting and subsequent regional meetings with the member schools.

Second Reading, Additional Prime Date Options for Prime Date Schedule Compliance

Staff initiated a discussion in late fall about additional options to ensure "prime date" exposure for female student-athletes in basketball. From the original adoption by the Board, the OCR consultant, the Board of Control and the staff were consistent and the board concurred with the following.

""Prime Time" is commonly used to describe the optimum game times and days that are: convenient for student-athletes; appropriate in the opinion of coaches; and conducive to audience attendance. The preferred game times are likely the same for girls' and boys' teams in the same sports. Coaches' and student-athletes' interests may include game times that do not conflict with classes and meals, such as scheduling one game during the week and one game on the weekend rather than scheduling two games on weeknights. Coaches' personal schedules or other employment commitments may not justify setting game times that disadvantage athletes of one sex."

As for audience attendance, OCR's 1979 Policy Interpretation recognizes that actions that "limit the potential for women's athletic events to rise in spectator appeal" could delay the growth of girls and women's athletic programs. Thus, schools are expected to schedule times for girls' and boys' events that are equally convenient, or equally inconvenient for audience attendance. This means that providing a boys' team preference in-game time, to the disadvantage of a girls' team, is not justified because of past traditions, a specific team's popularity, or any potential revenue production. For many interscholastic programs that offer multiple competitive levels of varsity, junior varsity, and freshman teams in particular sports,

the most preferred game times are often reserved for the varsity teams followed by the junior varsity, then freshman teams."

Before girls' basketball was revived in the 70s boys typically scheduled games on Tuesdays and Fridays. so, when schools added girls' basketball they conveniently, so as not to rock the boat started playing on Mondays and Thursdays.

When we got into the scheduling issue, we selected 40% as a reasonable standard to get going on getting the scheduling corrected for the benefit of the girls' programs. We could have selected 50% and the OCR consultant and OCR suggested that, which some might say should be the case.

As you know, a lot of work has been done in this area thanks to KHSAA support even with tournament scheduling of back-to-back doubleheaders, etc.

This proposed change to the regulation, to allow for a doubleheader to be counted as prime-date if played as a doubleheader, recognizes that even 20 plus years after the first emphasis on the prime-date aspect, the girls are likely to get more exposure in the community and the school by playing at the same date and site through the weeknights. This seems to be the best "middle ground" for those new coaches who in many cases, don't remember the struggle it was for girls' basketball to gain ground when it was first introduced back into the schools.

Amendment Discussion, KHSAA Bylaws

Pulaski County has submitted a proposal to be presented at the annual meeting proposing an adjustment to the athletic advantage rule. This proposal deals with enforcing the rule at grade seven. The transfer rule would still start at grade nine.

Discuss Bylaw 23, Limit of Seasons, End of Season

The conversation about ending the regular season a week before the post season starts was discussion. The board considered waiving the rule for schools this year and for the future getting rid of the rule. With this rule gone this would allow teams to play right up to the post season start date.

Discuss Amendment to Bylaw 6 per SB145 and Non-Resident Students Championship and Competition rules Issues

A discussion was held regarding the incongruence between SB145 and Non-Resident Students and Bylaw 6. The explanation was given that the students who meet the definitions of a staff member being the parent of a contestant excluded the student from the applicability of SB145 (KRS 157.350) but did not waive the transfer rule. Therefore a membership proposal would be required for further waiver to Bylaw 6.

A survey was conducted after nearly a year of discussion with various school groups on the problem with capacity at the state meet.

Based on the survey, it is clear that a majority do not favor a reduction in qualifiers from the region which has helped to continue to grow the sport.

Alignment, Track and Field and Cross Country 2023-2024

Based on the enrollments provided by the Kentucky Department of Education for the 2019-20 and 2022-23 school years, a draft alignment of track and cross-country teams has been developed. Those results were shared with the Board as part of the agenda. The original discussion of dividing the schools more evenly (same number of teams in each class) would have resulted in a great many moves and unsettled relocations within classes. By simply using the parameters of the last two alignments (75-77 schools in top two classes, balance in Class 1A), the amount of school movement is greatly diminished. It is also worth noting that many schools in the smallest school group (1A), do not regularly field a full team.

The Board's decision point is whether or not to distribute the alignment as final for the next two or four years or to distribute the alignment in draft form, with final approval in July. It is worth noting that for football since the numbers were delayed due to COVID, the alignment was simply distributed in final form with only minimal appeals and feedback considered. While the sports situations might be different, this matter of practice should be finalized.

With football realignment looming again for 2023-24, these parameters should be known well in advance to be sure communication is clear with the schools.

Triennial Survey Report and Action

The Commissioner and staff reviewed the triennial survey results and also reported on the requested follow-up surveys.

Due to interest in team tennis, boys' volleyball, boys' lacrosse, and girls' lacrosse, an additional survey was authorized by the Board of Control. The results of that survey, which closed on 5/8/23 were listed in the agenda material.

The current in-force policy requires 50 member schools wanting to enter championship play for the board to consider adding a sport. The board approved earlier this year to amend that number to 15% of the member schools. With 289 members, that new total needed would be 44 schools. Though this policy does not yet have the force of state regulation, staff has operated under the premise that the 15% should be the threshold to add a championship.

In addition, a 10% threshold exists for any support to be given by staff and a significant number of sports and sports activities have that level of support. With the addition of any new offerings, staffing needs to be a concern, however, this year's results appear to go a long way toward allowing that transition to be natural.

Follow-up Survey Team Tennis (Spring)

In team tennis, matches are contested between two teams, with each team consisting of seven or more players. The teams compete against each other in a series of matches, with each match consisting of a set number of games. The team with the most wins at the end of the matches is declared the winner. In individual tennis, matches are contested between two players. Each player competes against the other player in a series of sets, with each set consisting of a set number of games. Review Staffing Plan and Budget Impact

The Commissioner reviewed (again) the plans for staffing heading into 2023-24. The plan would be to create a part-time, minimal employment benefit position to serve as the Supervisor of Officials. This would be a two to two-and-a-half-day-per-week

position solely working with the recruiting and licensing of officials. This person would work with the Commissioner's office on programs to recruit and train officials, including integrating the training into the school curriculum with Refreps.com, as well as manage the day-to-day inquiries related to disqualifications and serve as a traffic officer so to speak with officials' inquiries. The position would be in the office, but would allow for some out-of-office work meetings with various colleges and universities about promoting sports officials and officiating and would be dedicated resources to the efforts instead of being just an additional duty for assigned staff. The estimated cost would be in the \$30K to 45K range.

The second position would be a full-time position in the office as an Event Services person. As the senior staff has met and analyzed long-term needs, this is the best use of resources at this time, getting "more hands-on deck" for the many championship events including advance planning, was seen as preferred, at least at this time, to hiring an assistant commissioner as so many of these tasks needed cross events without specialization. This position would be in the \$48K to \$54K range, very similar to other state associations that have expanded staff. These two positions would be included in the FY23-24 draft budget for planning purposes.

Longer range, based on the decisions regarding championships, the goal would be to make the new events self-sustaining to the point that the Association could, during the 2023-24 school year, add the fifth assistant commissioner to the staff if needed. This would ensure a smooth transition in the event of any other movements among staff in future years without disrupting member school services.
