Board of Control Meeting - February 11, 1950

The Board of Control of the Kentucky High School Athletic Association met at the Kentucky Hotel, Louisville, on Saturday morning, February 11, 1950.

The meeting was called to order by President Lyman V. Ginger at 9:30 o'clock, with all members present.

C. H. Arnett moved, seconded by Carl Hicks, that the reading of the minutes of the December 17 meeting of the Board of Control be waived, since all members of the Board had received copies of the minutes. The motion was carried unanimously.

James L. Cobb moved, seconded by H. B. Gray, that the annual meeting of the Association be held on Friday of K.E.A. week, the date being April 14. The motion was carried unanimously.

Miss Betty Kirlin, state representative of the N.S.W.A., appeared before the Board, for the purpose of explaining the work being done by her organization, and to request a small appropriation, to be used in defraying the cost of postage, mimeography, etc., in connection with mailing out certain material to K. H. S. A. A. member schools. T. K. Stone moved, seconded by James L. Cobb, that an appropriation of \$100.00 be made to the Kentucky Committee of the National Section on Women's Athletics. The motion was carried unanimously. Commissioner Sanford told Miss Kirlin that he would be glad to print articles relative to the N.S.W.A. program in "The Kentucky High School Athlete" from time to time.

There was a discussion concerning the advisability of the K. H. S. A. A. going into the Babe Ruth sportsmanship project at the present time. After much discussion relative to the good and bad points of the proposed program, James L. Cobb moved, seconded by Carlos Oakley, that the proposal relative to the Babe Ruth project be tabled indefinitely. The motion was carried unanimously. 284

The Commissioner read a letter from Charlie Vettiner, suggesting that a pre-tournament banquet be held for coaches and players of the sixteen regional winners, for the purpose of creating good will between the school representatives involved. The Board declined to approve such a meeting, due to the fact that it would be very difficult to get all of the teams together immediately prior to the first round of the State Basketball Tournament, and directed the Commissioner to notify Mr. Vettiner accordingly.

President Ginger made a short report on the meeting of the National Federation Football Committee, which he attended at Santa Monica late in December.

The Commissioner stated that, under authority given by the Board of Control in recent years, he and President Ginger had broken the tie vote for a district tournament site, between Vanceburg and Olive Hill in District 63, and that they had named Olive Hill as the site. Roy G. Eversole moved, seconded by James L. Cobb, that the decision of the President and the Commissioner be confirmed. The motion was carried unanimously.

The Commissioner reported that Vice-President T. K. Stone had been nominated for reelection as a member of the Board of Control, representing Section 4, and that no other nominations had been received. H. B. Gray moved, seconded by C. H. Arnett, that T. K. Stone be declared as elected to membership on the Board of Control for a period beginning July 1, 1950, and ending June 30, 1954. The motion was carried unanimously.

Carlos Oakley moved, seconded by Carl Hicks, that all bills of the Association for the period beginning December 17 and ending February 10 be allowed. The motion was carried unanimously.

The Board was then called to order in its capacity as the Board of Directors of the K. H. S. A. A. Protection Fund.

H. B. Gray moved, seconded by James L. Cobb, that the following claims against the K. H. S. A. A. Protection Fund be allowed:
