Dear Dawahares/KHSAA Hall of Fame Selection Committee,

It is with great pride, respect, and admiration that I submit Mr. Mike Riley's credentials for consideration for the KHSAA Hall of Fame. Mr. Riley served the Livingston County School System for 33 years as a teacher, multi-sport coach, athletic director and Principal. In 1975, he returned to Livingston Central High School, his alma mater, from where he had played high school baseball and basketball to start his career as an Industrial Arts teacher and coach. His dedication to Livingston County students and community never wavered over the next 33 years. His retirement in 2008 brought an end to era at Livingston Central High School; an era of success and longevity that will be very difficult for anyone to match in the future.

Mr. Riley served Livingston Central High School and community in numerous roles in his career. He was an assistant basketball coach for 11 years, head basketball coach for 11 years, and was head baseball coach for 18 years. In addition to his coaching, he moved into administration and in that role he served 4 years as athletic director, 15 years as board appointed representative, and 11 years as principal. In his administrative roles, he was a tireless advocate for athletics and he believed strongly in the opportunities KHSAA sports provided to our students. In all 33 years of his career, he was directly involved in the athletic program at Livingston Central High School. He was

very dedicated to providing equal opportunities in sports and was very concerned with promoting Livingston Central's status as related to Title IX. Under his watch, the school's staff was very diligent in remaining in Title IX compliance and he can be credited with the development of additional sports for girls at Livingston Central such as golf and volleyball.

During his coaching career, Livingston Central was a perennial force in 5th district baseball and basketball. His head coaching resume includes 7 district championships, 4 district runner-ups, and 11 regional appearances in 18 years. He also served for 11 years as an assistant basketball coach under Mr. Don Ringstaff, a 2002 inductee into the KHSAA Hall of Fame. Including his years as an assistant coach, Mr. Riley made 22 coaching appearances in 2nd region tournaments in his 33 year career. He coached in 2nd region championship games on two occasions, as head coach in the 1977 baseball championship and in the 1978 basketball championship as an assistant coach.

There are 3 key points about Mr. Riley that I believe make him an excellent candidate for your consideration for the KHSAA Hall of Fame. These are: 1) his dedication to one school's athletic program and community for 33 years. His career accomplishments were based on building a winning program from the ground up. In a world today where coaches are often seen relocating and following the talent, prestige, and the monetary rewards that come with coaching in a larger school, Mr. Riley never considered doing that. No doubt he could have followed that path if he had chosen to do so. Instead, his heart and loyalty were with his home school and community where he grew up, attended school, and played sports himself. In today's environment, I believe the days of seeing a person serve as a coach and administrator in one school for this long will become even rarer over time; 2) his role as a teacher and educator made his influence extend well beyond athletics. His example and positive influence he provided for thousands of students, not just those involved in athletics, cannot be overstated. He constantly stressed the need for students to challenge themselves and succeed academically. He was a great motivator who made people believe in themselves and aspire to reach higher goals. Mr. Riley taught sportsmanship, morals and values not only by words but more importantly, by example; 3) his high standards of personal excellence in everything he did during his career. Mr. Riley was very concerned with his school and community being represented in a positive manner. He held everyone around him to this standard, including students, players, coaches, and staff members. For nearly his entire career, he maintained his own baseball fields, sometimes even using his own mower and equipment. He donated a countless and untold number of volunteer hours to Livingston Central High School for which he was never compensated. He kept his bus driving credentials for his entire career so he could transport his teams and save transportation costs, so more funds would be available to spend on the student athlete. In today's world, I see men with the work ethic, dedication, selflessness, longevity, and commitment as displayed by Mr. Mike Riley for 33 years as a quickly vanishing breed.

The mission of the Kentucky High School Athletic Association reads "The KHSAA shall establish and deliver the highest quality interscholastic programs and activities in an efficient manner which emphasizes sportsmanship and integrity and enhances the education of the student athlete." Mr. Mike Riley lived and carried out this mission for 33 years in his service to Livingston Central High School, its students, athletes, and community. For this reason, I urge you to give his nomination to the Dawahares/KHSAA Hall of Fame the utmost consideration.

To Whom It May Concern,

It is my pleasure to write a letter of recommendation on behalf of Mike Riley so that he may be considered as an inductee to the KHSAA Hall of Fame. Mr. Riley was involved in athletics for over 33 years either as a multi-sports coach, athletic director, board appointed representative to KHSAA, assistant principal, and/or as principal at Livingston Central High School. In addition, Mr. Riley participated in athletics as a student in the same school system. It is highly unusual for an individual to play sports in high school, and then devote their entire career, much of which was largely invested in athletics, to the same school system. Mr. Riley was truly a champion for Livingston Central High School students and to all their athletic programs.

As a student Mr. Riley began playing basketball as an 8th grade student at Livingston Central High School. He continued playing basketball at Livingston Central High School throughout his high school career. In addition, he played baseball his junior and senior year. During his basketball and baseball career, Mr. Riley's teams found success at the district and regional levels.

While in college, Mr. Riley served as the 7th and 8th grade basketball coach at Salem Elementary located in Livingston County. After graduation from Murray State University, Mr. Riley was hired as an Industrial Arts teacher and began his 33 year career serving the students of Livingston Central and promoting athletics in the district.

Mr. Riley began his coaching career as an assistant basketball coach under the direction of 2002 KHSAA Hall of Fame inductee Don Ringstaff. He continued to serve as Coach Ringstaff's assistant until the retirement of Coach Ringstaff in 1986. Then, Mr. Riley was named as head basketball coach in 1986 and served in that capacity through the 1996-97 school year, when he was named as principal of Livingston Central High School.

While serving as assistant and head basketball coach, Mr. Riley also served as head baseball coach from 1976 through 1992. While serving in the capacity of baseball and basketball

coach, Mr. Riley's teams were very successful by winning several district championships as well as district runners up and making it as far as the regional runners up.

In 1993, Mr. Riley began his administrative career by becoming the Livingston Central High School's athletic director and KHSAA board appointed representative for the school, while still serving as the head basketball coach. In the 1996-97 school year, Mr. Riley was named as assistant principal of Livingston Central High School, but continued as the athletic director, board appointed representative to KHSAA and head basketball coach. At the end that school year, Mr. Riley announced his retirement from coaching.

The next school year (1997-98), Mr. Riley was named as principal of Livingston Central High School where he served until his retirement in 2008. While serving as principal, he continued to be the board appointed representative to KHSAA. In the 2004-05 school year while serving as principal, Mr. Riley was instrumental in forming the girls volleyball team at Livingston Central High School. During the 2006-07 and 2007-08 school year while serving as principal, Mr. Riley also reassumed the responsibility as head baseball coach.

As a high school basketball and baseball player myself from 1980-84, my teams played against the teams coached by Mr. Riley at Livingston Central High School. Then, as I began teaching, coaching, and serving in various administrative roles, my teams also competed against Mr. Riley's teams. Even though Mr. Riley taught his players to win and be competitive, Mr. Riley most importantly taught his players how to live life beyond sports through teaching sportsmanship, how to accept winning but also how to accept losing, and being a friend to his players/students.

As I mentioned earlier, it is very unusual to see an individual dedicating their entire life to one school system and to the athletics of one high school as Mr. Riley did throughout his career. For these reasons, I hope you give consideration to Mike Riley as a candidate for the KHSAA Hall of Fame.


