# Accomplishments of Don Salyers

# Primary Officiating Accomplishments at the High School Level

- He officiated high school wrestling from 1976 to 1994 and worked the state tournament the very first year.
- 2. He officiated 18 consecutive state tournaments along with districts, regions, etc.
- 3. He officiated the Coaches Association State Dual Meet Tournament from its inception until his retirement.
- 4. He was the first president of the Northern Kentucky Wrestling Officials Association and served in that capacity for the first three years of the organization.
- 5. He served on the National Rules Committee for the National Federation of High Schools for two different terms covering the years from 1981 to 1996.
- 6. He was a member of that committee that is responsible for cutting out extreme weight reduction from the sport. Examples: plastic suits and hot tubs.
- 7. During his terms the committee put the growth allowance back into wrestling so that the athletes were more able to grow naturally.
- 8. He was appointed the KHSAA rules interpreter by Commissioner Louis Stout and served in that capacity for several years.
- In addition to traveling the state as the KSHAA rules interpreter, Don conducted many free clinics for coaches and wrestlers across the state and also conducted a large clinic for the Coaches Association.

# Other Officiating Accomplishments

- 1. Don also worked at the collegiate level from the second year that he was a licensed official. He worked for the University of Kentucky until they dropped their program.
- He worked many college tournaments and was voted the top official at the Big Ten Dual Meet Tournament.
- 3. He worked a dual meet when Michigan defeated lowa for the first dual meet loss of Iowa Coach Dan Gable in 16 years.
- 4. He also worked two NCCA National Championships.

## Other Factors that I Would Like the Hall of Fame Committee To Consider

- 1. Don was responsible for recruiting and training several northern Kentucky officials who are working today in the sport of wrestling.
- 2. He was also a positive role model for these young officials and many young wrestlers.
- 3. He continues to have a great love for the sport, which is exemplified by his support for the KHSAA and its wrestling and Hall of Fame programs. Each year his company purchases an ad for the score clocks that we currently use at the state tournament. His company has also purchased ads in the state wrestling and state basketball programs in years past. I am writing this letter in support of Don Salyers being nominated to the KHSAA Hall of Fame.



I personally enjoyed Don's officiating as well as his friendship during the time we were refereeing together. I think the brotherhood Don and I developed over the years is priceless.






