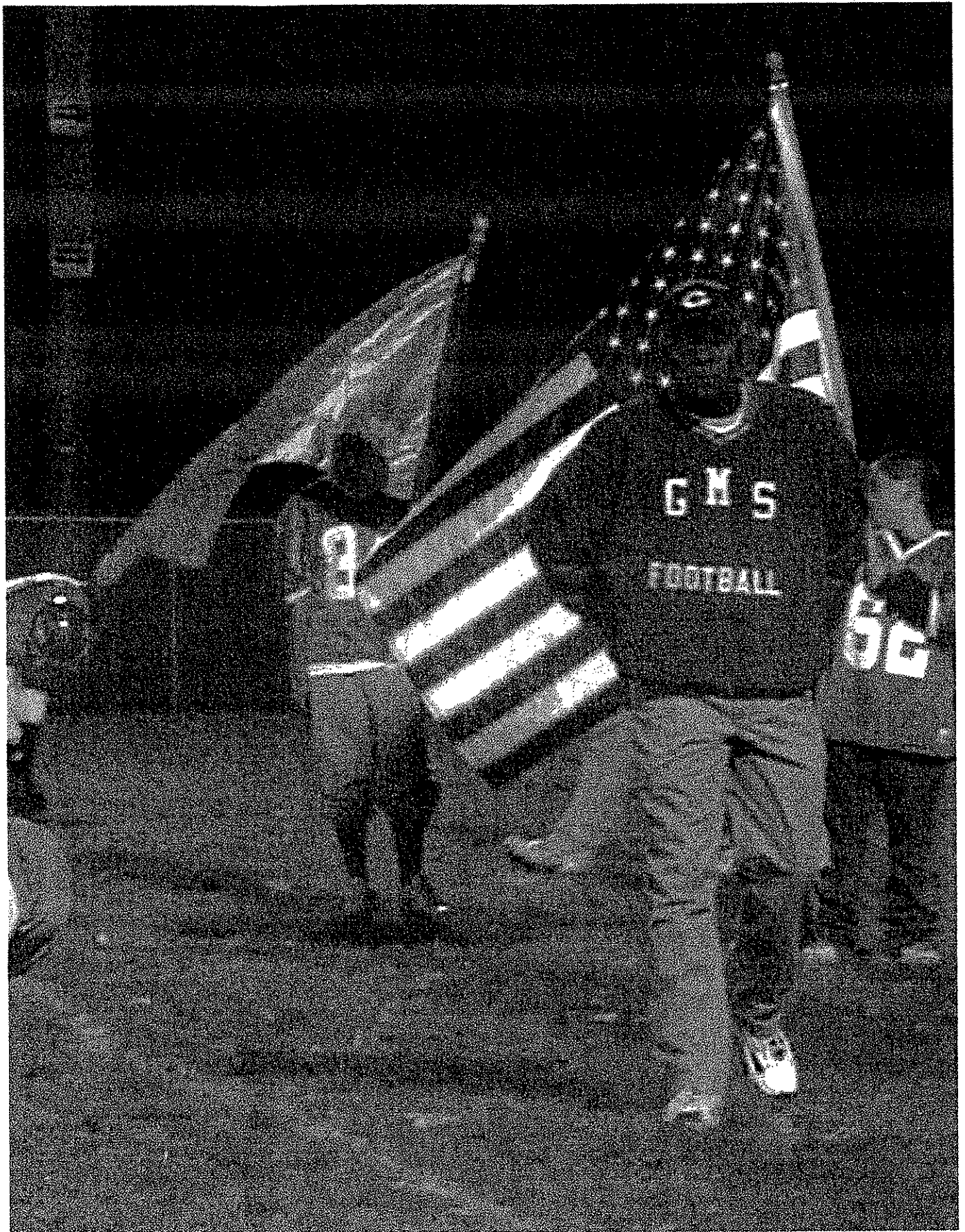
Seven make baseball coaches Hall of Fame

You have been selected to serve as one of the officials for the NAIA Division I Men's Basketball Championship Tournament, March 16-22, 1999, at the Reynold's Center on the campus of the University of Tulsa in Tulsa, Oklahoma. You will be provided the following:

1. Round trip airfare from your nearest airport to Tulsa or an allowance of \$.32 per mile for ground transportation from your home to Tulsa. Airline reservations will be made for you through the official NAIA travel agency, Passport Travel (1-800-499-NAIA) and your ticket will be mailed to you around the first part of March 1999. **In the event a ticket is purchased for you and you do not fulfill your contract, you will be responsible for the cost of the ticket.**

Passport Travel will direct bill the NAIA. Courtesy cars will be assigned at the hotel for transportation to and from the Mabee Center. The NAIA will transport you to and from the airport.

2. Complimentary housing at the Southern Hills Marriott begins March 15 and ends Saturday, March 20 or Monday, March 22. Officials will be housed in twin double rooms with two officials per room.
3. Meal allowance of \$25 per day (breakfast: \$5; lunch: \$8; and dinner: \$12), beginning with breakfast on March 16, and ending no later than breakfast on the day following your final assignment. Any complimentary meals provided, such as the Tip-Off Banquet, will not be included in the allowance.
4. Game fees of \$100 per game for all games through the quarterfinals. Semi-final games will be at \$125.00 and the championship officials will be paid \$150.00. A backup official will be employed for the semifinals and championship games only and will receive \$50 per game.

The officiating team is required to arrive in Tulsa and check in at the Southern Hills Marriott by 5:00 p.m. on March 15. All officials attend the tournament Tip-Off Banquet as guests of the NAIA at the Marriott on the 15th at 7:00 p.m. A mandatory meeting with the Tournament Committee and the supervisor of officials will be held immediately following the banquet in the hotel. General information, instructions and first round assignments will be covered at this meeting. Upon arrival at the Marriott, please check-in at the NAIA Headquarters room (Dogwood Room) for a packet of information.

Your assignments will be based on the following guidelines:

1. Tuesday - Thursday, March 16-18, all officials will work two games on each day for a total of six games (first and second rounds).
2. Friday - March 19, each official will work one game (quarterfinals). After the quarterfinal games - six (6) officials will be released after assignments on March 19.
3. Six officials will be assigned to the semifinals on March 20, and will be evaluated. The top four rated officials will be selected to work the championship on Monday, March 22. The top three will be assigned to the game and the number four official will serve as the back-up (bench) official.

Jenkins to be a replacement official for Cincy-Colts game

Burney Jenkins figured the opportunity was too good to pass up.

Jenkins, a long-time teacher at Georgetown Middle School and a 16-year veteran official in the Ohio Valley Conference, has agreed to be a replacement official for the NFL.

Jenkins will be flying to Atlanta this afternoon for a rules seminar, he said.

He'll be on the field in

Cincinnati Thursday for the Bengals-Colts preseason game, where he'll be the back judge, side judge or field judge, he said.

All replacement officials are guaranteed to earn at least \$4,000, or two games' pay.

A questionnaire was sent out to college officials, mostly Division I-A and I-AA, to find persons interested in becoming a replacement official, Jenkins said. Current league officials are on strike over a salary dispute.

Jenkins sent in the questionnaire and got a call back from Jim Daopoulos, supervisor of officials for the NFL, he said.

After faxing some information to Daopoulos for a background check, Jenkins was approved for today's training session and sub-

sequent games, he said.

Jenkins and the other officials will be graded at Thursday's preseason game, he said. Those who grade high could continue to serve as substitute officials even after the NFL's current officials return to work, Jenkins said.

"There is some apprehension about doing this while (league officials) are on strike, but this is an opportunity," Jenkins said. "I was offered a job, and I am going to take them up on it."

"It's just a great opportunity to do something that you may never get to do the rest of your lifetime. I can always say I worked in the NFL. It may be for one day, it may be short-lived, but I worked in the NFL."
