L. V. McGinty, Jr.

L. V. McGinty, Jr., began his Kentucky officiating career when he was transferred to Pikeville, KY in January 1968 from Denver, Colorado, while working as a special agent with the FBI. McGinty started officiating high school football, basketball, and baseball games and freshman SEC basketbail games in 1963 while attending Tulane University Law School. McGinty registered with the Kentucky High School Athletic Association in 1968 and officiated basketball, football, and baseball until he was transferred to Paducah, KY in March 1971. The first basketball game he called in Kentucky was with the legendary Foster "Sid" Meade. It was an experience to remember. After arriving in Paducah on April 1, 1971, McGinty joined the West Kentucky Football Conference and set out to line up some varsity basketball games as officials had to line up their own games. Starting in 1975, McGinty worked district and regional basketball tournaments for 17 years and on one occasion worked both the boys' and girls' regional finals. McGinty worked the first boys' state basketball tournament game played in Rupp Arena and worked two girls' state basketball tournaments. McGinty worked football state playoffs starting in 1974 and worked playoffs every year until 2002. He worked 4 state championship football games starting in 1978 and concluding with the Trinity-Male classic game in 2002 which was won by Trinity 59-56. McGinty was selected as the outstanding football official in western Kentucky in 1994 and 1995 and was named the outstanding football official in Kentucky in 1995. McGinty also has worked three college National Championship games. He and his wife Barbara have two children, L. V. III and Steven, and four grandchildren, Mary Lauren, Elinor Grace, Emily Louise, and Ava Fontaine.
