The letters and documents provided to you validates his integrity, his interest and concerns for the athletes of Kentucky, and students of schools he served. He wanted the student athlete to excel both on AND off the court, and that's what he did for me!

I have known Coach since I was 15 years old. He was my high school coach at Belfry from 1954-56. Long story short, I would not be where I am today if not for Zeb Blankenship. I had graduated from high school, moved to Cleveland, OH, and was working in a factory when he offered to help me enroll into Berea College. I graduated, have a BS, MA, and Rank I. I lived my dream of teaching and coaching at Scott County HS, building a state-tournament quality program. I've been able to provide for my family, and upon retirement, served my community of Georgetown as Mayor for 3 terms -- all made possible because of Zeb Blankenship.

I am nominating Coach Blankenship under the category of "Contributor" because of his service, dedication, leadership, and contributions as a Board member, and President of this organization. Please note...

- He served on the Board of Control from 1972
 1981.
- He served as President from 1979, 1980, and 1981.
- * The Ky High School State Basketball
 Tournament made record gate receipts in 1979, the
 first year it was played in Lexington. More than
 \$100.000 difference above the previous years when
 played in Louisville. (See Chart, provided by Lexington
 Herald Leader, in documents of receipts for 1978 in
 Louisville, 1979 in Lexington, and 1980 in Louisville.)
 This was a tremendous boost in revenue, contributing
 to the ability of KHSAA to assist schools with other
 non-revenue producing sports.
- * Record attendance of 21,000, then a world record for a high school championship game, as well as a record paid attendance.
- * His devotion to ALL Kentucky athletes, not only to excel on the field, court, floor of every kind, but his desire to see them achieve and be better prepared for a lifetime of challenges. The <u>student athlete</u> is just that. An education, be it at a college or trade school, is important for their future.

As a basketball player:

* He played in the state high school basketball tournament in 1943, 1944, and 1945, making the 1945 All-Star team, with Ralph Beard and Wah Wah Jones. All 3 went on to the University of Kentucky the next year and played for legendary Coach Adolph Rupp. This was also the FIRST Kentucky All-Star team to beat the Indiana All-Stars, always a difficult foe.

As a basketball coach:

* He had winning records at all 4 schools he coached basketball. (He also coached baseball and football). Virgie HS, Belfry HS, Richmond Madison, and Mercer County HS before becoming principal at Mercer County, then on to Jessamine County HS.

His ballplayers from these schools, including me, often would stop in to visit him at home. The door was always open. Many of these same players, students, coaches, and friends visited and/or attended his funeral when he passed away in November, 2012.

You won't meet another man any more respected and loved, smart, funny, versatile, and more deserving as Zeb Blankenship. His dedication to the KHSAA equalled that of the students and athletes from every school he served. It is imperative that you read the letters and documents submitted and know he is worthy of membership in the KHSAA Hall of Fame. Former Commissioner Tom Mills and former Board President Barney Thweatt have recommended the same. It is with great pleasure that I submit Coach Zeb Blankenship's name for your consideration.

I am pleased to write this letter of recommendation for Zeb Blankenship in support of his KHSAA Hall of Fame candidacy.

Zeb was an outstanding high school athlete, leading his Cumberland High School (Elkhorn City) team to three regional championships and state tournament appearances in 1943, 1944 and 1945. He was named to the All-State team in his senior year of 1945. He played his freshman year of college at the University of Kentucky before being drafted into the military and serving our country in the United States Army.

While Zeb's stellar basketball career is alone worthy of Hail of Fame induction, his high school coaching and administrative careers are maybe even more impressive and impactful. His basketball coaching career spanned over ten years as the head coach in four different high school settings and communities. At each stop, he developed winning programs and, more importantly, imparted meaningful life lessons to his players and students. He also coached baseball and football during these years.

His administrative career began in 1962 and stretched through 1981. He served as high school principal at both Mercer County High School (five years) and at Jessamine County High School (14 years). 

Mr. Blankenship is a native of Elkhorn City, Kentucky, where he was graduated from high school in 1945. He was a member of the then Cumberland High School basketball team which represented the 15th Region in the State High School Basketball Tournament in 1943, 1944, and 1945. He was named to the All-Tournament Team in 1945 and later played for the Kentucky All-Star Team which was conched by Ed Diddle of Western, He received a scholarship to the University of Kentucky, where after the Freshman scanon he was called into service in the U. S.

Upon discharge from the Army Mr. Blankenship attended the University of Louisville and Pikeville College. He was graduated from the University of Kentucky in 1982 and received his Masters Degree from U. K. In 1983. He received the Standard Leadership Certificate in 1969 from 11 K.

Zeb Blankenship has been associated with Pike County Schools in Virgie and Belfry as a teacher and coach; at Madison-Model in Richmond; at Mercer County High School and since 1967 has served in his present capacity as principal of Jessamine County Senior High School. Zeb Blankenship was installed Friday as president of the Kentucky High School Athletic Association. The formal action at Ken Lake State Park near Hardin in Western Kentucky. Oldham County Principal J.D. Minnehan was installed at the same time as vice president. Outgoing president is Barney Thweatt, principal at Christian County High School.

Nearing completon of his 13th year as principal at Jessamine County High School, Blankenship had been elected to the prestigious post April 17 at Lexington by the KHSAA 10 member Board of Controls.

Having mixed coaching experience in the four major high school sports at three different districts over 14 years prior to arrival at Jessamine County in August, 1967, Blankenship is well qualified to assume a public leadership role in state secondary school sporting activities.

He coached baseball, basketball, and track at Pike County four years; basketball and football assistant at Madison County five years; and basketball at Mercer County five years.

Duties of Blankenship as president of KHSAA will be to preside at board meetings and at delegate assembly meeting in April. During latter sessions, delegates have the option to amend old laws, adopt new regulations, and may vote on constitutional or bylaws changes.

All high school districts send delegates to the delegate assembly. All public high schools in Kentucky are members of KHSAA. The membership totals 309.

Tom Mills continues as commission of KHSAA. His job is to handle the day to day adminstraton of business matters relative to public high school sports. He interprets the association rules, represents the board, and enforces standards.

The 53-year-old Blankenship is a native of Elkhorn City. He graduated from Elkhorn City High School in 1945. He was a member of that school's basketball team which represented the 15th region in state tournament play in 1943, 1944, and 1945.

The Nicholasville resident received a scholarship to University of Kentucky. After his fresman season he went on a two-year tour of duty with the United States ARmy. He was recreational director at Fort Meade, Maryland in 1945-47.

Blankenship received his bachelors degree in 1952 from UK, majoring in physical education and biological science. He earned his masters in education from the same institution in 1953.

The principal and his wife, Nel, an employee in the Department of Human Resoursources at Frankfort, have four children.

Miss Kathy Blankenship is a minister of youth at Southside Baptist Church, Birmingham, Alabama.



Six winners from junior high schools in Lexington were chosen yesterday to advance to the Bluegrass Science Fair at Mary Queen of the Holy Rosary School on March 28.

Judged as having the outstanding science exhibits in a science fair at Crawford Junior High School were seventh-graders Lara Ashley and Khris Dyer and eighth-grader David Hasler, all of Bryan Station Junior High School; Ramin Karimi and Scott Baesler, eighth-graders at Crawford Junior High School; and Charles Fink of Tates Creek Junior High School.

"We feel that rotating the tournament every other year would keep both cities on their toes. It would keep the tournament from getting in a stagnant condition, as it did in Louisville because it had been here so long," he

"There are some things Louisville can offer that Lexington can't and some things Lexington has that we don't," Bell said.

"We have a different facility than Lexington has. We can offer parking on the grounds and 1,200 hotel rooms right at our front door," he said.

However, some of the things Lexington offers that Louisville doesn't amount to big pluses for the athletic

For instance, the Blue Grass Area McDonald's restaurants are providing he trophies for the tournament. That means a savings of about \$2,000 to the

The area Burger Queen restaurants have agreed to defray the cost of printing the tickets - another \$4, 000 savings.

The Lexington Center is cutting its "event parking" fee from \$3 to \$2 during tournament games.

And the LexTran bus system will provide shuttle service between local hotels and the arena for a \$1 round-

Those and other fringes aside, the biggest selling point for Lexington's bid to keep the tournament would be another year of record gate receipts. Lexington has a head start on that through an aggressive advance-ticket selling program devised by J.D. Reeves, first vice president of First Security Bank.

The bank distributed "season books" - tickets to all eight tournament sessions at a cost of \$44 - to 13 of its correspondent banks in different regions of the state.

Reeves said this week that the bank sent 25 books to each bank and that "they have pretty much sold

He said several of the banks asked for more tickets, including one in Elizabethtown that also requested 100 tickets to a session in which a team from that area is expected to

Reeves said tickets also are being sold through Dawahares stores in the central and eastern part of the state. Although exact figures were not available last week, Reeves said sales are

well ahead of the 1979 pace.

"And this is even before people know what teams are coming here,"

Mayor Jim Amato has been heading a campaign to have the athletic association declare Lexington the permanent site for the Sweet Sixteen when it takes up the issue of next year's tournament in either March or

Both Blankenship and KHSAA commissioner Tom Mills said they doubt that the board can make a longterm decision, such as the one Amato and local businessmen are pushing for, on the tournament's location,

But Blankenship said that, in practical terms, the city's enthusiasm for the tournament adds to its chances for a long run of the Sweet

"I don't think the board of control can pick a site for the future. I think it can only go on a year-by-year basis," Blankenship said.

But he also said: "In my personal opinion, I think Lexington is the place

"If you go by the bottom line, which is money, we made \$100,000 in 1979 above what we have the last several years in Louisville," said Blankenship, who is principal at Jessamine County High School.

"I think the board of control is going to have to look at this and really take it into consideration. That's enough money to run our entire spring sports program, so I really can't see changing sites as long as the money is there," he said

But there's another factor, Blankenship said.

Louisville, he said, seems to have become lackadaisical about the tour-

"Up to this point, I've only had one short letter from Louisville requesting the tournament next year just a few paragraphs. I think if Louisville really wanted the tournament, they would show more enthusiasm toward getting it," he said.

Meanwhile, he said: "The people of Lexington have really gone all out for the tournament. They have shown the KHSAA a lot of hospitality and enthusiasm. They really want the tournament. I think this has to go a long way with the board of control."

However, Louisville isn't about to let Lexington keep the tournament without a fight, said Joe Bell, executive vice president of the Kentucky State Fair Board, which schedules

in Lexington.

That year's attendance was 92,409, but gate receipts set a record — \$423,-648. And gate receipts, the total of all the money paid for tickets, will be one of the most important factors in determining where the tournament is played next year, athletic association officials said vesterday.

No estimate for the 1981 tournament was available last night, but officials said that based on the preliminary attendance figures, the receipts probably would set a tournament record.

Zeb Blankenship, chairman of the athetic association's board of control, said that the board would make the choice between Lexington and Louis-ville at its next regular meeting on April 16.

"We discussed it at a meeting yesterday (Friday), but we are waiting for a full financial statement (showing gate receipts) before we make a decision," Blankenship said. "Lexington is definitely in the running."

In fact, he said, some board members wanted to make the decision Friday and give the tournament to Lexington, but others wanted to wait for the financial statement and also to talk to athletic officials around the state.

Blankenship said another factor was the hospitality shown by Lexington to the fans, players and officials from around the state.

"The Lexington people have really gone out of their way to do everything to make this a successful tournament," he said. "It's been enjoyable; it's been great."

Said Mills: "We've had an outstanding tournament not only in terms of attendance, but also in the quality of competition and in every other way. .. It's been as smooth a tournament as we have ever had."

Minter and Richard Sewell, Lexington Center ticket manager, said it probably will be Monday before final figures for attendance and gate receipts are available.



Heralding the work of KHSAA staff and Board members, as well as the value of education for athletes

The role of sports in education

Perhaps, like me (retired), former members of the school systems and the Kentucky High School Athletic Association (KHSAA), have expected the active membership to stand up and be counted for the many contributions made by the association. Praise is in order for the efforts of former commissioners Ted Sanford and Joe Billy Mansfield, and current Commissioner Tom Mills and his staff. Not one of them has ever been dictatorial nor had an interest in other than quality, honest athletic programs at the high school level. They have been personally involved in the student athlete's life as a teacher, coach or school administrator.

There needs to be some support of the KHSAA by all the member schools, and I feel there is. It is time to speak up for its role in the education process! Some order must be applied to athletics — just as order is essential to traffic control. Turn us all loose in our cars without regulation and observe the chaos. There are always some abusers.

Having been involved in high school athletics as a player, coach, referee, and as a teacher and high school principal — I can speak with some authority on the realities of education and sports in the school, home and community.

Physical development of the body is essential for full and active development of the mind. Academic achievement must in part be attained with assistance, encouragement and determination by the student, parent and teacher. Encouraging the student to achieve his greatest potential in academics will prompt him or her to strive to reach their goals in their special interest area whether that be excellence in sports, the arts, science or the teaching field.

The school body as a majority takes pride

in the achievements of their fellow students in the sports, band or choral programs. Large numbers of students participate in these areas. Smaller groups enjoy their drama, foreign language and science activities. I watch with great interest when students compete in the intelligence "battles" on television. Training in these areas is the pursuit of those who have a gifted intelligence and superiority in academia. Most of us are of average intellect, but we may excel in sports, music, etc.

What actually matters here is not to penalize the athletes, but to encourage them. The public at large may enjoy athletic competition more than it enjoys the "IQ battles." With guidance from teachers, coaches and parents the athlete must be shown the proper place for sports in their personal life situation. Life beyond the sports age for them is to prepare them for a career, job, or vocation where they may happily engage in mingling with family, community and country.

The KHSAA is a contributor, not a conspirator in the field of education and in the lives of our students. If coaches tend to give sports a bad name and students a poor slant on life let them be disqualified and made exempt from involvement in school activities. Personally, I agree that coaches rather than athletes should be penalized for infractions.

The KHSAA should be allowed to pursue its primary purpose, which is to promote the student athlete in an honest manner, and to support the development of sports for any student who wishes to participate in their special interest whether that be basketball, football, swimming, tennis, baseball, wrestling or track.

I helped collect information from several people with whom Zeb played, coached, or served. It was my belief then and now, that his record should be considered carefully. Zeb always tried to participate in and promote the best in Kentucky High School Athletics.

Zeb was a member of the Elkhorn City High School "Cougars" Basketball team that won the 15th Region and played in the Boys State Tournament three years in a row. He was named to the All-Tournament Team in 1945, his senior year in addition to being a member on the Kentucky All State team along with Ralph Beard and Wah Wah Jones. Coach Alfred Rupp offered Zeb a scholarship to play for the University of Kentucky in the fall of 1945. His teammates went on to be known as the "Fabulous Five" but fate intervened and Zeb was drafted. He became a member of the United States Army in 1946, ending his basketball career at U.K. He played in the military and at Pikeville College before returning to the U.K. for his Graduate degrees.

Zeb always said that being a basketball official helped him as a coach and was beneficial in all of his other responsibilities. His tenure as a coach ended after approximately twelve years. He then began serving as a High School Administrator and Athletic Director for several years. Zeb served as a member on the Board of Control and as President of the Kentucky High School Athletic Association. I am honored to participate in the nomination of Zeb Blankenship to the Kentucky High School Athletic Association Hall of Fame.

I have known Zeb Blankenship all his life, as did my late husband Leslie Anderson. Zeb was born in Elkhorn City, Kentucky at the home of his grandparents, Dr. John Tilden and Lilly Deskins. His mother Beulah was married to Zeb Sr., who was a railroader. Beulah was never well or strong due to having contracted diphtheria as a young girl. His father died when Zeb was only two years of age so he and his mother continued to live with Dr. and Mrs. Deskins. His mother died when Zeb was 12 years old. Fortunately for Zeb there were three uncles in the home and they helped in shaping Zeb's feelings of a total family especially his uncle Tilden Deskins helped form his interest in athletics and education. Both were well known for their basketball abilities as players and coaches. Both went on to high positions in their career as school administrator.

Leslie and I owned and operated a Drug Store as it was first called but since we sold patented medicines, later changed to Cumberland Confectionary. Cumberland was also the name of the school. Our business was on Main Street, Which was the "only street". All businesses were located on this street. The Depot at the end of the street by railroad shipping address Elkhorn City. Other businesses, a restaurant, hotdog and hamburger joint, Dr. Deskins' and Dr. Newsome's offices, wholesale grocery, general store, barber shop, and theater. Our "drug store" was the gathering place for young and old with judebox, pinball machine, fountain, etc. After the ball games crowds would come to play over the "games". The depot was Elkhorn City, post office was Praise, and school was Cumberland, Kentucky. Around 1950 the Lion's Club had changed the post office and school name to Elkhorn City.

Zeb was an exceptional basketball player, as well as a model boy and student. Leslie attended the games at home and away also a crowd followed them. I remember every person in town and from the creeks and hollows followed them, even though this was hard to do back then because of the roads, etc. Leslie although not having been out of school too long himself was a father figure to many of them. He would go to scrimmage with them during holiday breaks in order to give them somebody to shoot and defend against. They would clean the gym and stoke the school furnace in order to get into the gym and have a basketball shoot around.

The boys traveled in milk wagon trucks, cars that were unsafe, gasoline shortages, coupons etc; they were allowed 25 cents for food after a game. Fans helped some too. Fans at home would listen by radio or next day's newspapers. They had only one uniform; had to furnish other gear themselves, some could not buy, Leslie helped them with this.

Zeb and others were on the all tournament teams who won the district 15th regional tournament on the road to state tournament three years in a row. He was named to all tournament team 43, 44, and 45. He entered the University of Kentucky when Adolph Rupp offered him a scholarship to play ball fall of 1945. He was drafted March of 1946 by U.S. Army. His teammates were those who went on to become the "fabulous five". He did play in the military and later at Pikeville College, he returned to the University of Kentucky and earned a graduate degree.

The 50° year anniversary was approaching; players, coaches, cheerleaders, were contacted and the first "gathering" of the 1943, 44 and 45 Cougars were called and many attended the first time on Alumni weekend, Easter 1992. There was a very good attendance and it has continued on Good Friday each year at the Breaks Lodge. Many teammates, coaches, good fans and friends have gone on to that "Big basketball game in the sky". This year we had 25 in attendance including fans. The Eikhorn City Alumni Association will also continue to meet Saturday before Easter although we have lost the high school, Zeb and his good faithful wife Neldora have kept it going and attended every time except a year of Zeb's illness kept them away.

In August 2002 our beloved Cumberland/Elkhorn City High School became East Ridge High School after consolidating with Feds Creek and Millard High Schools, no longer in Elkhorn City. The trophies and other sports memorabilia are hanging on display and trophies encased at the Elkhorn City Middle School Building. Zeb and other Elkhorn City/Cumberland Cougars will be there for generations to see what has been accomplished. These ball players, Zeb and others have been recognized for their outstanding contributions in athletics for Elkhorn City High School Athletic Hall of Fame Charter Inductees January 2, 1993 for years 43, 44, 45. I am also proud to say that Leslie Anderson was charter inductee for 1933-35, as were many others.

Neldora moved to Elkhorn City in March of 1946 after Zeb had graduated and was playing ball at the University of Kentucky. She regrets that she never saw him play a high school game. She has worked for years for the state of Kentucky traveling over Eastern and Central Kentucky. When people heard her name "Blankenship," they would reminisce about a "left-handed great basketball player from Elkhorn City, she would proudly acknowledge as her husband. They would then tell her great stories about Zeb's basketball talents.

Again I recommend Zeb Blankenship be added to Kentucky High School Athletic Hall of Fame.
